8 SYNOPSIS: Under existing law, a person is guilty of
9 trafficking in controlled substance analogues if he
10 or she knowingly sells, manufactures, delivers, or
11 brings into this state 28 or more grams of the
12 controlled substance.

13 This bill would increase the requisite
14 weight for trafficking in controlled substance
15 analogues to 56 grams.

16 Under existing law, certain named chemical
17 compounds of synthetic cannabinoid and other
18 controlled substance analogues are included in
19 Schedule I of the controlled substances list.
20 Possession, distribution, and trafficking of these
21 compounds is unlawful, and violations are subject
22 to the existing criminal penalties for distribution
23 and possession.

24 This bill would include additional synthetic
25 controlled substances and analogues to Schedule I.

26 Amendment 621 of the Constitution of Alabama
27 of 1901, now appearing as Section 111.05 of the

1 Official ReCompilation of the Constitution of
2 Alabama of 1901, as amended, prohibits a general
3 law whose purpose or effect would be to require a
4 new or increased expenditure of local funds from
5 becoming effective with regard to a local
6 governmental entity without enactment by a 2/3 vote
7 unless: it comes within one of a number of
8 specified exceptions; it is approved by the
9 affected entity; or the Legislature appropriates
10 funds, or provides a local source of revenue, to
11 the entity for the purpose.

12 The purpose or effect of this bill would be
13 to require a new or increased expenditure of local
14 funds within the meaning of the amendment. However,
15 the bill does not require approval of a local
16 governmental entity or enactment by a 2/3 vote to
17 become effective because it comes within one of the
18 specified exceptions contained in the amendment.

22 AN ACT

24 Relating to Schedule I controlled substances; to
25 amend Sections 13A-12-231 and 20-2-23, Code of Alabama 1975,
26 to increase the requisite weight for trafficking in controlled
27 substance analogues; to include additional synthetic

1 controlled substances and analogues to the Schedule I
2 controlled substances list; and in connection therewith would
3 have as its purpose or effect the requirement of a new or
4 increased expenditure of local funds within the meaning of
5 Amendment 621 of the Constitution of Alabama of 1901, now
6 appearing as Section 111.05 of the Official Recompilation of
7 the Constitution of Alabama of 1901, as amended.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. This act shall be known and may be cited
10 as Landon's Law.

11 Section 2. Sections 13A-12-231 and 20-2-23, Code of
12 Alabama 1975, are amended to read as follows:

13 "§13A-12-231.

14 "Except as authorized in Chapter 2, Title 20:

15 "(1) Any person who knowingly sells, manufactures,
16 delivers, or brings into this state, or who is knowingly in
17 actual or constructive possession of, in excess of one kilo or
18 2.2 pounds of any part of the plant of the genus Cannabis,
19 whether growing or not, the seeds thereof, the resin extracted
20 from any part of the plant, and every compound, manufacture,
21 salt, derivative, mixture, or preparation of the plant, its
22 seeds, or resin including the completely defoliated mature
23 stalks of the plant, fiber produced from the stalks, oil, or
24 cake, or the completely sterilized samples of seeds of the
25 plant which are incapable of germination is guilty of a
26 felony, which felony shall be known as "trafficking in
27 cannabis." Nothing in this subdivision shall apply to samples

1 of tetrahydrocannabinols including, but not limited to, all
2 synthetic or naturally produced samples of
3 tetrahydrocannabinols which contain more than 15 percent by
4 weight of tetrahydrocannabinols and which do not contain plant
5 material exhibiting the external morphological features of the
6 plant cannabis. If the quantity of cannabis involved:

7 "a. Is in excess of one kilo or 2.2 pounds, but less
8 than 100 pounds, the person shall be sentenced to a mandatory
9 minimum term of imprisonment of three calendar years and to
10 pay a fine of twenty-five thousand dollars (\$25,000).

11 "b. Is 100 pounds or more, but less than 500 pounds,
12 the person shall be sentenced to a mandatory minimum term of
13 imprisonment of five calendar years and to pay a fine of fifty
14 thousand dollars (\$50,000).

15 "c. Is 500 pounds or more, but less than 1,000
16 pounds, the person shall be sentenced to a mandatory minimum
17 term of imprisonment of 15 calendar years and to pay a fine of
18 two hundred thousand dollars (\$200,000).

19 "d. Is 1,000 pounds or more, the person shall be
20 sentenced to a mandatory term of imprisonment of life without
21 parole.

22 "(2) Any person who knowingly sells, manufactures,
23 delivers, or brings into this state, or who is knowingly in
24 actual or constructive possession of, 28 grams or more of
25 cocaine or of any mixture containing cocaine, described in
26 Section 20-2-25(1), is guilty of a felony, which felony shall

1 be known as "trafficking in cocaine." If the quantity
2 involved:

3 "a. Is 28 grams or more, but less than 500 grams,
4 the person shall be sentenced to a mandatory minimum term of
5 imprisonment of three calendar years and to pay a fine of
6 fifty thousand dollars (\$50,000).

7 "b. Is 500 grams or more, but less than one kilo,
8 the person shall be sentenced to a mandatory minimum term of
9 imprisonment of five calendar years and to pay a fine of one
10 hundred thousand dollars (\$100,000).

11 "c. Is one kilo, but less than 10 kilos, then the
12 person shall be sentenced to a mandatory minimum term of
13 imprisonment of 15 calendar years and to pay a fine of two
14 hundred fifty thousand dollars (\$250,000).

15 "d. Is 10 kilos or more, the person shall be
16 sentenced to a mandatory term of imprisonment of life without
17 parole.

18 "(3) Any person who knowingly sells, manufactures,
19 delivers, or brings into this state, or who is knowingly in
20 actual or constructive possession of, four grams or more of
21 any morphine, opium, or any salt, isomer, or salt of an isomer
22 thereof, including heroin, as described in Section 20-2-23(2)
23 or Section 20-2-25(1)a., or four grams or more of any mixture
24 containing any such substance, is guilty of a felony, which
25 felony shall be known as "trafficking in illegal drugs." If
26 the quantity involved:

1 "a. Is four grams or more, but less than 14 grams,
2 the person shall be sentenced to a mandatory minimum term of
3 imprisonment of three calendar years and to pay a fine of
4 fifty thousand dollars (\$50,000).

5 "b. Is 14 grams or more, but less than 28 grams, the
6 person shall be sentenced to a mandatory minimum term of
7 imprisonment of 10 calendar years and to pay a fine of one
8 hundred thousand dollars (\$100,000).

9 "c. Is 28 grams or more, but less than 56 grams, the
10 person shall be sentenced to a mandatory minimum term of
11 imprisonment of 25 calendar years and to pay a fine of five
12 hundred thousand dollars (\$500,000).

13 "d. Is 56 grams or more, the person shall be
14 sentenced to a mandatory term of imprisonment of life without
15 parole.

16 "(4) Any person who knowingly sells, manufactures,
17 delivers, or brings into this state, or who is knowingly in
18 actual or constructive possession of 1,000 or more pills or
19 capsules of methaqualone, as described in Section 20-2-1, et
20 seq., is guilty of a felony, which felony shall be known as
21 "trafficking in illegal drugs." If the quantity involved:

22 "a. Is 1,000 pills or capsules, but less than 5,000
23 pills or capsules, the person shall be sentenced to a
24 mandatory minimum term of imprisonment of three calendar years
25 and pay a fine of fifty thousand dollars (\$50,000).

26 "b. Is 5,000 capsules or more, but less than 25,000
27 capsules, that person shall be imprisoned to a mandatory

1 minimum term of imprisonment of 10 calendar years and pay a
2 fine of one hundred thousand dollars (\$100,000).

3 "c. Is 25,000 pills or more, but less than 100,000
4 pills or capsules, the person shall be sentenced to a
5 mandatory minimum term of imprisonment of 25 calendar years
6 and pay a fine of five hundred thousand dollars (\$500,000).

7 "d. Is 100,000 capsules or more, the person shall be
8 sentenced to a mandatory term of imprisonment of life without
9 parole.

10 "(5) Any person who knowingly sells, manufactures,
11 delivers or brings into this state, or who is knowingly in
12 actual or constructive possession of 500 or more pills or
13 capsules of hydromorphone as is described in Section 20-2-1,
14 et seq., is guilty of a felony which shall be known as
15 "trafficking in illegal drugs." If the quantity involved:

16 "a. Is 500 pills or capsules or more but less than
17 1,000 pills or capsules, the person shall be sentenced to a
18 mandatory term of imprisonment of three calendar years and to
19 pay a fine of fifty thousand dollars (\$50,000).

20 "b. Is 1,000 pills or capsules or more, but less
21 than 4,000 pills or capsules, the person shall be sentenced to
22 a mandatory term of imprisonment of 10 calendar years and to
23 pay a fine of one hundred thousand dollars (\$100,000).

24 "c. Is 4,000 pills or capsules or more but less than
25 10,000 pills or capsules, the person shall be sentenced to a
26 mandatory term of imprisonment of 25 calendar years and to pay
27 a fine of one hundred thousand dollars (\$100,000).

1 "d. Is more than 10,000 pills or capsules, the
2 person shall be sentenced to a mandatory term of life in
3 prison without parole.

4 "(6) Any person who knowingly sells, manufactures,
5 delivers, or brings into this state, or who is knowingly in
6 actual or constructive possession of, 28 grams or more of
7 3,4-methylenedioxy amphetamine, or of any mixture containing
8 3,4-methylenedioxy amphetamine, is guilty of a felony, which
9 felony shall be known as "trafficking in illegal drugs." If
10 the quantity involved:

11 "a. Is 28 grams or more, but less than 500 grams,
12 the person shall be sentenced to a mandatory minimum term of
13 imprisonment of three calendar years and to pay a fine of
14 fifty thousand dollars (\$50,000).

15 "b. Is 500 grams or more, but less than one kilo,
16 the person shall be sentenced to a mandatory minimum term of
17 imprisonment of five calendar years and to pay a fine of one
18 hundred thousand dollars (\$100,000).

19 "c. Is one kilo, but less than 10 kilos, then the
20 person shall be sentenced to a mandatory minimum term of
21 imprisonment of 15 calendar years and to pay a fine of two
22 hundred fifty thousand dollars (\$250,000).

23 "d. Is 10 kilos or more, the person shall be
24 sentenced to a mandatory term of imprisonment of life without
25 parole.

26 "(7) Any person who knowingly sells, manufactures,
27 delivers, or brings into this state, or who is knowingly in

1 actual or constructive possession of, 28 grams or more of
2 5-methoxy-3, 4-methylenedioxy amphetamine, or of any mixture
3 containing 5-methoxy-3, 4-methylenedioxy amphetamine is guilty
4 of a felony, which felony shall be known as "trafficking in
5 illegal drugs" if the quantity involved:

6 "a. Is 28 grams or more, but less than 500 grams,
7 the person shall be sentenced to a mandatory minimum term of
8 imprisonment of three calendar years and to pay a fine of
9 fifty thousand dollars (\$50,000).

10 "b. Is 500 grams or more, but less than one kilo,
11 the person shall be sentenced to a mandatory minimum term of
12 imprisonment of five calendar years and to pay a fine of one
13 hundred thousand dollars (\$100,000).

14 "c. Is one kilo, but less than 10 kilos, then the
15 person shall be sentenced to a mandatory minimum term of
16 imprisonment of 15 calendar years and to pay a fine of two
17 hundred fifty thousand dollars (\$250,000).

18 "d. Is 10 kilos or more, the person shall be
19 sentenced to a mandatory term of imprisonment of life without
20 parole.

21 "(8) Any person who knowingly sells, manufactures,
22 delivers, or brings into this state, or who is knowingly in
23 actual or constructive possession of, four grams or more of
24 phencyclidine, or any mixture containing phencyclidine, is
25 guilty of a felony, which felony shall be known as
26 "trafficking in illegal drugs." If the quantity involved:

1 "a. Is four grams or more, but less than 14 grams,
2 the person shall be sentenced to a mandatory minimum term of
3 imprisonment of three calendar years and to pay a fine of
4 fifty thousand dollars (\$50,000).

5 "b. Is 14 grams or more, but less than 28 grams, the
6 person shall be sentenced to a mandatory minimum term of
7 imprisonment of five calendar years and to pay a fine of one
8 hundred thousand dollars (\$100,000).

9 "c. Is 28 grams or more, but less than 56 grams,
10 then the person shall be sentenced to a mandatory minimum term
11 of imprisonment of 15 calendar years and to pay a fine of two
12 hundred fifty thousand dollars (\$250,000).

13 "d. Is 56 grams or more, the person shall be
14 sentenced to a mandatory term of imprisonment of life without
15 parole.

16 "(9) Any person who knowingly sells, manufactures,
17 delivers, or brings into this state, or who is knowingly in
18 actual or constructive possession of, four grams or more of
19 lysergic acid diethylamide, of four grams or more of any
20 mixture containing lysergic acid diethylamide, is guilty of a
21 felony, which felony shall be known as "trafficking in illegal
22 drugs." If the quantity involved:

23 "a. Is four grams or more, but less than 14 grams,
24 the person shall be sentenced to a mandatory minimum term of
25 imprisonment of three calendar years and to pay a fine of
26 fifty thousand dollars (\$50,000).

1 "b. Is 14 grams or more, but less than 28 grams, the
2 person shall be sentenced to a mandatory minimum term of
3 imprisonment of 10 calendar years and to pay a fine of one
4 hundred thousand dollars (\$100,000).

5 "c. Is 28 grams or more, but less than 56 grams, the
6 person shall be sentenced to a mandatory minimum term of
7 imprisonment of 25 calendar years and to pay a fine of five
8 hundred thousand dollars (\$500,000).

9 "d. Is 56 grams or more, the person shall be
10 sentenced to a mandatory term of imprisonment of life without
11 parole.

12 "(10) Any person who knowingly sells, manufactures,
13 delivers or brings into this state, or who is knowingly in
14 actual or constructive possession of, 28 grams or more of
15 amphetamine or any mixture containing amphetamine, its salt,
16 optical isomer, or salt of its optical isomer thereof, is
17 guilty of a felony, which felony shall be known as
18 "trafficking in amphetamine." If the quantity involved:

19 "a. Is 28 grams or more but less than 500 grams, the
20 person shall be sentenced to a mandatory minimum term of
21 imprisonment of three calendar years and to pay a fine of
22 fifty thousand dollars (\$50,000).

23 "b. Is 500 grams or more, but less than one kilo,
24 the person shall be sentenced to a mandatory minimum term of
25 imprisonment of five calendar years and to pay a fine of one
26 hundred thousand dollars (\$100,000).

1 "c. Is one kilo but less than 10 kilos, then the
2 person shall be sentenced to a mandatory minimum term of
3 imprisonment of 15 calendar years and to pay a fine of two
4 hundred fifty thousand dollars (\$250,000).

5 "d. Is 10 kilos or more, the person shall be
6 sentenced to a mandatory term of imprisonment of life without
7 parole.

8 "(11) Any person who knowingly sells, manufactures,
9 delivers, or brings into this state, or who is knowingly in
10 actual or constructive possession of, 28 grams or more of
11 methamphetamine or any mixture containing methamphetamine, its
12 salts, optical isomers, or salt of its optical isomers
13 thereof, is guilty of a felony, which felony shall be known as
14 "trafficking in methamphetamine." If the quantity involved:

15 "a. Is 28 grams or more but less than 500 grams, the
16 person shall be sentenced to a mandatory minimum term of
17 imprisonment of three calendar years and to pay a fine of
18 fifty thousand dollars (\$50,000).

19 "b. Is 500 grams or more, but less than one kilo,
20 the person shall be sentenced to a mandatory minimum term of
21 imprisonment of five calendar years and to pay a fine of one
22 hundred thousand dollars (\$100,000).

23 "c. Is one kilo but less than 10 kilos, then the
24 person shall be sentenced to a mandatory minimum term of
25 imprisonment of 15 calendar years and to pay a fine of two
26 hundred fifty thousand dollars (\$250,000).

1 "d. Is 10 kilos or more, the person shall be
2 sentenced to a mandatory term of imprisonment of life without
3 parole.

4 "(12) Any person who knowingly sells, manufactures,
5 delivers, or brings into this state, or who is knowingly in
6 actual or constructive possession of ~~28~~ 56 or more grams of a
7 synthetic controlled substance analog or a synthetic
8 controlled substance analogue, as described in subsection (4)
9 or (5) of Section 20-2-23, is guilty of a felony, which felony
10 shall be known as "trafficking in synthetic controlled
11 substance analogs substances." If the quantity involved:

12 "a. Is ~~28~~ 56 grams or more, but less than 500 grams,
13 the person shall be sentenced to a mandatory minimum term of
14 imprisonment of three calendar years and to pay a fine of
15 fifty thousand dollars (\$50,000).

16 "b. Is 500 grams or more, but less than 1 kilo, the
17 person shall be sentenced to a mandatory minimum term of
18 imprisonment of 10 calendar years and to pay a fine of one
19 hundred thousand dollars (\$100,000).

20 "c. Is one kilo, but less than 10 kilos, then the
21 person shall be sentenced to a mandatory minimum term of
22 imprisonment of 15 calendar years and to pay a fine of two
23 hundred fifty thousand dollars (\$250,000).

24 "d. Is 10 kilos or more, the person shall be
25 sentenced to a mandatory term of imprisonment of life without
26 parole.

1 "(13) The felonies of "trafficking in cannabis,"
2 "trafficking in cocaine," "trafficking in illegal drugs,"
3 "trafficking in amphetamine," "trafficking in
4 methamphetamine," and "trafficking in synthetic controlled
5 ~~substance analogs~~ substances" as defined in subdivisions (1)
6 through (12), above, shall be treated as Class A felonies for
7 purposes of Title 13A, including sentencing under Section
8 13A-5-9. Provided, however, that the sentence of imprisonment
9 for a defendant with one or more prior felony convictions who
10 violates subdivisions (1) through (12) of this section shall
11 be the sentence provided therein, or the sentence provided
12 under Section 13A-5-9, whichever is greater. Provided further,
13 that the fine for a defendant with one or more prior felony
14 convictions who violates subdivisions (1) through (12) of this
15 section shall be the fine provided therein, or the fine
16 provided under Section 13A-5-9, whichever is greater.

17 "(14) Notwithstanding any provision of law to the
18 contrary, any person who has possession of a firearm during
19 the commission of any act proscribed by this section shall be
20 punished by a term of imprisonment of five calendar years
21 which shall be in addition to, and not in lieu of, the
22 punishment otherwise provided, and a fine of twenty-five
23 thousand dollars (\$25,000); the court shall not suspend the
24 five-year additional sentence of the person or give the person
25 a probationary sentence.

26 "§20-2-23.

27 "(a) The Legislature finds the following:

1 "(1) New synthetic substances are being created
2 which are not controlled under the provisions of existing
3 state law but which have a potential for abuse similar to or
4 greater than that for substances controlled under existing
5 state law. These new synthetic substances are called
6 ~~"controlled substance analogs,"~~ "synthetic controlled
7 substances or synthetic controlled substance analogues" and
8 can be designed to produce a desired pharmacological effect
9 and to evade the controlling statutory provisions. ~~Controlled~~
10 Synthetic controlled substance analogs substances or synthetic
11 controlled substance analogues are being manufactured,
12 distributed, possessed, and used as substitutes for controlled
13 substances.

14 "(2) The hazards attributable to the traffic in and
15 use of a synthetic controlled substance analogs or synthetic
16 controlled substance analogues are increased because their
17 unregulated manufacture produces variations in purity and
18 concentration.

19 "(3) Many new synthetic substances are untested, and
20 it cannot be immediately determined whether they have useful
21 medical or chemical purposes.

22 "(4) The uncontrolled importation, manufacture,
23 distribution, possession, or use of controlled substance
24 ~~analog~~ analogues has a substantial and detrimental impact on
25 the health and safety of the people of this state.

26 "(5) ~~Controlled substance analogs~~ Synthetic
27 controlled substances or synthetic controlled substance

1 analogues can be created more rapidly than they can be
2 identified and controlled by action of the Legislature. There
3 is a need for a speedy determination of their proper
4 classification under existing law. It is therefore necessary
5 to identify and classify new substances that have a potential
6 for abuse, so that they can be controlled in the same manner
7 as other substances controlled under existing state law.

8 "(b) The controlled substances listed in this
9 section are included in Schedule I:

10 "(1) Any of the following opiates, including their
11 isomers, esters, ethers, salts, and salts of isomers, esters
12 and ethers, unless specifically excepted, whenever the
13 existence of these isomers, esters, ethers and salts is

1 halides, thioalkyl, cycloalkyl, cycloalkylhalides and/or
2 substitution at the nitrogen atom with alkyl, alkyl halide,
3 alkenyl, cycloalkylmethyl, cycloalkylethyl, phenyl, benzyl
4 whether or not further substituted in the (either) phenyl ring
5 to any extent.

6 "20. Any compound structurally related to
7 2-amino-1-phenyl-1-propanone (cathinone) by substitution of
8 the amine with alkyl, alkyl halide, alkenyl, cycloalkylmethyl,
9 cycloalkylethyl, phenyl, benzyl whether or not further
10 substituted in the (either) phenyl ring to any extent.

11 "21. Any compound structurally related to
12 a-pyrrolidinopentiophenone (a-pvp) whether or not further
13 substituted in the phenyl ring to any extent, whether or not
14 further substituted in the pyrrolidine ring to any extent.

15 "b. A ~~controlled substance analog~~ synthetic
16 controlled substance or analogue in subdivision (4) or this
17 subdivision does not include any of the following:

18 "1. Any substance for which there is an approved new
19 drug application under the Federal Food, Drug, and Cosmetic
20 Act.

21 "2. With respect to a particular person, any
22 substance, if an exemption is in effect for investigational
23 use, for that person, as provided by 21 U.S.C. § 355, and the
24 person is registered as a controlled substance researcher as
25 required under section 152.12, subdivision 3, to the extent
26 conduct with respect to the substance is pursuant to the
27 exemption and registration.

1 "c. A controlled substance ~~analog analogue,~~ to the
2 ~~extent intended for human consumption,~~ is treated as a
3 controlled substance in Schedule I.

4 "d. After the Alabama Department of Forensic
5 Sciences has determined a substance to be a synthetic
6 controlled substance ~~analog analogue~~ under this section, the
7 department shall notify the Alabama Department of Public
8 Health with information relevant to scheduling as provided by
9 Section 20-2-20."

10 Section 3. Although this bill would have as its
11 purpose or effect the requirement of a new or increased
12 expenditure of local funds, the bill is excluded from further
13 requirements and application under Amendment 621, now
14 appearing as Section 111.05 of the Official Recompilation of
15 the Constitution of Alabama of 1901, as amended, because the
16 bill defines a new crime or amends the definition of an
17 existing crime.

18 Section 4. This act shall become effective
19 immediately following its passage and approval by the
20 Governor, or its otherwise becoming law.
