## SENATE FLOOR AMENDMENT

Amend reengrossed bill, page 13, after line 27, insert:

"SECTION 9. In Colorado Revised Statutes, 39-22-104, add (4)(cc) as follows:

- 39-22-104. Income tax imposed on individuals, estates, and trusts single rate report legislative declaration definitions repeal. (4) There shall be subtracted from federal taxable income:
- (cc) (I) For income tax years commencing on or after January 1, 2025, an amount equal to the costs for obtaining or renewing a permit to carry a concealed handgun issued pursuant to part 2 of article 12 of title 18, including a temporary emergency permit issued pursuant to section 18-12-209.
- (II) FOR THE PURPOSES OF THIS SUBSECTION (4)(cc), COSTS FOR OBTAINING OR RENEWING A PERMIT TO CARRY A CONCEALED HANDGUN ARE THE NEW OR RENEWAL PERMIT FEE PAID TO A SHERIFF, AS SET BY THE SHERIFF PURSUANT TO SECTION 18-12-205 (5); A TEMPORARY PERMIT FEE DESCRIBED IN SECTION 18-12-209; THE FEE FOR PROCESSING THE APPLICANT'S FINGERPRINTS PAID TO THE COLORADO BUREAU OF INVESTIGATION, AS REQUIRED BY SECTION 18-12-205; AND THE TUITION AND FEES PAID TO COMPLETE A CONCEALED HANDGUN TRAINING CLASS OR A REFRESHER CLASS DESCRIBED IN SECTION 18-12-202.5.
- (III) (A) IN ACCORDANCE WITH SECTION 39-21-304 (1), WHICH REQUIRES EACH BILL THAT CREATES A NEW TAX EXPENDITURE TO INCLUDE A TAX PREFERENCE PERFORMANCE STATEMENT AS PART OF A STATUTORY LEGISLATIVE DECLARATION, THE GENERAL ASSEMBLY FINDS AND DECLARES THAT THE PURPOSE OF THE TAX SUBTRACTION PROVIDED IN THIS SECTION IS TO PROVIDE TAX RELIEF TO CERTAIN INDIVIDUALS, SPECIFICALLY INDIVIDUALS PAYING COSTS ASSOCIATED WITH OBTAINING OR RENEWING A PERMIT TO CARRY A CONCEALED HANDGUN. THE SPECIFIC PURPOSE IS TO REDUCE THE COSTS FOR LAWFULLY CARRYING A CONCEALED HANDGUN IN COLORADO.
- (B) THE GENERAL ASSEMBLY AND THE STATE AUDITOR SHALL MEASURE THE EFFECTIVENESS OF THE SUBTRACTION IN ACHIEVING THE PURPOSE SPECIFIED IN THIS SUBSECTION (4)(cc) BASED ON THE NUMBER AND VALUE OF SUBTRACTIONS CLAIMED.
- 36 (IV) NOTWITHSTANDING SECTION 39-21-304 (4), THIS 37 SUBTRACTION CONTINUES INDEFINITELY.".
