

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB25-003 be amended as follows:

1 Amend reengrossed bill page 11, strike lines 12 through 20 and substitute
2 "APPLICANT MUST SUBMIT AN APPLICATION TO THE SHERIFF ON A FORM
3 CREATED BY THE DIVISION OF PARKS AND WILDLIFE AND SUBMIT TO THE
4 SHERIFF THE MATERIALS DESCRIBED IN SUBSECTION (5)(b)(III) OF THIS
5 SECTION. THE APPLICATION FORM MUST REQUIRE THE APPLICANT TO
6 PROVIDE THEIR FULL NAME AND DATE OF BIRTH AND MAKE THE
7 FOLLOWING ATTESTATIONS:

8 (A) THE APPLICANT DOES NOT HAVE A STATE OR FEDERAL
9 CONVICTION THAT WOULD PROHIBIT THEM FROM PURCHASING OR
10 POSSESSING A FIREARM;

11 (B) THE APPLICANT WILL NOT VIOLATE RELEVANT STATE LAW
12 RELATED TO THE PURCHASE, POSSESSION, STORAGE, AND LAWFUL USE OF
13 FIREARMS; AND

14 (C) THE APPLICANT WILL ONLY TRANSFER A FIREARM PURSUANT
15 TO SECTION 18-12-112 AND THIS SECTION AND NOT ALLOW ANOTHER
16 PERSON WHO THE APPLICANT BELIEVES WOULD BE A DANGER TO THEMSELF
17 OR OTHERS ACCESS TO A FIREARM IN THE APPLICANT'S POSSESSION.

18 (III) AN APPLICANT MUST ALSO SUBMIT TO THE SHERIFF:

19 (A) GOVERNMENT-ISSUED PHOTOGRAPHIC IDENTIFICATION ISSUED
20 TO THE APPLICANT; AND

21 (B) THE RESULTS OF A COMPLETED NAME-BASED BACKGROUND
22 CHECK OF NATIONAL AND COLORADO PUBLIC CRIMINAL HISTORY AND
23 JUDICIAL DATABASES COMPLETED BY A THIRD-PARTY VENDOR THAT
24 CONDUCTS THOSE CHECKS AS A NORMAL PART OF THE VENDOR'S BUSINESS,
25 AND AN ATTESTATION FROM THE VENDOR THAT THE BACKGROUND CHECK
26 WAS PERFORMED BY THE VENDOR.

27 (IV) A PERSON WHO KNOWINGLY MAKES A FALSE OR MISLEADING
28 STATEMENT ON A FIREARMS SAFETY COURSE ELIGIBILITY CARD
29 APPLICATION OR DELIBERATELY OMITTS ANY MATERIAL INFORMATION
30 REQUESTED ON THE APPLICATION COMMITS PERJURY IN THE SECOND
31 DEGREE, AS DESCRIBED IN SECTION 18-8-503. IN ADDITION TO ANY
32 CRIMINAL PENALTIES, IF A PERSON IS CONVICTED OF PERJURY FOR MAKING
33 A FALSE OR MISLEADING STATEMENT ON A FIREARMS SAFETY COURSE
34 ELIGIBILITY CARD APPLICATION, THE SHERIFF SHALL REVOKE THE PERSON'S
35 CARD IF ISSUED PRIOR TO CONVICTION."
