23 Page 15, strike line 19 and substitute "PURPOSES OF THIS SECTION

(II) THE MONEY CREDITED TO THE FIREARMS TRAINING AND
SAFETY COURSE CASH FUND PURSUANT TO SECTION 18-12-116 (5)(b) AND
ANY INCOME AND INTEREST DERIVED FROM THE DEPOSIT AND INVESTMENT
OF THE MONEY IS EXEMPT FROM ANY RESTRICTION ON SPENDING,
REVENUE, OR APPROPRIATIONS, INCLUDING, WITHOUT LIMITATION, THE
RESTRICTIONS OF SECTION 20 OF ARTICLE X OF THE STATE
CONSTITUTION.".
