"AN ACT CONCERNING TRANSPARENCY IN EDUCATION."

- 1 After the last section, add the following and renumber sections and
- 2 internal references accordingly:
- 3 "Sec. 501. (*Effective from passage*) (a) There is established a task force to
- 4 study ways to reverse the academic achievement decline in the state.
- 5 (b) The task force shall consist of the following members:
- 6 (1) One appointed by the speaker of the House of Representatives;
- 7 (2) One appointed by the president pro tempore of the Senate;
- 8 (3) One appointed by the majority leader of the House of
- 9 Representatives;

- 10 (4) One appointed by the majority leader of the Senate;
- 11 (5) One appointed by the minority leader of the House of 12 Representatives;
- 13 (6) One appointed by the minority leader of the Senate; and
- 14 (7) The Commissioner of Education, or the commissioner's designee.
- 15 (c) Any member of the task force appointed under subdivision (1),
- 16 (2), (3), (4), (5) or (6) of subsection (b) of this section may be a member
- 17 of the General Assembly.

- (d) All initial appointments to the task force shall be made not later
- 19 than thirty days after the effective date of this section. Any vacancy shall
- 20 be filled by the appointing authority.
- 21 (e) The speaker of the House of Representatives and the president pro
- 22 tempore of the Senate shall select the chairpersons of the task force from
- 23 among the members of the task force. Such chairpersons shall schedule
- 24 the first meeting of the task force, which shall be held not later than sixty
- 25 days after the effective date of this section.
- 26 (f) The administrative staff of the joint standing committee of the
- 27 General Assembly having cognizance of matters relating to education
- 28 shall serve as administrative staff of the task force.
- 29 (g) Not later than January 1, 2024, the task force shall submit a report
- on its findings and recommendations to the joint standing committee of
- 31 the General Assembly having cognizance of matters relating to
- 32 education, in accordance with the provisions of section 11-4a of the
- 33 general statutes. The task force shall terminate on the date that it
- 34 submits such report or January 1, 2024, whichever is later."

This act shall take effect as follows and shall amend the following sections:
