30	2001, effective March 6, 2002 (D.C. Law 14-76; D.C. Official Code § 2-1831.03(b-2)(2)).
31	Notwithstanding any other provision of law, the burden of production of evidence and the burden
32	of persuasion at a hearing in such appeal shall be upon the Chief or his designated agent. This

provision controls over, and may not be altered by, any rule of procedure or regulation
promulgated by either the Office of Administrative Hearings or the Metropolitan Police
Department.".
