## AS PASSED SENATE

## A BILL TO BE ENTITLED AN ACT

1 To amend Part 5 of Article 4 of Chapter 11 of Title 16 of the Official Code of Georgia 2 Annotated, relating to Brady Law regulations, so as to revise standards for bringing an action 3 against the government for an unauthorized act relating to regulation of weapons; to provide 4 for definitions; to provide for related matters; to repeal conflicting laws; and for other 5 purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

8 <u>The General Assembly recognizes the importance of securing firearms for lawful purposes.</u>

16	(1) 'Lawful weapons carrier' shall have the same meaning as set forth in Code

37	(2) The authority to bring suit and right to recover against any weapons, firearms, or
38	ammunition manufacturer, trade association, or dealer by or on behalf of any

exclusively to the state. This paragraph shall not prohibit a political subdivision or local
government authority from bringing an action against a weapons, firearms, or
ammunition manufacturer or dealer for breach of contract or express warranty as to
weapons, firearms, or ammunition purchased by the political subdivision or local
government authority.

48 (c)(d)(1) A county or municipal corporation may regulate the transport, carrying, or 49 possession of firearms by employees of the local unit of government, or by unpaid 50 volunteers of such local unit of government, in the course of their employment or 51 volunteer functions with such local unit of government; provided, however, that the 52 sheriff or chief of police shall be solely responsible for regulating and determining the 53 possession, carrying, and transportation of firearms and other weapons by employees 54 under his or her respective supervision so long as such regulations comport with state and 55 federal law.

(2) The commanding officer of any law enforcement agency shall regulate and determine
the possession, carrying, and transportation of firearms and other weapons by employees
under his or her supervision so long as such regulations comport with state and federal
law.

(3) The district attorney, and the solicitor-general in counties where there is a state court,
 shall regulate and determine the possession, carrying, and transportation of firearms and
 other weapons by county employees under his or her supervision so long as such
 regulations comport with state and federal law.

64 (d)(e) Nothing contained in this Code section shall prohibit municipalities or counties, by
 65 ordinance or resolution, from requiring the ownership of guns by heads of households
 66 within the political subdivision.

67 (e)(f) Nothing contained in this Code section shall prohibit municipalities or counties, by
 68 ordinance or resolution, from reasonably limiting or prohibiting the discharge of firearms
 69 within the boundaries of the municipal corporation or county.

70	(f) As used in this Code section, the term 'weapon' means any device designed or intended
71	to be used, or capable of being used, for offense or defense, including but not limited to
72	firearms, bladed devices, clubs, electric stun devices, and defense sprays.
73	(g) Any person aggrieved as a result of a violation of this Code section may bring an
74	action against the person who caused such aggrievement. The aggrieved person shall be
75	entitled to reasonable attorney's fees and expenses of litigation and may recover or obtain
76	against the person who caused such damages any of the following:
77	(1) Actual damages or \$100.00, whichever is greater;
78	(2) Equitable relief, including, but not limited to, an injunction or restitution of money
79	and property; and
80	(3) Any other relief which the court deems proper Any individual who is a lawful
81	weapons carrier who is or has been subject to an act, rule, regulation, ordinance, or
82	resolution in violation of this Code section shall have standing to bring:
83	(1) An action in mandamus or other legal proceeding against a public entity or public
84	officer in his or her official capacity to obtain declaratory or injunctive relief. A
85	prevailing plaintiff in such action shall be entitled to recover his or her costs in such
86	action, including reasonable attorney's fees; or
87	(2) A civil action when such individual suffers personal, property, or economic damage
88	and recover the greater of:
89	(A) Actual damages or \$50,000.00, whichever is greater, plus the expenses of litigation
90	and reasonable attorney's fees; or
91	(B) Liquidated damages of three times the expenses of litigation and reasonable
92	attorney's fees.
93	(h) Any action brought pursuant to this Code section shall be brought in the superior court
94	of the county in which the violation occurred and within one year of such violation."
