Amendments proposed by House Committee on Administration of Criminal Justice to Reengrossed Senate Bill No. 118 by Senator Morris

1 AMENDMENT NO. 1

2 On page 1, at the end of line 2, after the comma "," insert "and R.S. 40:1379.3.3"

3 AMENDMENT NO. 2

4 On page 1, line 5, after "exceptions;" and before "and" insert "to provide relative to the
5 completion of a sixty-minute online concealed handgun education course; to provide relative
6 to a database of licensed firearm and handgun instructors; to provide relative to blood
7 alcohol readings;"

8 AMENDMENT NO. 3

9 On page 1, at the end of line 16, after "reenacted" insert "and R.S. 40:1379.3.3 is hereby
10 enacted"

11 AMENDMENT NO. 4

12 On page 2, line 8, insert the following:

13 ~~"(2) A Louisiana resident shall be required to possess a valid concealed~~
14 ~~handgun permit issued by the state of Louisiana pursuant to the provisions of this~~
15 ~~Section in order to carry a concealed handgun in the state of Louisiana **who meets**~~
16 ~~**the qualifications of R.S. 14:95(M) shall not be required to possess a valid**~~
17 ~~**concealed handgun permit issued by the state of Louisiana pursuant to the**~~
18 ~~**provisions of this Section in order to carry a concealed handgun in the state of**~~
19 ~~**Louisiana. The provisions of this Subsection shall not affect the requirements**~~
20 ~~**of reciprocity as provided in Subsection T of this Section."**~~

21 AMENDMENT NO. 5

22 On page 3, after line 10, add the following:

23 **"§1379.3.3. Louisiana permitless carry**
24 **A. The Department of Public Safety and Corrections, office of state**
25 **police shall provide a sixty-minute online concealed handgun education course**
26 **at no cost to Louisiana residents.**
27 **B. The concealed handgun education course shall cover the following**
28 **topics:**
29 **(1) Concealed handgun basics and nomenclature.**
30 **(2) Firearm free zones.**
31 **(3) Use of deadly force.**
32 **(4) Interactions with law enforcement officers.**
33 **C. The sixty-minute concealed handgun education course provided by**
34 **this Section does not fulfill the requirements for obtaining a concealed handgun**
35 **permit under R.S. 40:1379.3.**
36 **D. State police shall maintain an online database of all licensed handgun**
37 **and firearm instructors to allow the public to search for classes.**
38 **E. The Department of Public Safety and Corrections, office of state**
39 **police shall promulgate rules and regulations in accordance with the**
40 **Administrative Procedure Act to implement the provisions of this Section."**
