A BILL ENTITLED

1 AN ACT concerning

2 **General Provisions – Public Information Act – Enforcement, Fees, and**
3 **Exemptions**

4 FOR the purpose of altering certain provisions of law regarding the maintenance of public
5 records relating to certain agricultural operations and programs; establishing the
6 State Public Information Act Compliance Board; requiring the Governor to publish
7 on the Governor’s Office Web site certain notice relating to applications for
8 membership on the Board and the names and qualifications of certain applicants;
9 authorizing the Governor to broadcast certain interviews on the Governor’s Office
10 Web site; requiring the Governor, with the advice and consent of the Senate, to
11 appoint the members of the Board from a certain pool of applicants; providing for the
12 composition, chair, terms, and meetings of the Board; prohibiting a member of the
13 Board from receiving certain compensation, but authorizing the reimbursement of
14 certain expenses; requiring the Office of the Attorney General to provide staff for the
15 Board; providing for the powers and duties of the Board; authorizing any person to
16 file a certain complaint with the Board; requiring that the complaint contain certain
17 information and be signed by the complainant; requiring the Board to take certain
18 action regarding a complaint and filed within a certain time period; requiring a
19 custodian who receives a complaint from the Board to file a certain response within
20 a certain time period; requiring the Board to maintain the confidentiality of a certain
21 public record; authorizing the Board, under certain circumstances, to hold a certain
22 conference; providing that a certain conference held by the Board is not a contested
23 case; requiring the Board to assess certain statutory damages and reimbursement of
24 certain fees under certain circumstances; providing that compliance by a custodian
25 with an order of the Board is not a certain admission and may not be used as evidence
26 in a certain proceeding; providing that a complainant is not required to exhaust
27 certain administrative remedies before seeking certain judicial review; repealing
28 certain provisions of law related to the administrative review of a decision to deny
29 inspection of a public record; requiring a person receiving benefits from the State to

1 relinquish certain public records to a certain custodian; establishing that failure to
2 comply with a certain provision of law constitutes a denial of a certain application
3 and may not be considered the result of a bona fide dispute; altering a certain
4 provision of law to require a custodian who denies an application to inspect public
5 records to provide certain information to the applicant within certain periods of time;
6 repealing a certain limitation on the requirement that a custodian allow inspection
7 of any part of a record that is subject to disclosure; prohibiting a custodian from
8 denying or ignoring an application to inspect public records on certain grounds;
9 altering certain provisions of law that authorize a custodian to charge a reasonable
10 fee for certain tasks relating to public records requests; authorizing a custodian to
11 require a certain statement from an applicant under certain circumstances;
12 prohibiting an applicant from obtaining any part of a public record under certain
13 circumstances; requiring the Board to establish a penalty for a certain violation of a
14 certain provision of this Act; requiring a custodian within a certain period of time to
15 provide certain evidence to the Board if the custodian refuses to waive a certain fee
16 under certain circumstances; requiring a custodian to provide certain proof to the
17 Board if an applicant challenges a certain denial to disclose certain public records;
18 establishing that certain defendants are liable for certain statutory damages under
19 certain circumstances; repealing certain burdens of proof that a complainant must
20 show to recover certain damages in a certain court; defining certain terms; specifying
21 the initial terms of the members of the Board; making conforming changes; providing
22 for the effective dates of this Act; and generally relating to the Public Information
23 Act.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Agriculture**

6 8–801.1.

7 **(A) IN THIS SECTION, “PERSONAL INFORMATION” MEANS AN INDIVIDUAL’S**
8 **NAME, HOME TELEPHONE NUMBER, PERSONAL EMAIL ADDRESS, AND SOCIAL**
9 **SECURITY NUMBER.**

10 **[(a)] (B)** (1) Each nutrient management plan shall be developed considering
11 factors including:

12 (i) Levels of bioavailable nitrogen and phosphorus in the soil;

13 (ii) Levels of bioavailable nitrogen and phosphorus in all fertilizer
14 materials to be applied;

15 (iii) The amount of nitrogen and phosphorus necessary to achieve the
16 expected crop yield for the land that is the subject of the nutrient management plan, as
17 determined by:

18 1. The field’s actual yield record and soil productivity for that
19 crop; or

20 2. If information concerning actual yield record and soil
21 productivity for a crop is unavailable, relevant information concerning similar fields and
22 soil;

23 (iv) Soil erodibility and nutrient retention capacity;

24 (v) 1. The best reasonable scientific methods accepted by the
25 Department and the University of Maryland Cooperative Extension Service; or

26 2. Scientifically validated data for the development of a
27 nutrient management plan as defined by the Department in regulation; and

28 (vi) Existing best management practices.

29 (2) Each nutrient management plan shall provide flexibility for
30 management decisions that may be required by conditions beyond the control of the farmer.

1 **[(b)] (C)** (1) A summary of each nutrient management plan shall be filed and
2 updated with the Department at a time and in a form that the Department requires by
3 regulation.

4 (2) The Department shall maintain a copy of each summary for 3 years in
5 a manner that protects the **[identity] PERSONAL INFORMATION** of the individual for
6 whom the nutrient management plan was prepared.

8 **(A) IN THIS SECTION, “PERSONAL INFORMATION” MEANS AN INDIVIDUAL’S**
9 **NAME, HOME TELEPHONE NUMBER, PERSONAL EMAIL ADDRESS, AND SOCIAL**
10 **SECURITY NUMBER.**

11 **[(a)] (B)** Except as provided in § 8–1007(b) of this subtitle, all records and
12 information concerning any agricultural operation certified by the Department under this
13 subtitle shall be maintained by the Department and made available for public review in a
14 manner that provides the greatest public disclosure of records and information while
15 protecting the identity of the person for whom the records or information relates.

16 **[(b)] (C)** Except as provided in § 8–1008(b) of this subtitle, a certified verifier
17 shall maintain all records and information concerning a certified agricultural operation in
18 a manner that protects the identity of the person for whom the records or information
19 relates.

20 **[(c)] (D)** (1) Except as otherwise provided by law, the Department of the
21 Environment shall maintain all records and information received from the Department
22 under §§ 8–1004(c)(2) and 8–1007(b) of this subtitle in a manner that protects the **[identity]**
23 **PERSONAL INFORMATION** of the person for whom the records or information relates.

24 (2) This subsection does not affect the maintenance and disclosure of
25 records and information obtained from any other source by the Department of the
26 Environment, even if the records and information are duplicative of information provided
27 to the Department of the Environment by the Department under this subtitle.

28 **[(d)] (E)** Except as provided in § 8–1007(b) of this subtitle, records and
29 information relating to an agricultural operation that are generated or obtained solely for
30 the purpose of obtaining certification may not be disclosed by any State agency,
31 department, or certified verifier before the agricultural operation is certified under this
32 subtitle.

33 **[(e)] (F)** On or before December 31, 2014, and each December 31 thereafter, the
34 Department shall submit an annual report to the Governor and, in accordance with §
35 2–1246 of the State Government Article, the Senate Education, Health, and Environmental
36 Affairs Committee and the House Environmental Matters Committee on:

1 (1) Participation in the Program; and

2 (2) Recommendations of the oversight committee established in § 8–1013
3 of this subtitle.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
5 as follows:

6 **Article – General Provisions**

7 4–101.

8 (a) In this title the following words have the meanings indicated.

9 (b) “Applicant” means a person or governmental unit that asks to inspect a public
10 record.

11 (c) **“BOARD” MEANS THE STATE PUBLIC INFORMATION ACT COMPLIANCE**
12 **BOARD.**

13 [(c)] (D) “Custodian” means:

14 (1) the official custodian; or

15 (2) any other authorized individual who has physical custody and control
16 of a public record.

17 [(d)] (E) “Official custodian” means an officer or employee of the State or of a
18 political subdivision who is responsible for keeping a public record, whether or not the
19 officer or employee has physical custody and control of the public record.

20 [(e)] (F) “Person in interest” means:

21 (1) a person or governmental unit that is the subject of a public record or a
22 designee of the person or governmental unit;

23 (2) if the person has a legal disability, the parent or legal representative of
24 the person; or

25 (3) as to requests for correction of certificates of death under §
26 5–310(d)(2) of the Health – General Article, the spouse, adult child, parent, adult sibling,
27 grandparent, or guardian of the person of the deceased at the time of the deceased’s death.

28 [(f)] (G) (1) “Personal information” means information that identifies an
29 individual.

1 (2) Except as provided in § 4–355 of this title, “personal information”
2 includes an individual’s:

- 3 (i) name;
- 4 (ii) address;
- 5 (iii) driver’s license number or any other identification number;
- 6 (iv) medical or disability information;
- 7 (v) photograph or computer-generated image;
- 8 (vi) Social Security number; and
- 9 (vii) telephone number.

10 (3) “Personal information” does not include an individual’s:

- 11 (i) driver’s status;
- 12 (ii) driving offenses;
- 13 (iii) five-digit zip code; or
- 14 (iv) information on vehicular accidents.

15 **[(g)] (H)** “Political subdivision” means:

- 16 (1) a county;
- 17 (2) a municipal corporation;
- 18 (3) an unincorporated town;
- 19 (4) a school district; or
- 20 (5) a special district.

21 **[(h)] (I)** (1) “Public record” means the original or any copy of any
22 documentary material that:

- 23 (i) is made by a unit or an instrumentality of the State or of a
24 political subdivision or received by the unit or instrumentality in connection with the
25 transaction of public business; and
- 26 (ii) is in any form, including:

1. a card;
2. a computerized record;
3. correspondence;
4. a drawing;
5. film or microfilm;
6. a form;
7. a map;
8. a photograph or photostat;
9. a recording; or
10. a tape.

(2) "Public record" includes a document that lists the salary of an employee of a unit or an instrumentality of the State or of a political subdivision.

(3) "Public record" does not include a digital photographic image or signature of an individual, or the actual stored data of the image or signature, recorded by the Motor Vehicle Administration.

THERE IS A STATE PUBLIC INFORMATION ACT COMPLIANCE BOARD.

4-1A-02.

(A) (1) THE BOARD CONSISTS OF THREE MEMBERS.

(2) AT LEAST ONE OF THE MEMBERS OF THE BOARD SHALL BE AN ATTORNEY ADMITTED TO THE MARYLAND BAR.

(3) AT LEAST ONE OF THE MEMBERS OF THE BOARD SHALL BE A REPRESENTATIVE FROM A NONGOVERNMENTAL NONPROFIT GROUP THAT IS ORGANIZED IN THE STATE.

1 **(4) (I) THE GOVERNOR SHALL PUBLISH, ON THE GOVERNOR'S**
2 **OFFICE WEB SITE, NOTICE OF THE GOVERNOR'S INTENT TO CONSIDER APPLICANTS**
3 **FOR POSITIONS ON THE BOARD.**

4 **(II) THE NOTICE SHALL INCLUDE:**

5 **1. APPLICATION PROCEDURES;**

6 **2. CRITERIA FOR EVALUATING AN APPLICANT'S**
7 **QUALIFICATIONS; AND**

8 **3. PROCEDURES FOR RESOLVING ANY CONFLICTS OF**
9 **INTEREST.**

10 **(III) 1. AN INDIVIDUAL MAY SUBMIT TO THE GOVERNOR AN**
11 **APPLICATION FOR MEMBERSHIP ON THE BOARD AS PROVIDED UNDER**
12 **SUBPARAGRAPH (II) OF THIS PARAGRAPH.**

13 **2. THE NAMES AND QUALIFICATIONS OF APPLICANTS**
14 **SHALL BE POSTED ON THE GOVERNOR'S OFFICE WEB SITE AND INTERVIEWS MAY**
15 **BE BROADCAST ON THE WEB SITE.**

16 **(IV) WHEN EVALUATING AN APPLICANT, THE GOVERNOR SHALL**
17 **CONSIDER THE NEED FOR GEOGRAPHIC AND POLITICAL DIVERSITY ON THE BOARD.**

18 **(5) SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION AND**
19 **WITH THE ADVICE AND CONSENT OF THE SENATE, THE GOVERNOR SHALL APPOINT**
20 **THE MEMBERS OF THE BOARD FROM THE POOL OF APPLICANTS UNDER PARAGRAPH**
21 **(4) OF THIS SUBSECTION.**

22 **(B) FROM AMONG THE MEMBERS OF THE BOARD, THE GOVERNOR SHALL**
23 **APPOINT A CHAIR.**

24 **(C) (1) THE TERM OF A MEMBER IS 3 YEARS.**

25 **(2) THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE**
26 **TERMS PROVIDED FOR MEMBERS OF THE BOARD ON OCTOBER 1, 2015.**

27 **(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL**
28 **A SUCCESSOR IS APPOINTED.**

29 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
30 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED.**

1 **(5) A MEMBER MAY NOT SERVE FOR MORE THAN TWO CONSECUTIVE**
2 **3-YEAR TERMS.**

3 **4-1A-03.**

4 **(A) A MAJORITY OF THE FULL AUTHORIZED MEMBERSHIP OF THE BOARD IS**
5 **A QUORUM.**

6 **(B) THE BOARD SHALL DETERMINE THE TIMES AND PLACES OF ITS**
7 **MEETINGS.**

8 **(C) A MEMBER OF THE BOARD:**

9 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;**
10 **BUT**

11 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
12 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

13 **(D) THE OFFICE OF THE ATTORNEY GENERAL SHALL PROVIDE STAFF FOR**
14 **THE BOARD.**

16 **(A) THE BOARD SHALL:**

17 **(1) RECEIVE, REVIEW, AND, SUBJECT TO § 4-1A-07 OF THIS**
18 **SUBTITLE, RESOLVE COMPLAINTS FROM ANY PERSON ALLEGING THAT A**
19 **CUSTODIAN:**

20 **(I) DENIED INSPECTION OF A PUBLIC RECORD IN VIOLATION OF**
21 **THIS TITLE;**

22 **(II) CHARGED AN UNREASONABLE FEE OF MORE THAN \$250**
23 **UNDER § 4-206 OF THIS TITLE; OR**

24 **(III) IMPROPERLY DENIED A FEE WAIVER UNDER § 4-206(E) OF**
25 **THIS TITLE;**

26 **(2) ISSUE A WRITTEN OPINION AS TO WHETHER A VIOLATION HAS**
27 **OCCURRED; AND**

1 **(3) ORDER THE CUSTODIAN TO:**

2 **(I) IF THE BOARD FINDS THAT THE CUSTODIAN DENIED**
3 **INSPECTION OF A PUBLIC RECORD IN VIOLATION OF THIS TITLE, PRODUCE THE**
4 **PUBLIC RECORD FOR INSPECTION;**

5 **(II) IF THE BOARD FINDS THAT THE CUSTODIAN CHARGED AN**
6 **UNREASONABLE FEE OF MORE THAN \$250 UNDER § 4-206 OF THIS TITLE, REDUCE**
7 **THE FEE TO AN AMOUNT DETERMINED BY THE BOARD TO BE REASONABLE AND**
8 **REFUND THE DIFFERENCE; OR**

9 **(III) IF THE BOARD FINDS THAT THE CUSTODIAN IMPROPERLY**
10 **DENIED A FEE WAIVER UNDER § 4-206(E) OF THIS TITLE, WAIVE THE FEE.**

11 **(B) THE BOARD SHALL:**

12 **(1) ADOPT REGULATIONS TO CARRY OUT THIS TITLE;**

13 **(2) STUDY ONGOING COMPLIANCE WITH THIS TITLE BY CUSTODIANS;**
14 **AND**

15 **(3) MAKE RECOMMENDATIONS TO THE GENERAL ASSEMBLY FOR**
16 **IMPROVEMENTS TO THIS TITLE.**

17 **(C) (1) ON OR BEFORE OCTOBER 1 OF EACH YEAR, THE BOARD SHALL**
18 **SUBMIT A REPORT TO THE GOVERNOR AND, SUBJECT TO § 2-1246 OF THE STATE**
19 **GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY.**

20 **(2) THE REPORT SHALL:**

21 **(I) DESCRIBE THE ACTIVITIES OF THE BOARD;**

22 **(II) DESCRIBE THE OPINIONS OF THE BOARD;**

23 **(III) STATE THE NUMBER AND NATURE OF COMPLAINTS FILED**
24 **WITH THE BOARD AND DISCUSS COMPLAINTS THAT THE INSPECTION OF PUBLIC**
25 **RECORDS WAS DENIED; AND**

26 **(IV) RECOMMEND ANY IMPROVEMENTS TO THIS TITLE.**

1 **(A) ANY PERSON MAY FILE A WRITTEN COMPLAINT WITH THE BOARD**
2 **SEEKING A WRITTEN OPINION AND ORDER FROM THE BOARD ALLEGING THAT A**
3 **CUSTODIAN:**

4 **(1) DENIED INSPECTION OF A PUBLIC RECORD IN VIOLATION OF THIS**
5 **TITLE;**

6 **(2) CHARGED AN UNREASONABLE FEE OF MORE THAN \$250 UNDER §**
7 **4-206 OF THIS TITLE; OR**

8 **(3) IMPROPERLY DENIED A FEE WAIVER UNDER § 4-206(E) OF THIS**
9 **TITLE.**

10 **(B) THE COMPLAINT SHALL:**

11 **(1) IDENTIFY THE CUSTODIAN THAT IS THE SUBJECT OF THE**
12 **COMPLAINT;**

13 **(2) DESCRIBE THE ACTION OF THE CUSTODIAN, THE DATE OF THE**
14 **ACTION, AND THE CIRCUMSTANCES OF THE ACTION;**

15 **(3) BE SIGNED BY THE COMPLAINANT;**

16 **(4) IF AVAILABLE, INCLUDE A COPY OF THE ORIGINAL REQUEST FOR**
17 **PUBLIC RECORDS; AND**

18 **(5) BE FILED WITHIN 90 DAYS AFTER THE ACTION THAT IS THE**
19 **SUBJECT OF THE COMPLAINT OCCURRED.**

20 **4-1A-06.**

21 **(A) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, ON**
22 **RECEIPT OF A WRITTEN COMPLAINT, THE BOARD PROMPTLY SHALL:**

23 **(1) SEND THE COMPLAINT TO THE CUSTODIAN IDENTIFIED IN THE**
24 **COMPLAINT; AND**

25 **(2) REQUEST THAT A RESPONSE TO THE COMPLAINT BE SENT TO THE**

3 **(I) IF THE COMPLAINT ALLEGES THAT THE CUSTODIAN DENIED**
4 **INSPECTION OF A PUBLIC RECORD IN VIOLATION OF THIS TITLE:**

5 **1. A COPY OF THE PUBLIC RECORD; AND**

6 **2. THE PROVISION OF LAW THAT THE CUSTODIAN**
7 **ALLEGES ALLOWS THE CUSTODIAN TO DENY INSPECTION OF THE PUBLIC RECORD;**

8 **(II) IF THE COMPLAINT ALLEGES THAT THE CUSTODIAN**
9 **CHARGED AN UNREASONABLE FEE OF MORE THAN \$250 UNDER § 4-206 OF THIS**
10 **TITLE, THE BASIS FOR THE FEE THAT WAS CHARGED; OR**

11 **(III) IF THE COMPLAINT ALLEGES THAT THE CUSTODIAN**
12 **IMPROPERLY DENIED A FEE WAIVER UNDER § 4-206(E) OF THIS TITLE, THE BASIS**
13 **FOR THE DENIAL.**

14 **(3) THE BOARD SHALL MAINTAIN THE CONFIDENTIALITY OF A**
15 **PUBLIC RECORD SUBMITTED BY A CUSTODIAN UNDER PARAGRAPH (2) OF THIS**
16 **SUBSECTION.**

17 **(C) IF A WRITTEN RESPONSE IS NOT RECEIVED WITHIN 45 DAYS AFTER THE**
18 **NOTICE IS SENT, THE BOARD SHALL DECIDE THE CASE ON THE FACTS BEFORE THE**
19 **BOARD.**

20 **4-1A-07.**

21 **(A) (1) THE BOARD SHALL REVIEW THE COMPLAINT AND ANY RESPONSE.**

22 **(2) IF THE INFORMATION IN THE COMPLAINT AND RESPONSE IS**
23 **SUFFICIENT FOR MAKING A DETERMINATION BASED ON THE BOARD'S OWN**
24 **INTERPRETATION OF THE EVIDENCE, WITHIN 30 DAYS AFTER RECEIVING THE**
25 **RESPONSE, THE BOARD SHALL ISSUE A WRITTEN OPINION AS TO WHETHER A**
26 **VIOLATION OF THIS TITLE HAS OCCURRED OR WILL OCCUR.**

27 **(B) (1) IF THE BOARD IS UNABLE TO REACH A DETERMINATION BASED ON**
28 **THE WRITTEN SUBMISSIONS BEFORE IT, THE BOARD MAY SCHEDULE AN INFORMAL**
29 **CONFERENCE TO HEAR FROM THE COMPLAINANT, THE CUSTODIAN, OR ANY OTHER**
30 **PERSON WITH RELEVANT INFORMATION ABOUT THE SUBJECT OF THE COMPLAINT.**

1 **(2) AN INFORMAL CONFERENCE SCHEDULED BY THE BOARD IS NOT A**
2 **CONTESTED CASE WITHIN THE MEANING OF § 10-202(D) OF THE STATE**
3 **GOVERNMENT ARTICLE.**

4 **(3) THE BOARD SHALL ISSUE A WRITTEN OPINION WITHIN 30 DAYS**
5 **AFTER THE INFORMAL CONFERENCE.**

6 **(C) (1) IF THE BOARD IS UNABLE TO ISSUE AN OPINION ON A COMPLAINT**
