3 FOR the purpose of providing that certain requirements of the federal Patient Protection
4 and Affordable Care Act relating to prescription drug benefits apply to certain
5 coverage offered in certain markets; repealing a certain provision of law providing
6 for the applicability of a certain limitation on certain deductibles for certain health
7 insurance coverage; altering certain provisions of law relating to the provision of
8 benefits for the diagnosis and treatment of a mental illness, an emotional disorder,
9 a drug abuse disorder, or an alcohol abuse disorder to conform to the requirements
10 of the federal Mental Health Parity and Addiction Equity Act; applying the
11 provisions to health maintenance organizations and repealing certain duplicative
12 provisions of law; ~~requiring certain insurers, nonprofit health service plans, and~~
13 ~~health maintenance organizations to have procedures in place for certain individuals~~
14 ~~to request an expedited review of a request for coverage of a nonformulary drug or~~
15 ~~device based on a certain exigent circumstance; requiring the insurers, nonprofit~~

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

15 (a) Notwithstanding any other provisions of law, the following provisions of Title
16 I, Subtitles A, C, and D of the Affordable Care Act apply to individual health insurance
17 coverage and health insurance coverage offered in the small group and large group
18 markets, as those terms are defined in the federal Public Health Service Act, issued or
19 delivered in the State by an authorized insurer, nonprofit health service plan, or health
20 maintenance organization:

- 21 (1) coverage of children up to the age of 26 years;
22 (2) preexisting condition exclusions;
23 (3) policy rescissions;
24 (4) bona fide wellness programs;
25 (5) lifetime limits;
26 (6) annual limits for essential benefits;
27 (7) waiting periods;
28 (8) designation of primary care providers;
29 (9) access to obstetrical and gynecological services;
30 (10) emergency services;

1 (11) summary of benefits and coverage explanation;

2 (12) minimum loss ratio requirements and premium rebates;

3 (13) disclosure of information;

4 (14) annual limitations on cost sharing;

5 (15) child-only plan offerings in the individual market;

6 (16) minimum benefit requirements for catastrophic plans;

7 (17) health insurance premium rates;

8 (18) coverage for individuals participating in approved clinical trials;

9 (19) contract requirements for stand-alone dental plans sold on the
10 Maryland Health Benefit Exchange; [and]

16 Act, issued or delivered in the State by an authorized insurer, nonprofit health service plan,
17 or health maintenance organization.

18 (c) The provisions of [subsections (a) and (b)] SUBSECTION (A) of this section do
19 not apply to coverage for excepted benefits, as defined in 45 C.F.R. § 146.145(c).

20 [(d)] (C) The Commissioner may enforce this section under any applicable
21 provisions of this article.

23 (a) (1) In this section the following words have the meanings indicated.

24 (2) "Alcohol abuse" has the meaning stated in § 8-101 of the Health –
25 General Article.

1 **(4) “GRANDFATHERED HEALTH PLAN COVERAGE” HAS THE MEANING**
2 **STATED IN 45 C.F.R. § 147.140.**

3 **[(4)] (5) “Health benefit plan”:**

4 **(I) FOR A GROUP OR BLANKET PLAN,** has the meaning stated in §
5 15–1401 of this title; **AND**

6 **(II) FOR AN INDIVIDUAL PLAN, HAS THE MEANING STATED IN §**
7 **15–1301 OF THIS TITLE.**

8 **[(5) “Large employer” means an employer that has more than 50 employees**
9 **and is not a small employer.]**

10 (6) “Managed care system” means a system of cost containment methods
11 that a carrier uses to review and preauthorize a treatment plan developed by a health care
12 provider for a covered individual in order to control utilization, quality, and claims.

13 (7) “Partial hospitalization” means the provision of medically directed

15 (i) to an insured, subscriber, or member;

16 (ii) in a licensed or certified facility or program;

17 (iii) for mental illness, emotional disorders, drug abuse, or alcohol

26 **HEALTH PLAN COVERAGE, THIS** section applies to each [health insurance policy or
27 contract] **INDIVIDUAL, GROUP, AND BLANKET HEALTH BENEFIT PLAN** that is delivered
28 or issued for delivery in the State [to an employer or individual on a group or individual
29 basis and that provides coverage on an expense–incurred basis] **BY AN INSURER, A**
30 **NONPROFIT HEALTH SERVICE PLAN, OR A HEALTH MAINTENANCE ORGANIZATION.**

1 (c) A [policy or contract] **HEALTH BENEFIT PLAN** subject to this section [may
2 not discriminate against] **SHALL PROVIDE AT LEAST THE FOLLOWING BENEFITS FOR**
3 **THE DIAGNOSIS AND TREATMENT OF** [an individual with] a mental illness, emotional
4 disorder, drug abuse disorder, or alcohol abuse disorder [by failing to provide benefits for
5 the diagnosis and treatment of these illnesses under the same terms and conditions that
6 apply under the policy or contract for the diagnosis and treatment of physical illnesses.

7 (d) It is not discriminatory under subsection (c) of this section if at least the
8 following benefits are provided]:

9 (1) [with respect to] inpatient benefits for services provided in a licensed
10 or certified facility, including hospital inpatient benefits[, the total number of days for
11 which benefits are payable and the terms and conditions that apply to those benefits are at
12 least equal to those that apply to the benefits available under the policy or contract for
13 physical illnesses];

14 (2) [except as provided in item (3) of this subsection and subject to
15 subsection (g) of this section, with respect to benefits for partial hospitalization, at least 60
16 days of partial hospitalization are covered under the same terms and conditions that apply
17 to the benefits available under the policy or contract for physical illnesses;

18 (3) for group contracts covering employees of one or more large employers,
19 with respect to benefits for] partial hospitalization [for the treatment of mental illness,
20 emotional disorders, drug abuse, and alcohol abuse, the greater of:

21 (i) the same benefits payable under the contract for partial
22 hospitalization for physical illness; or

23 (ii) at least 60 days of partial hospitalization covered under the same
24 terms and conditions that apply to outpatient treatment of physical illnesses] **BENEFITS;**

25 [(4) except as provided in item (5) of this subsection, with respect to
26 outpatient coverage, other than for inpatient or partial hospitalization services, benefits for
27 covered expenses arising from services, including psychological and neuropsychological
28 testing for diagnostic purposes, provided to treat mental illnesses, emotional disorders,
29 drug abuse, or alcohol abuse are at a rate that, after the applicable deductible, is not less
30 than:

31 (i) 80% for the first five visits in a calendar year or benefit period of
32 not more than 12 months;

33 (ii) 65% for the 6th through 30th visit in a calendar year or benefit
34 period of not more than 12 months; and

35 (iii) 50% for the 31st visit and any subsequent visit in a calendar year
36 or benefit period of not more than 12 months;] and

1 ~~[(5)] (3)~~ [for group contracts covering employees of one or more large
2 employers, benefits for covered] outpatient [expenses arising from services] **BENEFITS**,
3 including all office visits and psychological and neuropsychological testing for diagnostic
4 purposes[, provided to treat mental illnesses, emotional disorders, drug abuse, or alcohol
5 abuse are covered under the same terms and conditions that apply to similar benefits
6 available under the contract for physical illnesses].

7 ~~[(e)] (D)~~ (1) The benefits under this section are required only for expenses
8 arising from the treatment of mental illnesses, emotional disorders, drug abuse, or alcohol
9 abuse if, in the professional judgment of health care providers:

10 (i) the mental illness, emotional disorder, drug abuse, or alcohol
11 abuse is treatable; and

12 (ii) the treatment is medically necessary.

13 (2) The benefits required under this section:

14 (i) shall be provided as one set of benefits covering mental illnesses,
15 emotional disorders, drug abuse, and alcohol abuse;

28 (4) [For group contracts covering employees of one or more large
29 employers, the] **THE** processes, strategies, evidentiary standards, or other factors used to
30 manage the benefits required under this section must be comparable as written and in
31 operation to, and applied no more stringently than, the processes, strategies, evidentiary
32 standards, or other factors used to manage the benefits for physical illnesses covered under
33 the [contract] **HEALTH BENEFIT PLAN**.

1 [(5) Except for the coinsurance requirements under subsection (d)(4) of this
2 section, a policy or contract subject to this section may not have:

3 (i) separate lifetime maximums for physical illnesses and illnesses
4 covered under this section;

5 (ii) separate deductibles and coinsurance amounts for physical
6 illnesses and illnesses covered under this section; or

7 (iii) separate out-of-pocket limits in a benefit period of not more than
8 12 months for physical illnesses and illnesses covered under this section.

9 (6) (i) Subject to subparagraph (ii) of this paragraph, any copayments
10 required under a policy or contract subject to this section for benefits for illnesses covered
11 under this section shall be:

12 1. actuarially equivalent to any coinsurance requirements
13 under this section; or

14 2. if there are no coinsurance requirements, not greater than
15 any copayment required under the policy or contract for a benefit for a physical illness.

16 (ii) **(5)** An insurer [or], nonprofit health service plan, **OR**
17 **HEALTH MAINTENANCE ORGANIZATION** may not charge a copayment **FOR METHADONE**
18 **MAINTENANCE TREATMENT** that is greater than 50% of the daily cost for methadone
19 maintenance treatment.

20 [(f) An office visit to a physician or other health care provider for medication
21 management:

22 (1) may not be counted against the number of visits required to be covered
23 as a part of the benefits required under subsection (d)(4) of this section; and

28 necessary and would serve to prevent inpatient hospitalization.

31 to its insureds **OR MEMBERS**:

3 Equity Act; and

4 (2) notice that the insured **OR MEMBER** may contact the Administration
5 for further information about the benefits.

14 is not in the formulary if, in the judgment of the authorized prescriber:
