- 1 (1) Notice of the admission of the individual;
- 2 (2) The right of the individual to consult with a lawyer that the individual
3 chooses;
- 4 (3) The availability of the services of the legal aid bureaus, lawyer referral
5 services, and other agencies that exist for the referral of individuals who need legal counsel;
- 6 (4) The right of the individual to call or write a lawyer or a referral agency

23 confinement of the individual.

 29 possess a firearm based on credible evidence of dangerousness to others, the hearing officer
 30 shall order the individual who is subject to the involuntary commitment to:

31 (1) Surrender to law enforcement authorities any firearms in the
 32 individual's possession; and

1 (2) *Refrain from possessing a firearm unless the individual is granted relief*
 2 *from firearms disqualification in accordance with § 5-133.3 of the Public Safety Article.*

4 (a) An individual who is admitted voluntarily to a facility, on an informal request,
 5 may leave the facility at any time between 9 a.m. and 4 p.m., unless the admission status
 6 of the individual has been changed to an involuntary admission.

7 (b) **(1)** An individual who has been admitted voluntarily, under a formal
 8 written application, may not be held for more than 3 days after the individual asks for
 9 release, unless the admission status of the individual has been changed to an involuntary
 10 admission.

11 **(2)** **IF THE ADMISSION STATUS OF THE INDIVIDUAL IS CHANGED FROM**
 12 **A VOLUNTARY TO AN INVOLUNTARY ADMISSION, THE FACILITY SHALL NOTIFY THE**
 13 **MENTAL HEALTH DIVISION IN THE OFFICE OF THE PUBLIC DEFENDER, BY E-MAIL**
 14 **OR FACSIMILE, OF THE INVOLUNTARY ADMISSION WITHIN 24 HOURS AFTER THE**
 15 **CHANGE IN ADMISSION STATUS IS MADE.**

16 (c) A minor who has been admitted voluntarily, on the application of a parent or
 17 guardian of the minor, may not be held for more than 3 days after the applicant for the
 18 admission asks for release, unless the admission status of the minor has been changed to
 19 an involuntary admission.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 21 October 1, 2018.
