SUBSTITUTE FOR HOUSE BILL NO. 4918

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 81g. (1) Except as otherwise provided in this section, a
- 2 person who assaults, or assaults and batters, an individual while
- 3 the individual is performing the individual's duties as the
- 4 operator of a bus, street railway vehicle, or train, or because of
- 5 the individual's status as an employee or contractor of a bus
- 6 service, street railway service, or railroad, is guilty of a
- 7 misdemeanor punishable by imprisonment for not more than 93 days, a
- 8 fine of not more than \$1,000.00, or both.
- 9 (2) Except as otherwise provided in this section, a person who





- 1 assaults an individual without a weapon and inflicts serious or
- 2 aggravated injury on that individual without intending to commit
- 3 murder or to inflict great bodily harm less than murder while the
- 4 individual is performing the individual's duties as the operator of
- 5 a bus, street railway vehicle, or train, or because of the
- 6 individual's status as an employee or contractor of a bus service,
- 7 street railway service, or railroad, is guilty of a misdemeanor
- 8 punishable by imprisonment for not more than 1 year, a fine of not
- 9 more than \$2,000.00, or both.
- 10 (3) Except as otherwise provided in this section, a person who
- 11 assaults an individual with a gun, revolver, pistol, knife, iron
- 12 bar, club, brass knuckles, or other dangerous weapon without
- 13 intending to commit murder or to inflict great bodily harm less
- 14 than murder while the individual is performing the individual's
- 15 duties as the operator of a bus, street railway vehicle, or train,
- 16 or because of the individual's status as an employee or contractor
- 17 of a bus service, street railway service, or railroad, is guilty of
- 18 a felony punishable by imprisonment for not more than 4 years, a
- 19 fine of not more than \$4,000.00, or both.
- 20 (4) A person who violates subsection (1) and has a prior
- 21 conviction under this section is guilty of a misdemeanor punishable
- 22 by imprisonment for not more than 180 days, a fine of not more than
- 23 \$2,000.00, or both.
- 24 (5) A person who violates subsection (2) and has a prior
- 25 conviction under this section is guilty of a felony punishable by
- 26 imprisonment for not more than 2 years, a fine of not more than
- 27 \$4,000.00, or both.
- 28 (6) A person who violates subsection (3) and has a prior
- 29 conviction under this section is guilty of a felony punishable by

- 1 imprisonment for not more than 8 years, a fine of not more than
- 2 \$8,000.00, or both.
- 3 (7) This section does not prohibit a person from being charged
- 4 with, convicted of, or punished for any other violation of law
- 5 arising out of the same transaction as the violation of this
- 6 section.
- 7 (8) As used in this section:
- 8 (a) "Bus" means that term as defined in section 4b of the
- 9 Michigan vehicle code, 1949 PA 300, MCL 257.4b.
- 10 (b) "Railroad" means that term as defined in section 109 of
- 11 the railroad code of 1993, 1993 PA 354, MCL 462.109.
- 12 (c) "Street railway service" means 1 or both of the following:
- 13 (i) A street railway as that term is defined in section 109 of
- 14 the railroad code of 1993, 1993 PA 354, MCL 462.109.
- 15 (ii) A street railway system as that term is defined in section
- 16 507 of the recodified tax increment financing act, 2018 PA 57, MCL
- 17 125.4507.
- (d) "Street railway vehicle" means a streetcar, trolly, or
- 19 tram that is operated on a rail.
- 20 (e) "Train" means railroad train as that term is defined in
- 21 section 49 of the Michigan vehicle code, 1949 PA 300, MCL 257.49.
- 22 Enacting section 1. This amendatory act takes effect 90 days
- 23 after the date it is enacted into law.
