7 Be it enacted by the people of the State of Nebraska,

Section 1. Section 60-336.01, Revised Statutes Cumulative
 Supplement, 2014, is amended to read:

60-336.01 Low-speed vehicle means a four-wheeled motor vehicle (1) whose speed attainable in one mile is more than twenty miles per hour and not more than twenty-five miles per hour on a paved, level surface, (2) whose gross vehicle weight rating is less than three thousand pounds, and (3) that complies with 49 C.F.R. part 571, as such part existed on January 1, <u>2015</u> 2014.

9 Sec. 2. Section 60-3,113.04, Revised Statutes Cumulative Supplement,
10 2014, is amended to read:

11 60-3,113.04 (1) A handicapped or disabled parking permit shall be of 12 a design, size, configuration, color, and construction and contain such 13 information as specified in the regulations adopted by the United States 14 Department of Transportation in 23 C.F.R. part 1235, UNIFORM SYSTEM FOR 15 PARKING FOR PERSONS WITH DISABILITIES, as such regulations existed on 16 January 1, <u>2015</u> 2014.

(2) No handicapped or disabled parking permit shall be issued to any person or for any motor vehicle if any permit has been issued to such person or for such motor vehicle and such permit has been suspended pursuant to section 18-1741.02. At the expiration of such suspension, a permit may be renewed in the manner provided for renewal in sections 60-3,113.02, 60-3,113.03, and 60-3,113.05.

23 (3) A duplicate handicapped or disabled parking permit may be 24 provided up to two times during any single permit period if a permit is destroyed, lost, or stolen. Such duplicate permit shall be issued as 25 provided in section 60-3,113.02 or 60-3,113.03, whichever is applicable, 26 except that a new certification by a physician, a physician assistant, or 27 28 an advanced practice registered nurse need not be provided. A duplicate permit shall be valid for the remainder of the period for which the 29 original permit was issued. If a person has been issued two duplicate 30 permits under this subsection and needs another permit, such person shall 31

reapply for a new permit under section 60-3,113.02 or 60-3,113.03,
 whichever is applicable.

60-3,193.01 For purposes of the Motor Vehicle Registration Act, the
International Registration Plan is adopted and incorporated by reference

Sec. 5. Section 60-479.01, Revised Statutes Cumulative Supplement,
2014, is amended to read:

17 60-479.01 (1) All persons handling source documents or engaged in 18 the issuance of new, renewed, or reissued operators' licenses or state 19 identification cards shall have periodic fraudulent document recognition 20 training.

21 (2) This subsection applies beginning on an implementation date 22 designated by the director on or before January 1, 2014. All persons and agents of the department involved in the recording of verified 23 application information or verified operator's license and state 24 25 identification card information, involved in the manufacture or production of licenses or cards, or who have the ability to affect 26 information on such licenses or cards shall be subject to a criminal 27 history record information check, including a check of prior employment 28 references, and a lawful status check as required by 6 C.F.R. part 37, as 29 such part existed on January 1, <u>2015</u> 2014. Such persons and agents shall 30 provide fingerprints which shall be submitted to the Federal Bureau of 31

Investigation. The bureau shall use its records for the criminal history
 record information check.

3 (3) Upon receipt of a request pursuant to subsection (2) of this section, the Nebraska State Patrol shall undertake a search for criminal 4 5 history record information relating to such applicant, including transmittal of the applicant's fingerprints to the Federal Bureau of 6 Investigation for a national criminal history record information check. 7 The criminal history record information check shall include information 8 9 concerning the applicant from federal repositories of such information and repositories of such information in other states, if authorized by 10 federal law. The Nebraska State Patrol shall issue a report to the 11 employing public agency that shall include the criminal history record 12 13 information concerning the applicant. The cost of any background check shall be borne by the employer of the person or agent. 14

(4) Any person convicted of any disqualifying offense as provided in 15 6 C.F.R. part 37, as such part existed on January 1, 2015 2014, shall not 16 17 be involved in the recording of verified application information or verified operator's license and state identification card information, 18 involved in the manufacture or production of licenses or cards, or 19 involved in any capacity in which such person would have the ability to 20 affect information on such licenses or cards. Any employee or prospective 21 employee of the department shall be provided notice that he or she will 22 undergo such criminal history record information check prior to 23 24 employment or prior to any involvement with the issuance of operators' 25 licenses or state identification cards.

60-4,147.02 No endorsement authorizing the driver to operate a commercial motor vehicle transporting hazardous materials shall be issued, renewed, or transferred by the Department of Motor Vehicles unless the endorsement is issued, renewed, or transferred in conformance

9 75-363 (1) The parts, subparts, and sections of Title 49 of the Code 10 of Federal Regulations listed below, as modified in this section, or any 11 other parts, subparts, and sections referred to by such parts, subparts, 12 and sections, in existence and effective as of January 1, <u>2015</u> 2014, are 13 adopted as Nebraska law.

14 (2) Except as otherwise provided in this section, the regulations15 shall be applicable to:

16 (a) All motor carriers, drivers, and vehicles to which the federal17 regulations apply; and

(5) The regulations adopted in subsection (3) of this section shall not apply to farm trucks registered pursuant to section 60-3,146 with a gross weight of sixteen tons or less. The following parts and sections of 49 C.F.R. chapter III shall not apply to drivers of farm trucks registered pursuant to section 60-3,146 and operated solely in intrastate

5 (6) The following parts and subparts of 49 C.F.R. chapter III shall

8 (b) Part 391, subpart E - Physical Qualifications and Examinations;

9 (c) Part 395 - HOURS OF SERVICE OF DRIVERS; and

10 (d) Part 396 - INSPECTION, REPAIR, AND MAINTENANCE.

11 (7) Part 393 - PARTS AND ACCESSORIES NECESSARY FOR SAFE OPERATION 12 and Part 396 - INSPECTION, REPAIR, AND MAINTENANCE shall not apply to 13 fertilizer and agricultural chemical application and distribution 14 equipment transported in units with a capacity of three thousand five 15 hundred gallons or less.

16 (8) For purposes of this section, intrastate motor carriers shall
17 not include any motor carrier or driver excepted from 49 C.F.R. chapter
18 III by section 390.3(f) of part 390.

(9)(a) Part 395 - HOURS OF SERVICE OF DRIVERS shall apply to motor
carriers and drivers who engage in intrastate commerce as defined in
section 75-362, except that no motor carrier who engages in intrastate
commerce shall permit or require any driver used by it to drive nor shall
any driver drive:

24 (i) More than twelve hours following eight consecutive hours off25 duty; or

(ii) For any period after having been on duty sixteen hours
following eight consecutive hours off duty.

(b) No motor carrier who engages in intrastate commerce shall permit or require a driver of a commercial motor vehicle, regardless of the number of motor carriers using the driver's services, to drive, nor shall any driver of a commercial motor vehicle drive, for any period after:

(i) Having been on duty seventy hours in any seven consecutive days
 if the employing motor carrier does not operate every day of the week; or
 (ii) Having been on duty eighty hours in any period of eight
 consecutive days if the employing motor carrier operates motor vehicles
 every day of the week.

6 (10) Part 395 - HOURS OF SERVICE OF DRIVERS, as adopted in 7 subsections (3) and (9) of this section, shall not apply to drivers 8 transporting agricultural commodities or farm supplies for agricultural 9 purposes during planting and harvesting season when:

(a) The transportation of such agricultural commodities is from the
source of the commodities to a location within a one-hundred-fifty-airmile radius of the source of the commodities;

(b) The transportation of such farm supplies is from a wholesale or retail distribution point of the farm supplies to a farm or other location where the farm supplies are intended to be used which is within a one-hundred-fifty-air-mile radius of the wholesale or retail distribution point; or

(c) The transportation of such farm supplies is from a wholesale
distribution point of the farm supplies to a retail distribution point of
the farm supplies which is within a one-hundred-fifty-air-mile radius of
the wholesale distribution point.

(11) 49 C.F.R. 390.21 - MARKING OF SELF-PROPELLED CMVS AND
INTERMODAL EQUIPMENT shall not apply to farm trucks and farm trucktractors registered pursuant to section 60-3,146 and operated solely in
intrastate commerce.

(12) 49 C.F.R. 392.9a - Operating Authority shall not apply to
 Nebraska motor carriers operating commercial motor vehicles solely in
 intrastate commerce.

(13) No motor carrier shall permit or require a driver of a
commercial motor vehicle to violate, and no driver of a commercial motor
vehicle shall violate, any out-of-service order.

75-366 For the purpose of enforcing Chapter 75, article 3, any officer of the Nebraska State Patrol may, upon demand, inspect the accounts, records, and equipment of any motor carrier or shipper. Any officer of the Nebraska State Patrol shall have the authority to enforce

1 the federal motor carrier safety regulations, as such regulations existed 2 on January 1, 2015 2014, and federal hazardous materials regulations, as such regulations existed on January 1, 2015 2014, and is authorized to 3 4 enter upon, inspect, and examine any and all lands, buildings, and 5 equipment of any motor carrier, any shipper, and any other person subject to the federal Interstate Commerce Act, the federal Department of 6 7 Transportation Act, and other related federal laws and to inspect and copy any and all accounts, books, records, memoranda, correspondence, and 8 9 other documents of a motor carrier, a shipper, and any other person subject to Chapter 75, article 3, for the purposes of enforcing Chapter 10 75, article 3. To promote uniformity of enforcement, the carrier 11 enforcement division of the Nebraska State Patrol shall cooperate and 12 consult with the Public Service Commission and the Division of Motor 13 Carrier Services. 14

17 75-393 The director may participate in the unified carrier 18 registration plan and agreement pursuant to the Unified Carrier Registration Act of 2005, 49 U.S.C. 13908, as the act existed on January 19 1, 2015 2014, and may file on behalf of this state the plan required by 20 such plan and agreement for enforcement of the act in this state. 21
