SUMMARY—Revises provisions relating to crimes. (BDR 3-403)

AN ACT relating to crimes; authorizing victims of human trafficking to bring a civil action; amending various provisions concerning the investigation and prosecution of sex trafficking, involuntary servitude and trafficking in persons; amending various provisions concerning the crimes of pandering, sex trafficking, involuntary servitude and trafficking in persons; revising various provisions governing the penalties for pandering, sex trafficking, involuntary servitude and trafficking in persons; requiring a person convicted of sex trafficking to register as a sex offender; amending various provisions relating to victims of sex trafficking; revising provisions relating to the powers and duties of the Advocate for Missing or Exploited Children; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law establishes the crime of pandering and provides that a person who
- 2 is found guilty of pandering is guilty of a category B, C or D felony, depending on
- 3 the circumstances surrounding the crime. (NRS 201.300-201.340) Existing law also
- 4 creates the crimes of involuntary servitude and trafficking in persons. (NRS
- 5 200.463-200.468)
- 6 **Sections 1, 30-33, 40.7-44, 46-48 and 55** of this bill amend various provisions
- 7 relating to the crimes of pandering, involuntary servitude and trafficking in persons.
- 8 **Section 30** increases the penalty for conspiracy to commit sex trafficking,
- 9 involuntary servitude or trafficking in persons, and **section 46** adds involuntary
- 10 servitude and trafficking in persons to the list of crimes constituting racketeering
- 11 activity. **Sections 41-44** create the crime of sex trafficking, set forth the actions



12 constituting the crimes of pandering and sex trafficking, and provide the terms of
13 imprisonment and fines that must be imposed against a person convicted of
14 pandering or sex trafficking. **Section 42** further provides that a court may not grant
15 probation to, or suspend the sentence of, a person convicted of sex trafficking and
16 that certain defenses are not available in a prosecution for pandering or sex
17 trafficking. **Sections 32, 33 and 40** require a court to order a person convicted of
18 sex trafficking, involuntary servitude or trafficking in persons to pay restitution to
19 the victim of the crime. **Section 47** authorizes victims of sex trafficking to obtain
20 compensation from the Fund for Compensation of Victims of Crime. **Section 48**
21 prohibits the consideration of certain contributory conduct of a victim when
22 considering compensation for a victim of sex trafficking. Finally, **section 1**
23 authorizes a victim of sex trafficking, involuntary servitude or trafficking in
24 persons to bring a civil action against any person who caused, was responsible for
25 or profited from the sex trafficking, involuntary servitude or trafficking in persons.

26 **Sections 4-6, 25, 34-39 and 49-51** of this bill revise provisions governing the
27 investigation and prosecution of sex trafficking. **Section 25** authorizes law
28 enforcement agencies to intercept wire and oral communications during an
29 investigation of sex trafficking, involuntary servitude and trafficking in persons
30 upon compliance with existing law governing the interception of wire and oral
31 communications by law enforcement agencies. **Sections 4-6** provide that the
32 provisions governing the statute of limitations for sex trafficking are the same as
33 the provisions governing the statute of limitations for sexual assault. Finally,
34 **sections 34-39 and 49-51** provide that certain information relating to a victim of
35 sex trafficking must be kept confidential.

36 Existing law provides for the taking and the use at trial of videotaped
37 depositions of certain victims in certain circumstances. (NRS 174.227, 174.228)
38 **Sections 10.3 and 10.7** of this bill authorize the taking and use at trial of
39 videotaped depositions of victims of sex trafficking in certain circumstances.

40 Existing law provides that a person convicted of pandering a child is required to
41 register as an offender convicted of a crime against a child and is a Tier II offender
42 for the purposes of offender registration and community notification. (NRS
43 179D.0357, 179D.115) **Section 27** of this bill provides that a person convicted of
44 sex trafficking an adult is required to register as a sex offender and is a Tier I
45 offender for the purposes of sex offender registration and community notification.

46 **Section 40.3** of this bill gives the Attorney General and the district attorneys of
47 the counties in this State concurrent jurisdiction to prosecute crimes involving
48 pandering, sex trafficking and living from the earnings of a prostitute.

49 Existing law creates the Office of Advocate for Missing or Exploited Children
50 within the Office of the Attorney General and establishes the powers and duties of
51 the Children's Advocate. (NRS 432.157) **Section 53** of this bill authorizes the
52 Children's Advocate to investigate and prosecute certain crimes. **Section 53** also
53 creates the Special Account for the Support of the Office of Advocate for Missing
54 or Exploited Children and authorizes the Children's Advocate to apply for and
55 accept gifts, grants and donations to assist the Children's Advocate in carrying out
56 his or her duties.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 41 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 1. *Any person who is a victim of human trafficking may bring*
4 *a civil action against any person who caused, was responsible for*
5 *or profited from the human trafficking.*

6 2. *A civil action brought under this section may be instituted*
7 *in the district court of this State in the county in which the*
8 *prospective defendant resides or has committed any act which*
9 *subjects him or her to liability under this section.*

10 3. *In an action brought under this section, the court may*
11 *award such injunctive relief as the court deems appropriate.*

12 4. *A plaintiff who prevails in an action brought under this*
13 *section may recover actual damages, compensatory damages,*
14 *punitive damages or any other appropriate relief. If a plaintiff*
15 *recovers actual damages in an action brought under this section*
16 *and the acts of the defendant were willful and malicious, the court*
17 *may award treble damages to the plaintiff. If the plaintiff prevails*
18 *in an action brought under this section, the court may award*
19 *attorney's fees and costs to the plaintiff.*

20 5. *The statute of limitations for an action brought under this*
21 *section does not commence until:*

22 (a) *The plaintiff discovers or reasonably should have*
23 *discovered that he or she is a victim of human trafficking and that*
24 *the defendant caused, was responsible for or profited from the*
25 *human trafficking;*

26 (b) *The plaintiff reaches 18 years of age; or*

27 (c) *If the injury to the plaintiff results from two or more acts*
28 *relating to the human trafficking, the final act in the series of acts*
29 *has occurred,*

30 ↪ *whichever is later.*

31 6. *The statute of limitations for an action brought under this*
32 *section is tolled for any period during which the plaintiff was*
33 *under a disability. For the purposes of this subsection, a plaintiff*
34 *is under a disability if the plaintiff is insane, a person with an*
35 *intellectual disability, mentally incompetent or in a medically*
36 *comatose or vegetative state.*

37 7. *A defendant in an action brought under this section is*
38 *estopped from asserting that the action was not brought within the*
39 *statute of limitations if the defendant, or any person acting on*
40 *behalf of the defendant, has induced the plaintiff to delay bringing*
41 *an action under this section by subjecting the plaintiff to duress,*
42 *threats, intimidation, manipulation or fraud or any other conduct*



1 *inducing the plaintiff to delay bringing an action under this*
2 *section.*

3 *8. In the discretion of the court in an action brought under*
4 *this section:*

5 *(a) Two or more persons may join as plaintiffs in one action if*
6 *the claims of those plaintiffs involve at least one defendant in*
7 *common.*

8 *(b) Two or more persons may be joined in one action as*
9 *defendants if those persons may be liable to at least one plaintiff in*
10 *common.*

11 *9. The consent of a victim is not a defense to a cause of*
12 *action brought under this section.*

13 *10. For the purposes of this section:*

14 *(a) A victim of human trafficking is a person against whom a*
15 *violation of any provision of NRS 200.463 to 200.468, inclusive,*
16 *201.300 or 201.320, or 18 U.S.C. § 1589, 1590 or 1591 has been*
17 *committed.*

18 *(b) It is not necessary that the defendant be investigated,*
19 *arrested, prosecuted or convicted for a violation of any provision*
20 *of NRS 200.463 to 200.468, inclusive, 201.300 or 201.320, or 18*
21 *U.S.C. § 1589, 1590 or 1591 to be found liable in an action*
22 *brought under this section.*

25 **Sec. 4.** NRS 171.083 is hereby amended to read as follows:

26 171.083 1. If, at any time during the period of limitation
27 prescribed in NRS 171.085 and 171.095, a victim of a sexual assault
28 , ~~for~~ a person authorized to act on behalf of a victim of a sexual
29 assault , *or a victim of sex trafficking or a person authorized to act*
30 *on behalf of a victim of sex trafficking*, files with a law
31 enforcement officer a written report concerning the sexual assault ~~for~~
32 *or sex trafficking*, the period of limitation prescribed in NRS
33 171.085 and 171.095 is removed and there is no limitation of the
34 time within which a prosecution for the sexual assault *or sex*
35 *trafficking* must be commenced.

36 2. If a written report is filed with a law enforcement officer
37 pursuant to subsection 1, the law enforcement officer shall provide a
38 copy of the written report to the victim or the person authorized to
39 act on behalf of the victim.

40 3. If a victim of a sexual assault *or sex trafficking* is under a
41 disability during any part of the period of limitation prescribed in
42 NRS 171.085 and 171.095 and a written report concerning the
43 sexual assault *or sex trafficking* is not otherwise filed pursuant to
44 subsection 1, the period during which the victim is under the



1 disability must be excluded from any calculation of the period of
2 limitation prescribed in NRS 171.085 and 171.095.

3 4. For the purposes of this section, a victim of a sexual assault
4 *or sex trafficking* is under a disability if the victim is insane,
5 ~~mentally retarded,~~ *intellectually disabled*, mentally incompetent or
6 in a medically comatose or vegetative state.

7 5. As used in this section, "law enforcement officer" means:

8 (a) A prosecuting attorney;

9 (b) A sheriff of a county or the sheriff's deputy;

10 (c) An officer of a metropolitan police department or a police
11 department of an incorporated city; or

12 (d) Any other person upon whom some or all of the powers of a
13 peace officer are conferred pursuant to NRS 289.150 to 289.360,
14 inclusive.

15 **Sec. 5.** NRS 171.085 is hereby amended to read as follows:

16 171.085 Except as otherwise provided in NRS 171.080,
17 171.083, 171.084 and 171.095, an indictment for:

18 1. Theft, robbery, burglary, forgery, arson, sexual assault, *sex*
19 *trafficking*, a violation of NRS 90.570, a violation punishable
20 pursuant to paragraph (c) of subsection 3 of NRS 598.0999 or a
21 violation of NRS 205.377 must be found, or an information or
22 complaint filed, within 4 years after the commission of the offense.

23 2. Any felony other than the felonies listed in subsection 1
24 must be found, or an information or complaint filed, within 3 years
25 after the commission of the offense.

26 **Sec. 6.** NRS 171.095 is hereby amended to read as follows:

27 171.095 1. Except as otherwise provided in subsection 2 and
28 NRS 171.083 and 171.084:

29 (a) If a felony, gross misdemeanor or misdemeanor is committed
30 in a secret manner, an indictment for the offense must be found, or
31 an information or complaint filed, within the periods of limitation
32 prescribed in NRS 171.085, 171.090 and 624.800 after the discovery
33 of the offense, unless a longer period is allowed by paragraph (b) or
34 (c) or the provisions of NRS 202.885.

35 (b) An indictment must be found, or an information or
36 complaint filed, for any offense constituting sexual abuse of a child
37 ~~as~~ as defined in NRS 432B.100 ~~as~~ *or sex trafficking of a child as*
38 *defined in NRS 201.300*, before the victim ~~of the sexual abuse~~ is:

39 (1) Twenty-one years old if the victim discovers or
40 reasonably should have discovered that he or she was a victim of the
41 sexual abuse *or sex trafficking* by the date on which the victim
42 reaches that age; or

43 (2) Twenty-eight years old if the victim does not discover
44 and reasonably should not have discovered that he or she was a



1 victim of the sexual abuse *or sex trafficking* by the date on which
2 the victim reaches 21 years of age.

3 (c) If a felony is committed pursuant to NRS 205.461 to
4 205.4657, inclusive, against a victim who is less than 18 years of
5 age at the time of the commission of the offense, an indictment for
6 the offense must be found, or an information or complaint filed,
7 within 4 years after the victim discovers or reasonably should have
8 discovered the offense.

9 2. If any indictment found, or an information or complaint
10 filed, within the time prescribed in subsection 1 is defective so that
11 no judgment can be given thereon, another prosecution may be
12 instituted for the same offense within 6 months after the first is
13 abandoned.

22 (a) A victim of sexual abuse as that term is defined in NRS
23 432B.100; ~~to~~

24 (b) A prospective witness in any criminal prosecution if the
25 witness is less than 14 years of age ~~to~~; *or*

26 *(c) A victim of sex trafficking as that term is defined in*
27 *subsection 2 of NRS 201.300. There is a rebuttable presumption*
28 *that good cause exists where the district attorney seeks to take the*
29 *deposition of a person alleged to be the victim of sex trafficking.*

30 ➤ The court may specify the time and place for taking the
31 deposition and the persons who may be present when it is taken.

32 2. The district attorney shall give every other party reasonable
33 written notice of the time and place for taking the deposition. The
34 notice must include the name of the person to be examined. On the
35 motion of a party upon whom the notice is served, the court:

36 (a) For good cause shown may release the address of the person
37 to be examined; and

38 (b) For cause shown may extend or shorten the time.

39 3. If at the time such a deposition is taken, the district attorney
40 anticipates using the deposition at trial, the court shall so state in the
41 order for the deposition and the accused must be given the
42 opportunity to cross-examine the deponent in the same manner as
43 permitted at trial.

44 4. Except as limited by NRS 174.228, the court may allow the
45 videotaped deposition to be used at any proceeding in addition to or



1 in lieu of the direct testimony of the deponent. It may also be used
2 by any party to contradict or impeach the testimony of the deponent
3 as a witness. If only a part of the deposition is offered in evidence
4 by a party, an adverse party may require the party to offer all of it
5 which is relevant to the part offered and any party may offer other
6 parts.

7 **Sec. 10.7.** NRS 174.228 is hereby amended to read as follows:

8 174.228 A court may allow a videotaped deposition to be used
9 instead of the deponent's testimony at trial only if:

10 1. In the case of a victim of sexual abuse, as that term is
11 defined in NRS 432B.100:

12 (a) Before the deposition is taken, a hearing is held by a justice
13 of the peace or district judge who finds that:

14 (1) The use of the videotaped deposition in lieu of testimony
15 at trial is necessary to protect the welfare of the victim; and

16 (2) The presence of the accused at trial would inflict trauma,
17 more than minimal in degree, upon the victim; and

18 (b) At the time a party seeks to use the deposition, the court
19 determines that the conditions set forth in subparagraphs (1) and (2)
20 of paragraph (a) continue to exist. The court may hold a hearing
21 before the use of the deposition to make its determination.

22 2. *In the case of a victim of sex trafficking as that term is*
23 *defined in subsection 2 of NRS 201.300:*

24 (a) *Before the deposition is taken, a hearing is held by a justice*
25 *of the peace or district judge and the justice or judge finds that*
26 *cause exists pursuant to paragraph (c) of subsection 1 of NRS*
27 *174.227; and*

28 (b) *Before allowing the videotaped deposition to be used at*
29 *trial, the court finds that the victim is unavailable as a witness.*

30 3. In all cases:

31 (a) A justice of the peace or district judge presides over the
32 taking of the deposition;

33 (b) The accused is able to hear and see the proceedings;

34 (c) The accused is represented by counsel who, if physically
35 separated from the accused, is able to communicate orally with the
36 accused by electronic means;

37 (d) The accused is given an adequate opportunity to cross-
38 examine the deponent subject to the protection of the deponent
39 deemed necessary by the court; and

40 (e) The deponent testifies under oath.

27 person is or has been required by the laws of that jurisdiction to
28 register as an offender who has committed a crime against a child
29 because of the offense. This subsection includes, without limitation,
30 an offense prosecuted in:

31 (a) A tribal court.

32 (b) A court of the United States or the Armed Forces of the
33 United States.

34 (c) A court having jurisdiction over juveniles.

35 **Sec. 27.** NRS 179D.097 is hereby amended to read as follows:

36 179D.097 1. "Sexual offense" means any of the following
37 offenses:

38 (a) Murder of the first degree committed in the perpetration or
39 attempted perpetration of sexual assault or of sexual abuse or sexual
40 molestation of a child less than 14 years of age pursuant to
41 paragraph (b) of subsection 1 of NRS 200.030.

42 (b) Sexual assault pursuant to NRS 200.366.

43 (c) Statutory sexual seduction pursuant to NRS 200.368.

44 (d) Battery with intent to commit sexual assault pursuant to
45 subsection 4 of NRS 200.400.



1 (e) An offense involving the administration of a drug to another
2 person with the intent to enable or assist the commission of a felony
3 pursuant to NRS 200.405, if the felony is an offense listed in this
4 section.

5 (f) An offense involving the administration of a controlled
6 substance to another person with the intent to enable or assist the

TEXT OF REPEALED SECTIONS

201.310 Pandering: Placing spouse in brothel; penalties.

1. A person who by force, fraud, intimidation or threats, places, or procures any other person to place, his or her spouse in a house of prostitution or compels his or her spouse to lead a life of prostitution is guilty of pandering and shall be punished:

(a) Where physical force or the immediate threat of physical force is used upon the spouse, for a category C felony as provided in NRS 193.130.

(b) Where no physical force or immediate threat of physical force is used, for a category D felony as provided in NRS 193.130.

2. Upon the trial of any offense mentioned in this section, either spouse is a competent witness for or against the other spouse, with or without the other's consent, and may be compelled so to testify.

201.330 Pandering: Detaining person in brothel because of debt; penalties.

1. A person who attempts to detain another person in a disorderly house or house of prostitution because of any debt or debts the other person has contracted or is said to have contracted while living in the house is guilty of pandering.

2. A person who is found guilty of pandering:

(a) An adult:



(1) If physical force or the immediate threat of physical force is used upon the adult, is guilty of a category C felony and shall be punished as provided in NRS 193.130.

(2) If no physical force or immediate threat of physical force is used upon the adult, is guilty of a category D felony and shall be punished as provided in NRS 193.130.

(b) A child:

(1) If physical force or the immediate threat of physical force is used upon the child, is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 2 years and a maximum term of not more than 20 years and may be further punished by a fine of not more than \$20,000.

(2) If no physical force or immediate threat of physical force is used upon the child, is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 1 year and a maximum term of not more than 10 years and may be further punished by a fine of not more than \$10,000.

201.340 Pandering; Furnishing transportation; penalties.

1. A person who knowingly transports or causes to be transported, by any means of conveyance, into, through or across this state, or who aids or assists in obtaining such transportation for a person with the intent to induce, persuade, encourage, inveigle, entice or compel that person to become a prostitute or to continue to engage in prostitution is guilty of pandering.

2. A person who is found guilty of pandering:

(a) An adult:

(1) If physical force or the immediate threat of physical force is used upon the adult, is guilty of a category C felony and shall be punished as provided in NRS 193.130.

(2) If no physical force or immediate threat of physical force is used upon the adult, is guilty of a category D felony and shall be punished as provided in NRS 193.130.

(b) A child:

(1) If physical force or the immediate threat of physical force is used upon the child, is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 2 years and a maximum term of not more than 20 years and may be further punished by a fine of not more than \$20,000.

(2) If no physical force or immediate threat of physical force is used upon the child, is guilty of a category B felony and shall be punished by imprisonment in the state prison for a minimum term of not less than 1 year and a maximum term of not more than 10 years and may be further punished by a fine of not more than \$10,000.



3. A person who violates subsection 1 may be prosecuted, indicted, tried and convicted in any county or city in or through which he or she transports or attempts to transport the person.
