3 STATE.

4 The General Assembly of North Carolina enacts:

5  
6 **IMPLEMENT A STATE HEMP PROGRAM IN ACCORDANCE WITH SECTION**  
7 **10113 OF THE FEDERAL AGRICULTURE IMPROVEMENT ACT OF 2018, TO BE**  
8 **ADMINISTERED BY THE NORTH CAROLINA HEMP COMMISSION UNTIL JULY**  
9 **1, 2021**

10 **SECTION 1.(a)** Article 50E of Chapter 106 of the General Statutes reads as  
11 rewritten:

12 "Article 50E.

13 "~~Industrial Hemp-North Carolina Hemp Commission.~~

14 "**§ 106-568.50. Legislative findings and purpose.**

15 ~~The General Assembly finds and declares that it is in the best interest of the citizens of North~~  
16 ~~Carolina to promote and encourage the development of an industrial hemp industry in the State~~  
17 ~~in order to expand employment, promote economic activity, and provide opportunities to small~~  
18 ~~farmers for an environmentally sustainable and profitable use of crop lands that might otherwise~~  
19 ~~be lost to agricultural production. The purposes of this Article are to establish an agricultural~~  
20 ~~pilot program for the cultivation of industrial hemp in the State, to provide for reporting on the~~  
21 ~~program by growers and processors for agricultural or other research, and to pursue any federal~~  
22 ~~permits or waivers necessary to allow industrial hemp to be grown in the State.~~

23 The General Assembly finds and declares that hemp is a viable agriculture commodity in this  
24 State and that it is in the best interest of the citizens of North Carolina to:

- 25 (1) Promote the cultivation and processing of hemp, and open new commercial  
26 markets for farmers and businesses through the sale of hemp products.  
27 (2) Promote the expansion of the State's hemp industry to the maximum extent  
28 permitted by law, allowing farmers and businesses to cultivate, handle, and  
29 process hemp and sell hemp products for commercial purposes.  
30 (3) Encourage and empower research into hemp growth and hemp products at  
31 State institutions of higher education and in the private sector.  
32 (4) Move the State and its citizens to the forefront of the hemp industry.

33 "**§ 106-568.51. Definitions.**

34 The following definitions apply in this Article:

- 1           (1a)   Cannabidiol or CBD. – The nonpsychoactive cannabinoid compound derived  
2           from the hemp variety of the plant *Cannabis sativa* (L.) that is essentially free  
3           of plant material and does not exceed the federally defined THC level for  
4           hemp.
- 5           (1b)   Cannabinoid. – Means any of the terpenophenolic compounds found within  
6           the plant *Cannabis sativa* (L.) that are functionally or structurally similar,  
7           biologically active, and are classified in subgroups such as Cannabigerols  
8           (CBG), Cannabichromenes (CBC), Cannabidiols (CBD),  
9           tetrahydrocannabinols (THC), Cannabinol (CBN), Cannabicyclol (CBDL),  
10           and all other chemical cannabinoid constituents derived from hemp.
- 11          (1c)   Commercial sale. – The sale of products in the stream of commerce, at retail,  
12           wholesale, and online.
- 13          (2)    ~~Commercial use. – The use of industrial hemp as a raw ingredient in the~~  
14           ~~production of hemp products.~~
- 15          (3)    ~~Commission. – The North Carolina Industrial-Hemp Commission created by~~  
16           ~~this Article.~~
- 17          (3a)   Cultivating. – Planting, watering, growing, or harvesting a plant or crop.  
18           "Cultivating" also includes possessing or storing hemp plants for any period  
19           of time on the premises where the hemp was cultivated and transporting hemp  
20           to the first point of sale by the cultivator.
- 21          (4)    ~~Department. – The North Carolina Department of Agriculture, Agriculture and~~  
22           ~~Consumer Services.~~
- 23          (4a)   Federally defined THC level for hemp. – A delta-9 THC concentration of not  
24           more than three-tenths percent (0.3%) on a dry weight basis.
- 25          (5)    ~~Grower. – Any person licensed to grow industrial hemp by the Commission~~  
26           ~~pursuant to this Article.~~
- 27          (5a)   Handling. – Possessing or storing hemp plants for any period of time on  
28           premises owned, operated, or controlled by a person licensed to handle hemp.  
29           "Handling" also includes possessing or storing hemp plants in a vehicle for  
30           any period of time other than during its actual transport from the premises of  
31           a person licensed to cultivate, handle, or process hemp to the premises of  
32           another licensed person. "Handling" does not include possessing or storing  
33           finished hemp products.
- 34          (5b)   Hemp. – The plant *Cannabis sativa* (L.) and any part of that plant, including  
35           the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids,  
36           salts, and salts of isomers, whether growing or not, within the federally  
37           defined THC level for hemp.
- 38          (5c)   Hemp extract. – An extract from hemp, or a mixture or preparation containing  
39           hemp plant material or compounds, within the federally defined THC level for  
40           hemp.
- 41          (6)    ~~Hemp products. – All products made from industrial hemp, including, but not~~  
42           ~~limited to, cloth, cordage, fiber, food, fuel, paint, paper, particleboard,~~  
43           ~~plastics, seed, seed meal and seed oil for consumption, and verified propagules~~  
44           ~~for cultivation if the seeds originate from industrial hemp varieties product. –~~  
45           ~~Any product within the federally defined THC level for hemp derived from,~~  
46           ~~or made by, processing hemp plants or plant parts, that are prepared in a form~~  
47           ~~available for commercial sale, including, but not limited to, cosmetics,~~  
48           ~~personal care products, food intended for animal or human consumption as~~  
49           ~~approved by the United States Food and Drug Administration or the United~~

34 **"§ 106-568.52. North Carolina Industrial Hemp Commission.**

35            (a) Creation and Membership. – The North Carolina ~~Industrial~~ Hemp Commission is  
 36 established and shall consist of nine members as follows:

- 37            (1) The Commissioner of Agriculture or the Commissioner's designee, who shall  
 38 serve as vice-chair.  
 39            (2) One appointed by the General Assembly upon recommendation of the  
 40 President Pro Tempore of the Senate in accordance with G.S. 120-121, who  
 41 shall at the time of appointment be a municipal chief of police.  
 42            (3) One appointed by the General Assembly upon recommendation of the Speaker  
 43 of the House of Representatives in accordance with G.S. 120-121, who shall  
 44 at the time of appointment be an elected sheriff or the sheriff's designee.  
 45            (4) Two appointed by the Governor who shall at the time of appointment be a  
 46 full-time or Emeritus faculty member of a State land grant university who  
 47 regularly works in the field of agricultural science or research.  
 48            (5) Two appointed by the Commissioner of Agriculture, who shall be a full-time  
 49 farmer with at least 10 years of experience in agricultural production in the  
 50 State.

- 1 (6) One appointed by the Commissioner of Agriculture, who shall be a  
2 professional agricultural consultant.
- 3 (7) One appointed by the Commissioner of Agriculture, who shall be an  
4 agribusiness professional.

5 (b) Terms of Members. – Members of the Commission shall serve terms of four years,  
6 beginning effective July 1 of the year of appointment, and may be reappointed to a second  
7 four-year term. The terms of members designated by subdivisions (a)(1), (a)(2), (a)(4), and (a)(6)  
8 of this section shall expire on June 30 of any year evenly divisible by four. The terms of the  
9 remaining members shall expire on June 30 of any year that follows by two years a year evenly  
10 divisible by four. However, the terms of all members of the Commission shall expire July 1,  
11 2021.

12 (c) Chair. – The members of the Commission shall elect a chair. The chair shall serve a  
13 two-year term and may be reelected.

14 (d) Vacancies. – Any appointment to fill a vacancy on the Commission created by the  
15 resignation, dismissal, death, or disability of a member shall be made by the original appointing  
16 authority and shall be for the balance of the unexpired term.

17 (e) Removal. – The appointing authority shall have the power to remove any member of  
18 the Commission appointed by that authority from office for misfeasance, malfeasance, or  
19 nonfeasance.

20 (f) Reimbursement. – The members of the Commission shall receive per diem and  
21 necessary travel and subsistence expenses in accordance with the provisions of G.S. 138-5.

22 (g) Quorum. – Five members of the Commission shall constitute a quorum for the  
23 transaction of business.

24 (h) Staff. – The Commission is authorized and empowered to employ no more than two  
25 persons as staff to assist the Commission in the proper discharge of its duties and responsibilities.  
26 The chair of the Commission shall organize and direct the work of the Commission staff. The  
27 salaries and compensation of all such personnel shall be determined by the Commission;  
28 provided, however, that the aggregate cost for salaries and benefits of the staff may not exceed  
29 two hundred thousand dollars (\$200,000).

30 **"§ 106-568.53. Powers and duties of the Commission.**

31 The Commission shall have the following powers and duties:

- 32 (1) ~~To establish an industrial hemp research program~~ the North Carolina Hemp  
33 Program to grow or cultivate industrial hemp in the State, to be directly  
34 managed and coordinated by State land grant universities. The Commission  
35 shall pursue any permits or waivers from the United States Drug Enforcement  
36 Agency or any other federal agency that are necessary for the establishment  
37 of the industrial hemp research program established by this Article. This  
38 research program shall consist primarily of demonstration plots planted and  
39 cultivated in North Carolina by selected growers. The growers shall be  
40 licensed pursuant to subdivision (2) of this section prior to planting any  
41 industrial hemp. ~~State.~~
- 42 (2) To issue licenses allowing a person, firm, or corporation to cultivate ~~industrial~~  
43 or handle hemp for research purposes to the extent allowed by federal law,  
44 upon proper application as the Commission may specify, and in accordance  
45 with G.S. 106-568.53A. ~~Each licensee shall provide a complete and accurate~~  
46 legal description of the location of the industrial hemp farming operation,  
47 including GPS coordinates, and the license shall be issued for cultivation only  
48 in those locations identified in the application and shall include on its face the  
49 description of those areas. ~~The Commission may delegate approval of license~~  
50 applications to Commission staff, but the Commission shall hear any appeals

1 of denial of a license. The Department shall provide administrative support to  
2 the Commission for the processing of applications and issuance of licenses.

3 ~~(3) To support the Commission's activities, and to reimburse the Department for~~  
4 ~~expenses associated with the issuance of cultivation licenses under~~  
5 ~~subdivision (2) of this section, the Commission may charge the following fees:~~

6 a. ~~An initial, graduated license fee, to be paid by each cultivator, based~~  
7 ~~upon the number of acres proposed for cultivation of industrial hemp,~~  
8 ~~not to exceed ten thousand dollars (\$10,000), with incentive provisions~~  
9 ~~to encourage the participation of small acreage farmers.~~

10 b. ~~An annual fee that is the sum of two hundred fifty dollars (\$250.00)~~  
11 ~~and two dollars (\$2.00) per acre of industrial hemp cultivated.~~

12 ~~In setting fees under this subdivision, the Commission may create fair and~~  
13 ~~reasonable licensing preferences for license applicants from North Carolina~~  
14 ~~counties that have been recognized as economically depressed or~~  
15 ~~disadvantaged. The Department shall collect and manage all fees charged by~~  
16 ~~the Commission and shall remit all funds collected under this subdivision to~~  
17 ~~the Commission at least monthly. The Department may retain its actual~~  
18 ~~expenses associated with the issuance of cultivation licenses from the amount~~  
19 ~~to be remitted to the Commission.~~

20 (4) To receive gifts, grants, federal funds, and any other funds both public and  
21 private needed to support the Commission's duties and programs.

22 ~~(5) To establish procedures for reporting to the Commission by the growers and~~  
23 ~~processors for agricultural or academic research and to collaborate and~~  
24 ~~coordinate research efforts with the appropriate departments or programs of~~  
25 ~~North Carolina State University and North Carolina A & T State University.~~

27 (8) To adopt rules necessary to carry out the purposes of this Article, which shall  
28 include, but are not limited to, rules for all of the following:

29 a. ~~Testing of the industrial hemp during growth to determine~~  
30 ~~tetrahydrocannabinol levels. Testing methods and protocols shall~~  
31 ~~comply in all respects with any and all applicable federal~~  
32 ~~requirements. Prescribe sampling and testing procedures to ensure that~~  
33 ~~hemp cultivated or handled under the authority of this Article does not~~  
34 ~~exceed the federally defined THC level for hemp.~~

35 b. ~~Supervision of the industrial hemp during its growth and harvest,~~  
36 ~~including rules for verification of the type of seeds and plants used and~~  
37 ~~grown by licensees.~~

38 c. ~~The production and sale of industrial hemp, consistent with the rules~~  
39 ~~of the United States Department of Justice and Drug Enforcement~~

1 f. ~~The fees authorized by subdivision (3) of this section. Set and collect a~~  
2 ~~schedule of nonrefundable fees for administering the North Carolina~~

4 ~~The Commission shall adopt by reference or otherwise the federal regulations~~  
5 ~~in effect regarding industrial hemp and any subsequent amendments to those~~  
6 ~~regulations. No North Carolina rule, regulation, or statute shall be construed~~  
7 ~~to authorize any person to violate any federal law or regulation.~~

8 (9) ~~To undertake any additional studies relating to the production, distribution, or~~  
9 ~~use of industrial hemp as requested by the General Assembly, the Governor,~~

11 (10) ~~To notify the State Bureau of Investigation and all local law enforcement~~

15 **"§ 106-568.53A. Responsibilities Qualification of licensees.**

16 ~~A person granted an industrial hemp license pursuant to this section shall:~~

17 (1) ~~Maintain records that demonstrate compliance with this Article and with all~~  
18 ~~other State laws regulating the planting and cultivation of industrial hemp.~~

19 (2) ~~Retain all industrial hemp production records for a minimum of three years.~~

20 (3) ~~Allow industrial hemp crops, throughout sowing, growing, and harvesting, to~~  
21 ~~be inspected by and at the discretion of the Commission, the State Bureau of~~  
22 ~~Investigation, or the chief law enforcement officer of the unit or units of local~~  
23 ~~government where the farm is located.~~

24 (4) ~~Maintain a current written agreement with a State land grant university that~~  
25 ~~states that the grower is a participant in the industrial hemp research program~~  
26 ~~managed by that institution.~~

27 (a) No person shall cultivate or handle hemp in this State unless the person holds a hemp  
28 license issued by the North Carolina Hemp Commission.

29 (b) In order to obtain a license to cultivate hemp pursuant to this Article, a person must  
30 be a qualifying farmer pursuant to G.S. 105-164.13E(a) or a conditional qualifying farmer  
31 pursuant to G.S. 105-164.13E(b). The Commission may also grant a license to cultivate hemp to  
32 a State agency or institution of higher learning, or an employee of a State agency or institution  
33 of higher learning for use in the scope of the employee's duties.

34 (c) An applicant for a license issued by the Commission shall submit to and pay for an  
35 annual criminal background check conducted by the State Bureau of Investigation or another  
36 State or federal law enforcement agency approved by the Commission.

37 (d) A person granted a license to cultivate hemp pursuant to this Article shall provide to  
38 the Commission prior to issuance of the license:

39 (1) The legal description and global positioning coordinates sufficient for locating  
40 the fields or greenhouses to be used to cultivate hemp.

41 (2) Written consent allowing representatives of the Department, the State Bureau  
42 of Investigation, and the chief law enforcement officer of the unit or units of  
43 local government where the farm is located to enter all premises where hemp  
44 is cultivated or stored for the purpose of conducting physical inspections or  
45 ensuring compliance with the requirements of this Article and rules adopted  
46 by the Commission.

47 (e) Any person convicted of a felony relating to a controlled substance under State or  
48 federal law shall be ineligible to obtain any hemp license for the 10-year period following the  
49 date of the conviction.

50 (f) Any person who materially falsifies any information contained in an application for  
51 a hemp license shall be ineligible to obtain a hemp license.

1 (g) A license issued by the North Carolina Industrial Hemp Commission shall be valid  
2 for the term of the license. A person who holds a license issued by the North Carolina Industrial  
3 Hemp Commission who wishes to modify the conditions of the license shall be required to apply  
4 for a new license from the North Carolina Hemp Commission.

5 **"§ 106-568.54. Limitations.**

6 ~~The Commission shall not meet or undertake any of its powers and duties under this Article~~  
7 ~~until it has obtained funding from sources other than State funds of at least two hundred thousand~~  
8 ~~dollars (\$200,000) to support operations of the Commission. Funding from non-State sources for~~  
9 ~~the Commission's activities may be returned to the donor or funder if not spent or encumbered~~  
10 ~~within 12 months, upon request of the donor or funder. Non-State funds donated and carried over~~  
11 ~~at the end of the fiscal year in which they are donated shall be retained and remain eligible for~~  
12 ~~expenditure in the following fiscal year.~~

13 **"§ 106-568.55. Authorized research purposes.**

14 ~~As part of the industrial hemp research program directly managed by a State land grant~~  
15 ~~university, a licensed grower may engage in any of the following research activities:~~

- 16 (1) ~~Studying and investigating marketplace opportunities for hemp products to~~  
17 ~~increase the job base in the State by means of employment related to the~~  
18 ~~production of industrial hemp.~~
- 19 (2) ~~Studying and investigating methods of industrial hemp cultivation that are~~  
20 ~~best suited to soil conservation and restoration.~~
- 21 (3) ~~Overseeing and analyzing the growth of industrial hemp by licensed growers~~  
22 ~~for agronomy research and analysis of required soils, growing conditions, and~~  
23 ~~harvest methods relating to the production of various varieties of industrial~~  
24 ~~hemp that may be suitable for various commercial hemp products.~~
- 25 (4) ~~Conducting seed research on various types of industrial hemp that are best~~  
26 ~~suited to be grown in North Carolina, including seed availability, creation of~~  
27 ~~North Carolina hybrid types, and in the ground variety trials and seed~~  
28 ~~production. The Commission may establish a program to recognize certain~~  
29 ~~industrial hemp seeds as being North Carolina varieties of hemp seed.~~
- 30 (5) ~~Studying the economic feasibility of developing an industrial hemp market in~~  
31 ~~various types of industrial hemp that can be grown in the State, including by~~  
32 ~~commercial marketing and sale of industrial hemp.~~
- 33 (6) ~~Reporting on the estimated value added benefits, including environmental~~  
34 ~~benefits, to North Carolina businesses of an industrial hemp market of North~~  
35 ~~Carolina grown industrial hemp varieties.~~
- 36 (7) ~~Studying the agronomy research being conducted worldwide relating to~~  
37 ~~industrial hemp varieties, production, and use.~~
- 38 (8) ~~Researching and promoting on the world market industrial hemp and hemp~~  
39 ~~seed that can be grown in the State.~~
- 40 (9) ~~Promoting research into the development of industrial hemp and commercial~~  
41 ~~markets for North Carolina industrial hemp and hemp products.~~
- 42 (10) ~~Studying the feasibility of attracting federal or private funding for the North~~  
43 ~~Carolina industrial hemp research program.~~
- 44 (11) ~~Studying the use of industrial hemp in new energy technologies, including~~  
45 ~~electricity generation, biofuels, or other forms of energy resources; the growth~~  
46 ~~of industrial hemp on reclaimed mine sites; the use of hemp seed oil in the~~  
47 ~~production of fuels; and the production costs, environmental issues, and costs~~  
48 ~~and benefits involved with the use of industrial hemp for energy.~~

49 **"§ 106-568.55A. Bonding requirement for hemp handlers.**

50 The Commission shall not issue a license to handle hemp to any person until the person has  
51 furnished the Commissioner of Agriculture a bond satisfactory to the Commissioner in an amount

1 of not less than two hundred fifty thousand dollars (\$250,000). The Commissioner may require  
2 a new bond or may require the amount of any bond to be increased if the Commissioner finds it  
3 necessary for the protection of the cultivator. The bond shall be payable to the State and shall be  
4 conditioned upon the fulfilling of all financial obligations incurred by the handler with all hemp  
5 cultivators with whom the handler contracts. Any cultivator alleging any injury by the fraud,  
6 deceit, willful injury, or failure to comply with the terms of any written contract by a handler  
7 may bring suit on the bond against the principal and the principal's surety in any court of  
8 competent jurisdiction and may recover the damages found to be caused by such acts complained  
9 of.

10 **"§ 106-568.55B. Corrective action plans authorized.**

11 (a) The Commission shall require any person who is required to obtain a hemp license  
12 issued by the Commission to comply with a corrective action plan if the Commission determines  
13 that the person has negligently violated any provision of this Article or any rule adopted by the

37 (d) Any person that knowingly or intentionally manufactures, delivers, sells, or possesses  
38 smokable hemp, except for hemp plants or parts of a hemp plant grown or handled by a licensee  
39 for processing or manufacturing into a legal hemp product, shall be deemed guilty of a Class 1  
40 misdemeanor.

41 **"§ 106-568.68. Hemp products.**

42 (a) Except as provided in G.S. 106-139(g), no license shall be required to possess, handle,  
43 transport, or sell hemp products or hemp extracts.

44 (b) Hemp products may be legally transported to other states and exported to foreign  
45 nations, consistent with the laws of the receiving jurisdiction.

46 **"§ 106-568.69. North Carolina Hemp Program Fund.**

47 (a) The North Carolina Hemp Program Fund is established as a special fund in the  
48 Department of Agriculture and Consumer Services. The fund shall consist of amounts received  
49 from appropriations and any other proceeds from gifts, grants, federal funds, application fees,  
50 license fees, and any other funds, both public and private, made available for purposes of this

1 Article. Any interest received and accruing from the fund shall be paid into the State's General  
2 Fund.

47 methods, the increased production, use and sale, domestic and foreign, of any and all of such  
48 agricultural commodities. The provisions of this Article, however, shall not include the  
49 agricultural products of tobacco, strawberries, strawberry plants, porcine animals, or equines,  
50 with respect to which separate provisions have been made.

1 (b) The "Got to be NC" marketing campaign of the Department of Agriculture and  
2 Consumer Services shall be the official agricultural marketing campaign for the State."

3 **SECTION 13.(b)** Article 50 of Chapter 106 of the General Statutes is amended by

8 (a) The underlying fee owner of land encumbered by any easement acquired by a utility  
9 company, whether acquired by purchase or by condemnation, on which construction has not been  
10 commenced by the utility company for the purpose for which the easement was acquired within  
11 20 years of the date of acquisition, may file a complaint with the Commission for an order  
12 requiring the utility company to terminate the easement in exchange for payment by the  
13 underlying fee owner of the current fair market value of the easement.

14 (b) Upon receipt of the complaint, the Commission shall serve a copy of the complaint  
15 on each utility company named in the complaint, together with an order directing that the utility  
16 company file an answer to the complaint within 90 days after service.

17 (c) If the utility company agrees to terminate the easement, the utility company shall  
18 submit to the Commission, within the time allowed for answer, an original plus four copies of a  
19 statement of the utility company's agreement to terminate the easement.

20 (d) If the utility company does not agree that the easement should be terminated, the  
21 utility company may request a determination from the Commission as to whether the easement  
22 is necessary or advisable for the utility company's long-range needs for the provision of utilities  
23 to serve its service area, and whether termination of the easement would be contrary to the  
24 interests of the using and consuming public. The Commission may conduct a hearing on the  
25 matter, which shall be conducted in accordance with Article 4 of this Chapter. Either party may  
26 appeal the Commission's decision in accordance with Article 5 of this Chapter. The burden of  
27 proof shall be on the utility company to show that the easement is necessary or advisable for the  
28 utility company's long-range needs for the provision of utilities to serve its service area and that  
29 termination of the easement would be contrary to the interests of the using and consuming public.

30 (e) If the underlying fee owner and the utility company cannot reach a mutually agreed  
31 upon fair market value of the easement, whether terminated voluntarily or by order of the  
32 Commission, the Commission shall make a request to the clerk of superior court in the county  
33 where the easement is located for the appointment of commissioners to determine the fair market  
34 value of the easement in accordance with the process set forth in G.S. 40A-48.

35 (f) If the Commission decides that the easement should not be terminated, the underlying  
36 fee owner may not file a complaint with the Commission under this section regarding the same  
37 easement for a period of five years from the date of the decision.

14 ~~the property on which the crop is grown provided: (i) to promote a bona fide~~  
15 ~~farm that is exempt from zoning regulations pursuant to G.S. 153-340(b),~~  
16 ~~provided the sign is no more than two-three feet long on any side; (ii) side and~~  
17 ~~the sign is located on property owned or leased by the grower where the crop~~  
18 ~~is grown; (iii) the grower is also the seller; and (iv) the sign is kept in place by~~

20 leased by the owner or lessee of the bona fide farm.

39           (8) The President of the North Carolina Farm Bureau Federation, Inc., or the

41           (9) The President of the North Carolina State Grange or the President's designee.  
42           (10) The Secretary of Environmental Quality or the Secretary's designee.  
43           (11) The President of the North Carolina Forestry Association, Inc., or the  
44 President's designee.

45           (b) Members shall be appointed for two-year terms beginning October 1 of each  
46 odd-numbered year. The Chairs of the House Agriculture Committee and the Chairs of the Senate  
47 Committee on Agriculture, Environment, and Natural Resources shall serve as cochairs. The  
48 President Pro Tempore of the Senate and the Speaker of the House of Representatives may each  
49 appoint an additional member of the Senate and House, respectively, to serve as cochair. If  
50 appointed, these cochairs shall be voting members of the Commission. A quorum of the  
51 Commission is nine members.

1       (c)     Cochairs' terms on the Commission are for two years and begin on the convening of  
2 the General Assembly in each odd-numbered year. Except as otherwise provided in this  
3 subsection, a cochair of the Commission shall continue to serve for so long as the cochair remains  
4 a member of the General Assembly and no successor has been appointed. A cochair of the  
5 Commission who does not seek reelection or is not reelected to the General Assembly may  
6 complete a term of service on the Commission until the day on which a new General Assembly  
7 convenes. A member of the Commission who resigns or is removed from service in the General  
8 Assembly shall be deemed to have resigned or been removed from service on the Commission."

37       sports, equestrian activities, or natural activities and attractions. An activity is  
38       an agritourism activity whether or not the participant paid to participate in the

40       comply with guidelines for design and site evaluation as established by the

21 (4) "North Carolina Sweetpotato Advisory Council" means the advisory council  
22 established pursuant to G.S. 106-1070.

23 **"§ 106-1067. North Carolina sweetpotato brand.**

24 Only sweetpotatoes that are grown in the State of North Carolina may be identified, classified,  
25 packaged, labeled, or otherwise designated for sale inside or outside the State as North Carolina  
26 sweetpotatoes.

27 **"§ 106-1068. Powers of Commissioner to regulate and promote North Carolina**  
28 **sweetpotatoes.**

29 (a) The Commissioner of Agriculture may take all actions necessary and appropriate to  
30 create, register, license, promote, and protect a trademark for use on or in connection with the  
31 sale or promotion of North Carolina sweetpotatoes and products containing North Carolina  
32 sweetpotatoes. The Commissioner may impose and collect a reasonable royalty or license fee per  
33 hundredweight of sweetpotatoes for the use of such trademark on products containing North  
34 Carolina sweetpotatoes or the packaging containing such sweetpotato products. The  
35 Commissioner shall determine the fee in consultation with representatives of the sweetpotato  
36 industry and the Marketing Division of the Department of Agriculture and Consumer Services.  
37 The Commissioner shall remit all royalties and license fees received from this Article, less any  
38 costs associated with monitoring the use of the trademark, prohibiting the unlawful or  
39 unauthorized use of the trademark, and enforcing rights in the trademark, to the North Carolina  
40 SweetPotato Commission for the promotion of North Carolina sweetpotatoes.

41 (b) The Board of Agriculture may adopt rules that may include, but are not limited to,  
42 quality standards, grades, packing, handling, labeling, and marketing practices for the marketing  
43 of sweetpotatoes in this State, and such other rules as are necessary to administer this Article.  
44 The Board of Agriculture may also adopt rules establishing a registration, inspection, and

The Commissioner shall appoint a North Carolina Sweetpotato Advisory Council, to consist of individuals involved in growing, packing, or growing and packing North Carolina sweetpotatoes; at least one sweetpotato processor; at least one sweetpotato retailer; at least one county cooperative extension agent familiar with the production of North Carolina sweetpotatoes; and any other person or persons selected by the Commissioner, for the purpose of rendering advice upon his or her request regarding the exercise of the Commissioner's authority pursuant to G.S. 106-1068. Members of the North Carolina Sweetpotato Advisory Council shall receive no compensation for their service."

23          purposes of effecting repair.
- 24          (12)   "Trade secret" means anything tangible or intangible or electronically stored  
25          or kept that constitutes, represents, evidences, or records intellectual property,  
26          including secret or confidentially held designs, processes, procedures,  
27          formulas, inventions, or improvements or secrets of confidentially held  
28          scientific, technical, merchandising, production, financial, business, or

31    **"§ 75-151. Right to repair.**

32          (a)    For farm equipment sold or used in this State, the original farm equipment  
33          manufacturer shall make available all of the following:

35               updates and corrections to embedded software, to any independent repair  
36               provider or owner of farm equipment manufactured by the original farm  
37               equipment manufacturer for no charge or in the same manner as the original

- 40               (2)    Farm equipment parts, including any updates to the farm equipment's

 16 ~~serves a swine farm under this Article only if the Commission determines that the animal waste~~
