1 A BILL for an Act to create and enact six new subsections to section 11-11-14, subsection 4 of  
2 section 11-11.1-01, and section 18-10-07.1 of the North Dakota Century Code, relating to  
3 consolidation and revision of provisions governing property tax levy authority; to amend and  
4 reenact section 2-02-07, subsection 9 of section 2-06-01, section 2-06-07, sections 2-06-14,  
5 2-06-15, 4-02-26, 4-02-27.3, and 4-08-15, subsection 17 of section 4-22-26, sections 4-33-11,

9 provisions relating to property tax levy authority of counties, cities, park districts, soil  
10 conservation districts, and various boards and commissions; to provide for a transition; and to  
11 provide an effective date.

12 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

13 **SECTION 1. AMENDMENT.** Section 2-02-07 of the North Dakota Century Code is amended  
14 and reenacted as follows:

15 **2-02-07. Authority to raise money by taxation and use airport income.**

16 The local public authorities having power to appropriate moneys within the political  
17 subdivisions acquiring, establishing, developing, operating, maintaining, or controlling airports  
18 ~~or landing fields~~ under the provisions of this chapter may appropriate and cause to be raised by  
19 taxation under section 2-06-15 or ~~otherwise from revenue derived from general fund levy~~  
20 authority in such political subdivisions, moneys sufficient to carry out therein the provisions of  
21 this chapter, and also may use for such purpose or purposes moneys derived from said airports  
22 ~~or landing fields~~.

23 **SECTION 2. AMENDMENT.** Subsection 9 of section 2-06-01 of the North Dakota Century  
24 Code is amended and reenacted as follows:

25 9. "Municipality" means any county, city, ~~town, park district, or public body~~ township of this  
26 state.

27 **SECTION 3. AMENDMENT.** Section 2-06-07 of the North Dakota Century Code is amended  
28 and reenacted as follows:

1           **2-06-07. General powers of an authority.**

2           An authority has all the powers necessary or convenient to carry out the purposes of this  
3 chapter including the power to certify, annually to the governing bodies creating it, the amount of  
4 the proposed tax to be levied by said governing bodies for airport purposes within the limitations  
5 in section 2-06-15, including the power:

- 6           1. To sue and be sued, to have a seal, and to have perpetual succession.
- 7           2. To execute such contracts and other instruments and take such other action as may  
8           be necessary or convenient to carry out the purposes of this chapter.
- 9           3. To plan, establish, acquire, develop, construct, purchase, enlarge, improve, maintain,  
10          equip, operate, regulate, and protect airports and air navigation facilities, within this  
11          state and within any adjoining state, including the acquisition, construction, installation,  
12          equipment, maintenance, and operation at such airports or buildings and other  
13          facilities for the servicing of aircraft or for comfort and accommodation of air travelers,  
14          and the purchase and sale of supplies, goods, and commodities as are incident to the  
15          operation of its airport properties. For such purposes an authority may by purchase,  
16          gift, devise, lease, eminent domain proceedings, or otherwise acquire property, real or  
17          personal, or any interest therein, including easements in airport hazards or land  
18          outside the boundaries of an airport or airport site, as are necessary to permit the  
19          removal, elimination, obstruction-marking or obstruction-lighting of airport hazards or  
20          to prevent the establishment of airport hazards.
- 21          4. To establish comprehensive airport zoning regulations in accordance with the laws of  
22          this state. For the purpose of this chapter, a regional airport authority has the same  
23          powers as all other political subdivisions in the adoption and enforcement of  
24          comprehensive airport zoning regulations as provided for by the laws of this state.
- 25          5. To acquire, by purchase, gift, devise, lease, eminent domain proceedings or otherwise,  
26          existing airports and air navigation facilities; provided, however, an authority may not  
27          acquire or take over any airport or air navigation facility owned or controlled by another  
28          authority, a municipality, or public agency of this or any other state without the consent  
29          of such authority, municipality, or public agency.
- 30          6. To establish or acquire and maintain airports in, over, and upon any public waters of  
31          this state, any submerged lands under such public waters; and to construct and

1 maintain terminal buildings, landing floats, causeways, roadways, and bridges for  
2 approaches to or connecting with any such airport, and landing floats and breakwaters  
3 for the protection thereof.

4 7. To establish toll access roadways leading to air carrier terminal buildings. The toll  
5 access charge may not exceed one dollar per vehicle.

6 **SECTION 4. AMENDMENT.** Section 2-06-14 of the North Dakota Century Code is amended  
7 and reenacted as follows:

8 **2-06-14. Tax levy may be certified by airport authority or municipality.**

9 The airport authority may certify annually to the governing bodies, the amount of tax to be  
10 levied by each municipality participating in the creation of the airport authority, and the  
11 municipality ~~shall~~may levy the amount certified, pursuant to provisions of law authorizing cities  
12 and other political subdivisions of this state to levy taxes for airport purposes. The levy made  
13 may not exceed the maximum levy permitted by the laws of this state for airport purposes. The  
14 municipality shall collect the taxes certified by an airport authority in the same manner as other  
15 taxes are levied and collected. The proceeds of such taxes must be deposited in a special  
16 account or accounts in which other revenues of the authority are deposited and may be  
17 expended by the authority as provided for in this chapter. Prior to the issuance of bonds under  
18 section 2-06-10, and if approved by vote of the governing body or electors of the municipality as  
19 required under section 2-06-10, the airport authority or the municipality may by resolution  
20 covenant and agree that the total amount of such taxes then authorized by law, or such portion  
21 thereof as may be specified by the resolution, will be certified, levied, and deposited annually  
22 until the bonds and interest are fully paid.

23 **SECTION 5. AMENDMENT.** Section 2-06-15 of the North Dakota Century Code is amended  
24 and reenacted as follows:

25 **2-06-15. ~~County tax~~ Tax levy by county, city, or township for airport or airport**  
26 **authority purposes.**

27 ~~In counties supporting airports or airport authorities, a~~A county, city, or township supporting  
28 an airport or airport authority may levy a tax not exceeding the limitation in subsection 1 of  
29 ~~section 57-15-06.7 may be made for such~~four mills for airport or airport authority purposes, but  
30 this levy shall not apply to any city, township, or park district that already has an airport levy.

1       **SECTION 6. AMENDMENT.** Section 4-02-26 of the North Dakota Century Code is amended  
2 and reenacted as follows:

3       **4-02-26. County fairs - Association - Aiding County funding.**

4       A county fair association may be organized in any county ~~having taxable property of a~~  
5 ~~taxable valuation of not less than seven hundred fifty thousand dollars.~~ The executive officers  
6 and directors must be residents of the county. The association may ~~apply~~ make written  
7 application to the board of county commissioners of the county for a grant to aid in the erection  
8 of suitable buildings and other improvements to accommodate its patrons and exhibits; and to  
9 pay premiums and expenses that may be awarded on ~~such~~ fair exhibits ~~at any fair.~~ An  
10 application ~~for the grant must be in writing and~~ must state the incorporation of the association,  
11 the names and places of residence of all its executive officers, and the ownership of real  
12 property in the county sufficient in area for the purpose of its fair ~~and of the value of at least two-~~  
13 ~~thousand five hundred dollars.~~ If the board of county commissioners is satisfied that the  
14 statements in the application are true and that the association intends in good faith to hold a fair  
15 within the county annually for the exhibition of agricultural, horticultural, mechanical, and  
16 manufactured products of the county, and of such articles as are usually exhibited at fairs, it  
17 may ~~levy for the first year's grant of aid a tax not exceeding the limitation in section 57-15-06.7-~~  
18 ~~which must be collected as other taxes are collected~~ provide funding from revenues derived  
19 from the county general fund levy authority. If the ~~tax~~ funding is ~~levied~~ approved, the board of  
20 county ~~commissioner~~ treasurer shall pay to the secretary of the association, ~~not later than~~ by  
21 the following July thirty-first thereafter, the amount of the ~~tax levied~~ funding approved and shall  
22 take the receipt of the association ~~therefor~~ for the payment.

23       Any amount received by the county fair association must be deposited by the secretary of  
24 the association in a fund to be known as the "county fair fund". To promote holding a county fair,  
25 the board of county commissioners may purchase or lease in the name of the county not to  
26 exceed two hundred forty acres [97.12 hectares] of real estate and construct buildings and  
27 improvements for the conduct of a county fair. The board of county commissioners may issue  
28 bonds in the name of the county if approved by electors of the county in accordance with  
29 sections 21-03-06 and 21-03-07 to purchase not to exceed two hundred forty acres  
30 [97.12 hectares] of real estate and construct buildings and improvements for the conduct of a  
31 county fair.

1 The board of county commissioners may continue ~~the levy~~ to provide funding under this  
2 section after the first year's grant of aid upon the board's own motion.

3 The authority of this section may be used by a county to join in formation and funding of a  
4 multicounty fair association under terms of an agreement with one or more other counties.

5 **SECTION 7. AMENDMENT.** Section 4-02-27.3 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **4-02-27.3. Disposition of property.**

8 Any property used for county fair purposes may be sold by the board of county  
9 commissioners upon such terms and conditions as the board shall determine, and the proceeds  
10 of such sale shall be placed in the county fair fund and used exclusively for county fair  
11 purposes, ~~provided that if~~ If the county fails to hold a fair within the county for two successive  
12 years, any property on hand may be sold and the proceeds of such sale, together with any  
13 other unexpended balance in the county fair fund, at the discretion of the board of county  
14 commissioners, may be transferred to the county general fund. The board of county  
15 commissioners of any county in which a county fair has not been held for five consecutive years  
16 shall transfer any funds in the county fair fund or funds budgeted for county fairs to the county  
17 general fund to be used for general county purposes. ~~The levy of the tax funding from revenues~~  
18 ~~derived from the county general fund levy authority~~ authorized by section ~~4-02-27-24-02-26,~~  
19 expenditures of ~~the~~ those proceeds thereof, and the conduct of the fair shall be governed by  
20 sections 4-02-07 through 4-02-31 to the extent such sections are consistent with section  
21 ~~4-02-27-24-02-26~~ and this section.

22 **SECTION 8. AMENDMENT.** Section 4-08-15 of the North Dakota Century Code is amended  
23 and reenacted as follows:

24 **4-08-15. Tax Extension work levy - Appropriation from county general fund - Both**  
25 **authorized and funding - Additional levy with voter approval.**

26 ~~The board of county commissioners of any county of this state in which~~ If a levy for  
27 extension work has been voted on and approved by the people as ~~provided for in~~ under sections  
28 4-08-01 and 4-08-03, the board of county commissioners may levy ~~not to exceed an amount~~  
29 ~~necessary for such purpose, as provided in section 4-08-09,~~ for extension work in an amount  
30 not exceeding the limitation in subsection 4~~2~~ of section 57-15-06.7. ~~The statutory mill levy~~  
31 ~~limitation in effect during any biennium, and not the limitation in effect at the time of a county's~~

1 ~~vote for extension work or the number of mills that may have been stated in the ballot for such a~~  
2 ~~vote, is the applicable limitation. If it determines that the amount derived from the levy will not~~  
3 ~~be sufficient for such purpose, the~~

4 The board of county commissioners may submit to the electors at a primary or general  
5 election the question of approval of voter-approved levy authority for extension work for a period  
6 not exceeding ten years and if approved by a majority of the electors voting on the question the  
7 board of county commissioners may levy an additional tax not exceeding the limitation in  
8 subsection 2 of section 57-15-06.7. Voter-approved levy authority authorized by electors of a  
9 county before January 1, 2015, remains in effect through taxable year 2024 or for the time  
10 period authorized by the electors, whichever expires first. After January 1, 2015, approval or  
11 reauthorization by electors of voter-approved levy authority under this section may not be  
12 effective for more than ten taxable years.

13 The board of county commissioners may appropriate additional funds out of the county  
14 general fund to cover ~~the~~any unanticipated deficiency in funding for extension work.

15 **SECTION 9. AMENDMENT.** Subsection 17 of section 4-22-26 of the North Dakota Century  
16 Code is amended and reenacted as follows:

17 17. To levy taxes as follows:

- 18 a. The supervisors may make a general fund tax levy, not exceeding two and  
19 one-half mills, for the payment of the expenses of the district, including mileage  
20 and other expenses of the supervisors, and technical, administrative, clerical, and  
21 other operating expenses.
- 22 b. Immediately after the completion of the district budget and the adoption of the  
23 annual tax levy by the district supervisors, but not later than July first, the  
24 supervisors shall send one certified copy of the levy as adopted to the county  
25 auditor of each county in the district.
- 26 c. The county auditor of each county in the district shall extend the levy upon the  
27 tax list of the county for the current year against each description of real property  
28 lying both within the county and the district in the same manner and with the  
29 same effect as other taxes are extended.
- 30 d. The treasurer of each county in the district shall collect all district taxes together  
31 with interest and penalty thereon in the same manner as the general taxes are

1 collected, and shall pay over to the soil conservation district by the tenth working  
2 day of each month, all taxes so collected during the preceding month, with  
3 interest and penalties collected thereon and shall immediately send notification of  
4 such payment to the treasurer of the soil conservation district.

5 e. ~~Whenever the supervisors of a soil conservation district deem it advisable to~~  
6 ~~raise funds by taxation in excess of the levy provided by this section, for any~~  
7 ~~purpose for which the supervisors of a district are authorized to expend moneys~~  
8 ~~raised by taxes, the supervisors of the district shall submit to the qualified~~  
9 ~~electors of the district at the next general election the question of increasing the~~  
10 ~~levy by a certain number of mills. Notice of the question must be filed with the~~  
11 ~~county auditor fifty-five days before the election. When authorized by a majority~~  
12 ~~of qualified electors of the soil conservation district voting on the question at an~~  
13 ~~election in which the question has been submitted, the supervisors may increase~~  
14 ~~the levy in the amount so authorized~~Voter-approved levy authority authorized by  
15 electors of a district under the provisions of this section before January 1, 2015,  
16 remains in effect through taxable year 2024 or for the time period authorized by  
17 the electors, whichever expires first.

18 No provisions with respect to the acquisition, operation, or disposition of property by other  
19 public bodies are applicable to a district unless the same specifically are made applicable by  
20 law.

21 **SECTION 10. AMENDMENT.** Section 4-33-11 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **4-33-11. Authority for financing local control programs - County pest coordinator.**

24 1. ~~The governing body of any political subdivision~~board of county commissioners may  
25 appropriate money for the control of pests under this chapter. If state funds are  
26 involved, the money must be expended according to control plans approved by the  
27 commissioner. ~~The governing body of a political subdivision~~board of county  
28 commissioners shall determine the portion, if any, of control program costs to be paid  
29 by the ~~political subdivision~~county. Costs of the control program may be paid by  
30 ~~moneys in the emergency fund. If the emergency fund is not sufficient to carry out the~~  
31 ~~program, the governing body may expend money from the general fund and in this~~



1           ~~event the governing body, except the governing body of a park district, upon approval~~  
2           ~~of sixty percent of those voting in any special election or the next regularly scheduled~~  
3           ~~primary or general election, may levy a tax during the following year upon all taxable~~  
4           ~~property in the political subdivision to fully reimburse the general fund for the amount~~  
5           ~~expended except that the levy may not exceed the limitation in subsection 1 of section~~  
6           ~~57-15-28.1~~from revenues derived from general fund levy authority of the county or  
7           from the county levy authority under section 4.1-47-14.

- 8           2. The board of county commissioners for any county shall designate an individual to  
9           serve as county pest coordinator. The county weed control officer may serve in that  
10          capacity if approved by the board of county commissioners. The county pest  
11          coordinator shall administer local and private funds in cooperation with state and  
12          federal pest control programs. When state funds are involved, the county pest  
13          coordinator shall submit county and township control plans to the agriculture  
14          commissioner for approval.

15          **SECTION 11. AMENDMENT.** Section 4.1-47-14 of the North Dakota Century Code is  
16          amended and reenacted as follows:

17          **4.1-47-14. County noxious weed control program - Payment of expenses - Mill levy**  
18          **authorization.**

- 19          1. The board of county commissioners may pay the expenses of a county noxious weed  
20          control program authorized under this chapter from the county general fund, the  
21          noxious weed control fund, or both. In addition to the other program expenditures  
22          authorized in this chapter, the board of county commissioners may expend funds from  
23          the levy authorized under subsection 11 of section 57-15-06.7 to control noxious  
24          weeds or undesirable vegetation along county or township roads in the county.
- 25          2. a. The county weed board may annually certify to the board of county  
26          commissioners a tax, not to exceed ~~two mills on the taxable valuation of all~~  
27          ~~property in the county, other than that which~~the levy limitation in subsection 11 of  
28          section 57-15-06.7, but any tax levied under this section does not apply to  
29          property that lies within the boundaries of a city having a noxious weed control  
30          program under this chapter.

- 1           b. ~~In addition to the levy authorized in subdivision a, the board of county~~  
2           ~~commissioners may levy an amount not to exceed two mills per dollar on the~~  
3           ~~taxable valuation of all property in the county, other than that which lies within the~~  
4           ~~boundaries of a city having a noxious weed control program under this chapter.~~  
5           e. The board of county commissioners shall may levy the taxes authorized by this  
6           subsection and shall place those moneys in a separate fund designated as the  
7           ~~noxious weed control fund, which is~~ may be used to pay the expenses of a county  
8           ~~noxious weed control program authorized under this section.~~  
9           d. ~~The tax may be levied in excess of the mill levy limit prescribed by law for general~~  
10          ~~purposes.~~  
11          3. For purposes of this section, the expenses of a county noxious weed control program  
12          include compensation for and the reimbursement of expenses incurred by the county  
13          weed board, the county weed control officer, and other employees of the board, and  
14          expenses incurred in the ~~provision of noxious weed control,~~ as authorized by this  
15          chapter.

16          **SECTION 12. AMENDMENT.** Section 4.1-47-16 of the North Dakota Century Code is  
17          amended and reenacted as follows:

18          **4.1-47-16. State appropriations for noxious weed control - Landowner assistance**  
19          **program.**

- 20          1. The commissioner shall consult with representatives of county and city weed boards  
21          and develop a formula for the distribution to eligible county weed boards and eligible  
22          city weed boards of all moneys appropriated by the state for the landowner assistance  
23          program.  
24          2. a. The formula must require that county officials budget, from revenues derived from  
25          county sources, an amount equal to the revenue that could be raised by a levy of  
26          at least three mills for noxious weed control; ~~provided, however, that this amount~~  
27          ~~does not apply to property that lies~~ against taxable property in the county which  
28          does not lie within the boundaries of a city having a noxious weed control  
29          program under this chapter.

- 1           b. The formula must require that city officials budget, from city sources, an amount  
2           equal to the revenue that could be raised by a levy of at least three mills for  
3           noxious weed control.
- 4           3. a. The formula must require that the landowner contribute an amount equal to at  
5           least twenty percent of the cost to be expended on behalf of the landowner.
- 6           b. The nature and type of the landowner's contribution must be determined by the  
7           weed board having jurisdiction over the area in which the landowner's property is  
8           located.

9           **SECTION 13. AMENDMENT.** Section 4.1-47-25 of the North Dakota Century Code is  
10          amended and reenacted as follows:

11           **4.1-47-25. City noxious weed control program - Payment of expenses -~~Mill levy~~**  
12          **authorization.**

- 13           1. The governing body of a city may ~~pay the expenses of~~provide funding for a city  
14           noxious weed control program authorized under this chapter ~~from the city general~~  
15           ~~fund, the noxious weed control fund, or both~~from revenues derived from its general  
16           fund levy authority.
- 17           2. a. The city weed board may annually ~~certify to request~~ the governing body of a city  
18           ~~a tax, not to exceed two mills on the taxable valuation of all property in the city to~~  
19           provide funds derived from its general fund levy authority in the amount necessary for  
20           the city noxious weed control program.
- 21           b. ~~In addition to the levy authorized in subdivision a, the governing body of a city~~  
22           ~~may levy an amount not to exceed two mills per dollar on the taxable valuation of~~  
23           ~~all property in the city.~~
- 24           c. ~~The governing body of a city shall levy the taxes authorized by this subsection~~  
25           ~~and shall place those moneys in a separate fund designated as the noxious weed~~  
26           ~~control fund, which is used to pay the expenses of a city noxious weed control~~  
27           ~~program.~~
- 28           d. ~~The tax may be levied in excess of the mill levy limit prescribed by law for general~~  
29           ~~purposes.~~
- 30           3. For purposes of this section, the expenses of a city noxious weed control program  
31           include compensation for and the reimbursement of expenses incurred by the city

1 weed board, the city weed control officer, and other employees of the board, and  
2 expenses incurred in the provision of noxious weed control, as authorized by this  
3 chapter.

4 **SECTION 14.** Six new subsections to section 11-11-14 of the North Dakota Century Code  
5 are created and enacted as follows:

6 To expend county funds for eradication of gophers, prairie dogs, rabbits, crows, or  
7 magpies.

8 To expend county funds to enhance communications infrastructure for countywide  
9 benefit.

10 To provide for the planning, design, acquisition, development, operation, maintenance,  
11 and support of automation and telecommunications resources.

12 To provide for firebreaks and other fire protection and suppression measures.

13 To construct, equip, operate, and maintain county buildings, including court facilities,  
14 correction centers, jails, and other law enforcement facilities.

15 To require that all financial records, including all revenues, expenditures, fund  
16 balances, and complete budgets be submitted to the board of county commissioners  
17 at a time and in a format requested by the board of county commissioners by all  
18 boards, authorities, committees, and commissions appointed by the board of county  
19 commissioners before consideration by the board of county commissioners of the  
20 budget and levy request.

21 **SECTION 15. AMENDMENT.** Section 11-11-53 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **11-11-53. Appropriation for historical works - Authorization of tax levy - Approval of**  
24 **state historical society and attorney general.**

25 1. The board of county commissioners of any county may appropriate out of the general  
26 fund of the county a sum, not exceeding five thousand dollars annually, to be paid to

1 the historical society of the county and used for the promotion of historical work within  
2 the borders of the county, including the collection, preservation, and publication of  
3 historical material, and to disseminate historical information of the county, and in  
4 general to defray the expense of carrying on historical work in the county.

- 5 2. The board of county commissioners may levy a tax, not exceeding the limitation in  
6 subsection ~~83~~ of section 57-15-06.7, for the promotion of historical works within the  
7 borders of the county and in general defray the expense of carrying on historical work  
8 in the county, including the maintenance of any historical room or building, and  
9 furthering the work of the historical society of the county. The levy is in addition to any  
10 moneys appropriated from the general fund of the county for historical work as  
11 provided in subsection 1.

12 The board of county commissioners may, by resolution, submit the question of an-  
13 ~~additional~~ a voter-approved tax levy to the qualified electors of the county at the next  
14 countywide general, primary, or special election. If sixty percent of the qualified  
15 electors voting on the question approve, a tax ~~must~~ may be levied not exceeding the  
16 limitation in subsection ~~83~~ of section 57-15-06.7, which tax may be expended as  
17 provided in this section. Voter-approved levy authority under this section authorized by  
18 electors of a county before January 1, 2015, remains in effect through taxable year  
19 2024 or for the time period authorized by the electors, whichever expires first. After  
20 January 1, 2015, approval or reauthorization by electors of voter-approved levy  
21 authority under this section may not be effective for more than ten taxable years.

- 22 3. The appropriation and levy authorized by this section may not be used to defray any  
23 expenses of a county historical society until it is incorporated under the laws of this  
24 state as a nonprofit corporation, is affiliated with and has its articles of incorporation  
25 and bylaws approved by the state historical society and the attorney general, and has  
26 contracted with the board of county commissioners in regard to the manner in which  
27 the funds received will be expended and the services to be provided. Historical  
28 societies that qualified for county funds under subsection 1 before July 1, 1965, are  
29 not required to have articles of incorporation and bylaws approved by the attorney  
30 general to receive funds under subsection 1.

1       **SECTION 16. AMENDMENT.** Section 11-11-65 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3       **11-11-65. Programs and activities for handicapped persons - Expenditure of funds.**

4       The board of county commissioners may establish or maintain programs and activities for  
5 handicapped persons, including recreational and other leisure-time activities and informational,  
6 health, welfare, transportation, counseling, and referral services. The board may expend funds  
7 received from state, federal, or private sources or provide funding from revenues derived from  
8 its general fund levy authority for the public purposes provided for in this section. No  
9 expenditure may be made to defray any expenses of any organization or agency until the  
10 organization or agency is incorporated under the laws of this state as a nonprofit corporation  
11 and has contracted with the board in regard to the manner in which the funds will be expended  
12 and the services will be provided. An organization or agency that receives the funds must be  
13 reviewed or approved annually by the board to determine its eligibility to receive funds under  
14 this section.

15       **SECTION 17.** Subsection 4 to section 11-11.1-01 of the North Dakota Century Code is  
16 created and enacted as follows:

17       4. The board of county commissioners in a county where an active industrial  
18 development organization exists may enter a contract with the industrial development  
19 organization for performance of the functions of a job development authority or joint  
20 job development authority as provided in this chapter and may use the proceeds of the  
21 levy authority under section 11-11.1-04 for that purpose.

22       **SECTION 18. AMENDMENT.** Section 11-11.1-04 of the North Dakota Century Code is  
23 amended and reenacted as follows:

24       **11-11.1-04. Tax levy for job development authorities.**

25       The board of county commissioners of a county which has a job development authority or  
26 joint job development authority shall establish a job development authority fund and may levy a  
27 tax not exceeding the limitations in subsection 29 of section 57-15-06.7. The county treasurer  
28 shall keep the job development authority fund separate from other money of the county. ~~If~~  
29 ~~directed by the board of county commissioners, the county treasurer shall keep a separate fund~~  
30 ~~for the job development authority for the proceeds of any designated portion of the levy for~~  
31 ~~promotion of tourism by the job development authority.~~ The county treasurer shall transmit all

1 funds received pursuant to this section within thirty days to the board of directors of the  
2 authority. The funds when paid to the authority must be deposited in a special account, or  
3 special accounts if the authority chooses to maintain a separate account for promotion of  
4 tourism, in which other revenues of the authority are deposited. Moneys received by the job  
5 development authority from any other source must also be deposited in the special accounts.  
6 The moneys in the special accounts may be expended by the authority as provided in sections  
7 11-11.1-02 and 11-11.1-03.

8 **SECTION 19. AMENDMENT.** Section 11-28-06 of the North Dakota Century Code is  
9 amended and reenacted as follows:

10 **11-28-06. Tax levy**~~County parks and recreation areas funding and county parks and~~  
11 ~~recreation areas capital projects levy by board of county commissioners.~~

12 At the time of levying county general fund taxes for other county purposes, the board of  
13 county commissioners shall consider the certificate and budget statement of the board of county  
14 park commissioners and shall ~~levy each year upon all taxable property in the county a tax-~~  
15 ~~sufficient in amount~~may fund from revenues derived from county general fund levy authority an  
16 amount to pay the actual necessary expenses of the county park and recreational areas and  
17 activities program of the board of county park commissioners, including ~~construction,~~  
18 ~~improvement, repair, and~~ operation, and maintenance of the park and recreational areas and  
19 their facilities under its control and those recreational activities of benefit to the general  
20 populace of the county which are under the control of a city or a city park district within the  
21 county, ~~not exceeding the limitation in subsection 10 of section 57-15-06.7. No levy in excess of~~  
22 ~~this limitation shall be made without approval of the eligible voters in the county at a special or~~  
23 ~~general election. The county auditor shall credit the proceeds of such taxfunding authorized by~~  
24 the board of county commissioners to the separate fund of the board of county park  
25 commissioners. This levy shall not apply to cities that already have a park levy unless the  
26 governing body of the city by resolution consents to the levy.

27 The board of county commissioners shall consider the certificate and budget statement of  
28 the board of county park commissioners and may levy taxes annually as provided in 57-15-06.6  
29 for county park capital projects and acquiring real estate as a site for public parks and  
30 construction and equipping and maintaining structural and mechanical components of parks  
31 and recreational facilities. The question of whether the levy for county park capital projects for

1 county parks and recreational facilities is to be discontinued must be submitted to the qualified  
2 electors at the next regular election upon petition of twenty-five percent of the qualified electors  
3 voting in the last regular county election, if the petition is filed not less than sixty days before the  
4 election. A levy may not be discontinued or reduced if it is dedicated to the payment of bonds  
5 issued pursuant to subsection 6 of section 21-03-07. If the majority of the qualified electors vote  
6 to discontinue the levy for county park capital projects for county parks and recreational  
7 facilities, it may not again be levied without a majority vote of the qualified electors at a later  
8 regular election on the question of relevying the tax, which question may be submitted upon  
9 petition as above provided or by decision of the governing board. The levy for county park  
10 capital projects for county parks and recreational facilities does not apply to any property  
11 located in a city in which park district taxes are levied, unless the governing body of the city in  
12 which the property is located consents, by resolution, to the levy.

13 **SECTION 20. AMENDMENT.** Section 11-28.3-03 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15 **11-28.3-03. Notice of election.**

16 In addition to the usual requirements of notices of election, the notice for an election at  
17 which the question provided for in this chapter will be voted upon shall include a statement  
18 describing the boundaries of the proposed rural ambulance service district, expressed,  
19 wherever possible, in terms of the government survey, a statement setting forth a specified mill  
20 levy for the proposed district, which levy shall not exceed the limitation in section  
21 ~~57-15-26.5~~11-28.3-09. The notice of election shall also state the voting areas in which the  
22 question provided by this chapter will be on the ballot.

23 **SECTION 21. AMENDMENT.** Section 11-28.3-09 of the North Dakota Century Code is  
24 amended and reenacted as follows:

25 **11-28.3-09. Emergency medical service policy to be determined- Levy.**

26 The board of directors shall establish a general emergency medical service policy for the  
27 district and shall annually estimate the probable expense for carrying out that policy. The  
28 estimate shall be certified by the president and secretary to the proper county auditor or county  
29 auditors, on or before June thirtieth of each year. ~~The auditor or auditors shall~~board or boards of  
30 county commissioners may levy a tax not to exceed the mill rate approved by the electors of the  
31 district under section 11-28.3-04, and in no event exceeding a mill rate of ten mills upon the



1 taxable property within the district for the maintenance of the rural ambulance service district for  
2 the fiscal year as provided by law. A rural ambulance service district may be dissolved by  
3 approval of electors of the district as provided in section 11-28.3-13.

4 The tax levied for a rural ambulance service district shall be:

- 5 1. Collected as other taxes are collected in the county.
- 6 2. Turned over to the secretary-treasurer of the rural ambulance service district, who  
7 shall be bonded in the amount of at least five thousand dollars.
- 8 3. Deposited by the secretary-treasurer in a state or national bank in a district account.
- 9 4. Paid out upon warrants drawn upon the district account by authority of the board of  
10 directors of the district, bearing the signature of the secretary-treasurer and the  
11 countersignature of the president.

12 In no case shall the amount of the tax levy exceed the amount of funds required to defray  
13 the expenses of the district for a period of one year as embraced in the annual estimate of  
14 expense, including the amount of principal and interest upon the indebtedness of the district for  
15 the ensuing year. The district may include in its operating budget no more than ten percent of its  
16 annual operating budget as a depreciation expense to be set aside in a dedicated emergency  
17 medical services sinking fund deposited with the treasurer for the replacement of equipment  
18 and ambulances. The ten percent emergency medical services sinking fund may be in addition  
19 to the actual annual operating budget, but the total of the annual operating budget and the  
20 annual ten percent emergency medical services sinking fund shall not exceed the  
21 approved amount of revenue that would be generated by application of the maximum mill levy  
22 approved by the electors.

23 **SECTION 22. AMENDMENT.** Section 18-06-10 of the North Dakota Century Code is  
24 amended and reenacted as follows:

25 **18-06-10. Township may contract for prevention and extinguishment of fires.**

26 The electors of each township at the annual township meeting may authorize and empower  
27 the board of township supervisors to levy, ~~not exceeding the limitation in subsection 1 of section~~  
28 ~~57-15-20.2, and fund from revenues derived from the general fund levy authority of the township~~  
29 and provide by contract or otherwise for the prevention of, protection from, and extinguishment  
30 of fires within the townships in such manner as the board of supervisors deems-  
31 advisable township.

1 When so authorized, the supervisors may enter into a five-year contract and levy, not  
2 exceeding the limitation in subsection 1 of section 57-15-20.2, for the payment of the services  
3 obtained under such the contract. Such The contract may be renewed or renegotiated for  
4 another five-year period upon authorization by the electors of the township at the annual  
5 meeting.

6 A voter-approved levy under this section authorized by electors of a township before  
7 January 1, 2015, remains in effect under the provisions of this section at the time the levy was  
8 authorized but not exceeding ten taxable years. Upon expiration of any mill levy under this  
9 section authorized by electors of a township before January 1, 2015, the governing body of the  
10 township or county may, by resolution, transfer any unobligated balance in the fund in which the  
11 levy proceeds were deposited to the general fund of the township.

12 **SECTION 23. AMENDMENT.** Section 18-10-07 of the North Dakota Century Code is  
13 amended and reenacted as follows:

14 **18-10-07. Fire protection policy to be determined - Tax levy limit - Voter-approved levy**  
15 **authority.**

16 The board of directors shall determine a general fire protection policy for the district and  
17 shall annually estimate the probable expense for carrying out the contemplated program. The  
18 annual estimate of probable expense may include an amount determined by the board of  
19 directors to be necessary to be carried over to a future year for purchase of firefighting  
20 equipment, ambulances, or other emergency vehicles. The estimate must be certified by the  
21 president and secretary to the proper county auditor or county auditors, on or before June  
22 thirtieth of each year, who shall levy a tax upon the taxable property within the district for the  
23 maintenance of the fire protection district for the fiscal year as provided by law. The tax may not  
24 exceed the limitation in section 57-15-26.3. No signature on the petition may be considered  
25 valid if made more than ninety days prior to receipt of the petition a tax rate of five mills per  
26 dollar of the taxable valuation of property in the district. Voter-approved levy authority  
27 authorized by the board of directors and the electors, before January 1, 2015, remains in effect  
28 under the provisions of law at the time the levy was authorized for the time period authorized by  
29 the electors but not exceeding five taxable years or the period of time necessary for repayment  
30 of indebtedness incurred which was intended to be repaid from the increased levy. Upon  
31 approval or reauthorization by a majority of electors of the district voting in a mail ballot election

1 conducted as provided in section 18-10-07.1, the tax may be increased to a tax rate not  
2 exceeding thirteen mills per dollar of the taxable valuation of property in the district for a period  
3 not exceeding ten taxable years.

4 The tax must be:

- 5 1. Collected as other taxes are collected in the county.
- 6 2. Turned over to the secretary-treasurer of the rural fire protection district, who shall  
7 have a surety bond in the amount of at least five thousand dollars.
- 8 3. Placed to the credit of the rural fire protection district so authorizing the same by its  
9 secretary-treasurer in a state or national bank, except amounts to be carried over to a  
10 future year for purchase of firefighting equipment, ambulances, or other emergency  
11 vehicles may be invested to earn the maximum return available.
- 12 4. Paid out upon warrants drawn upon the fund by authority of the board of directors of  
13 the district, bearing the signature of the secretary-treasurer and the countersignature  
14 of the president of the rural fire protection district.

15 The amount of tax levy may not exceed the amount of funds required to defray the expenses of  
16 the district for a period of one year as embraced in the annual estimate of expense, including  
17 the amount of principal and interest upon the indebtedness of the district for the ensuing year  
18 and including any amount determined by the board of directors to be necessary to be carried  
19 over to a future year for purchase of firefighting equipment, ambulances, or other emergency  
20 vehicles.

21 **SECTION 24.** Section 18-10-07.1 of the North Dakota Century Code is created and enacted  
22 as follows:

23 **18-10-07.1. Mail ballot election for voter-approved levy approval.**

24 The board of directors of a fire protection district may hold an election by mail ballot for  
25 consideration of approval of a voter-approved levy under section 18-10-07. If the board of  
26 directors holds an election by mail ballot, the board must appoint an election board of five  
27 electors residing in the district to oversee the conduct and determine the result of the election.

28 The members of the election board shall choose a chairman from their number.

29 The secretary of the board of directors shall cause publication of a notice of the mail ballot  
30 election in the newspaper or newspapers of general circulation where the district is located and  
31 in the official newspaper of each county in which the district is located. The newspaper

1 publication must occur at least twenty-five days before and not more than thirty-five days before  
2 a mail ballot election. The notice must specify the amount of the mill levy authority to be voted  
3 upon, that the election is to be held by mail ballot, that no polling places will be open for the  
4 election, and the name and address of the secretary of the board of directors to whom requests  
5 may be made to receive a mail ballot.

6 At least fifteen days before a mail ballot election in a fire protection district, the secretary  
7 shall prepare and have printed an official ballot. The ballot must be headed "Official Ballot" and  
8 state the question "Do you approve a voter-approved additional levy of \_\_\_\_\_ mills for  
9 the \_\_\_\_\_ Fire Protection District?" and provide boxes for the elector to mark a yes or  
10 no vote and a line designated as being for the elector's signature.

11 On the fifteenth day before the election, the secretary of the board of directors shall mail an  
12 official mail ballot with a return identification envelope and instructions sufficient to describe the  
13 voting process to each elector known by the secretary to be residing in the district. The voting  
14 instructions must contain a statement informing the elector that the elector must sign the mail  
15 ballot to make it valid and that the elector is entitled to complete the mail ballot in secrecy. The  
16 secretary shall mail the ballot by first-class mail, addressed to the last-known address of the  
17 elector and placed in an envelope that is prominently marked "Do Not Forward". The return  
18 identification envelope must include an affidavit for the elector to certify that the ballot submitted  
19 represents the elector's vote. An elector may obtain a replacement ballot if a mail ballot is  
20 destroyed, spoiled, lost, or not received by the elector by signing a sworn statement that the  
21 ballot was destroyed, spoiled, lost, or not received and delivering the statement to the secretary  
22 of the district no later than four p.m. on the day before the election. An elector voting by mail  
23 ballot shall either deliver the mail ballot to the secretary of the district before five p.m. on the day  
24 of the election or mail the ballot, which must be postmarked no later than the day of the  
25 election.

26 Immediately after five p.m. on the day of the election, the election board publicly shall open  
27 and canvass the ballots cast and shall declare the preliminary result of the canvass, pending  
28 receipt of any ballots postmarked no later than the day of the election. A mail ballot may be  
29 counted only if the ballot is returned in the return identification envelope and is signed by the  
30 elector. The chairman of the election board shall wrap securely all lists, tally sheets, oaths and

1 affirmations, and other documents relating to the progress of the election and shall deliver the  
2 same to the secretary of the board of directors of the district.

3 **SECTION 25. AMENDMENT.** Section 18-11-10 of the North Dakota Century Code is  
4 amended and reenacted as follows:

5 **18-11-10. Additional city levy Firefighters relief fund contributions.**

6 ~~At the time the tax levies for the support of the city are made the governing body of any~~  
7 ~~city that has adopted a plan under this chapter shall also levy a tax on all taxable property within~~  
8 ~~the city fund from revenues derived from its general fund levy authority a sufficient in amount for~~  
9 ~~firefighters relief association contributions to equal a minimum of eight percent of the current~~  
10 ~~annual salary of a first-class firefighter as last determined and approved by the governing body~~  
11 ~~of the city, for each active member of the fire department relief association at the time the levy is~~  
12 ~~made. This tax must be levied notwithstanding the city maximum annual tax levy for all~~  
13 ~~purposes as limited by statute. This tax is in addition to the tax levy as so limited.~~

14 **SECTION 26. AMENDMENT.** Subsection 1 of section 21-03-06 of the North Dakota  
15 Century Code is amended and reenacted as follows:

- 16 1. By any county:
- 17 a. To provide county buildings ~~and to acquire land for county purposes~~, but all  
18 outstanding unpaid bonds for this purpose may not exceed in amount at any one  
19 time five percent of the value of taxable property in such county.
  - 20 b. To construct, enlarge, or repair, or aid in the construction, enlargement, or repair,  
21 of bridges within or without the county, but all outstanding unpaid bonds for this  
22 purpose may not exceed in amount at any one time one percent of the value of  
23 taxable property in the county.
  - 24 c. To provide funds for the original construction and for the improvement and  
25 maintenance of highways, but all outstanding unpaid bonds for these purposes  
26 may not exceed in amount at any one time four percent of the value of taxable  
27 property in such county.
  - 28 d. To provide funds for the construction of solid waste disposal facilities, for the  
29 acquisition of real estate for that purpose, for facilities and equipment for the  
30 collection of solid wastes, and for facilities and equipment to dispose of waste  
31 products.

- 1 e. To provide money for the payment of any deficiency in the fund of any special  
2 improvement district whenever the special assessment or taxes levied and  
3 collected for the specific improvements are insufficient to pay the principal or  
4 interest of any special improvement warrants or bonds issued for the  
5 improvement and due and unpaid, but only to the extent of that deficiency.
- 6 f. To provide funds for the acquiring, laying out, equipping, and improving parks and  
7 recreational facilities and to acquire land for these purposes.
- 8 g. To provide funds to purchase not to exceed two hundred forty acres  
9 [97.12 hectares] of real estate and construct buildings and improvements for the  
10 conduct of a county fair.

11 **SECTION 27. AMENDMENT.** Subsections 3, 5, and 6 of section 21-03-07 of the North  
12 Dakota Century Code are amended and reenacted as follows:

- 13 3. The governing body of any municipality may issue bonds of the municipality for the  
14 purpose of providing funds to meet its share of the cost of any ~~federal-aid~~ highway  
15 project undertaken under an agreement entered into by the governing body with the  
16 United States government, the director of the department of transportation, the board  
17 of county commissioners, or any of them, including the cost of any construction,  
18 improvement, financing, planning, and acquisition of right of way of a bridge eligible for  
19 ~~federal~~ matching funds, ~~federal-aid~~ highway routed through the municipality and of any  
20 bridges and controlled access facilities thereon and any necessary additional width or  
21 capacity of the bridge or roadway thereof greater than that required for federal or state  
22 bridge or highway purposes, and of any necessary relaying of utility mains and  
23 conduits, curbs and gutters, and the installation of utility service connections and  
24 streetlights. The portion of the total cost of the project to be paid by the municipality  
25 under the agreement, including all items of cost incurred directly by the municipality  
26 and all amounts to be paid by it for work done or contracted for by other parties to the  
27 agreement, may not exceed a sum equal to thirty percent of the total cost, including  
28 engineering and other incidental costs, of all construction and reconstruction work to  
29 be done plus fifty percent of the total cost of all right of way to be acquired in  
30 connection therewith. The initial resolution authorizing issuance of bonds under this  
31 subsection must be published in the official newspaper of the municipality. Within sixty

1 days after publication, an owner of taxable property within the municipality may file  
2 with the auditor or chief fiscal officer of the municipality a written protest against  
3 adoption of the resolution. A protest must describe the property that is the subject of  
4 the protest. If the governing body finds protests have been signed by the owners of  
5 taxable property having an assessed valuation equal to five percent or more of the  
6 assessed valuation of all taxable property in the municipality, as most recently finally  
7 equalized, all further proceedings under the initial resolution are barred. Nothing  
8 herein may be deemed to prevent any municipality from appropriating funds for or  
9 financing out of taxes, special assessments, or utility revenues any work incidental to  
10 any such project, in the manner and to the extent otherwise permitted by law, and the  
11 cost of any work so financed may not be included in computing the portion of the  
12 project cost payable by the municipality, within the meaning of this subsection, unless  
13 the work is actually called for by the agreement between the municipality and the other  
14 governmental agencies involved.

15 5. The governing body of any city may also by resolution adopted by a two-thirds vote  
16 dedicate the mill levies ~~as~~ levy authorized by ~~sections~~ section 57-15-42 and ~~57-15-44~~  
17 and may authorize and issue general obligation bonds to be paid by ~~these~~ the  
18 dedicated ~~levies~~ levy for the purpose of providing funds for the purchase, construction,  
19 reconstruction, or repair of public buildings or fire stations; provided, that the initial  
20 resolution authorizing the mill levy dedication and general obligation bonds must be  
21 published in the official newspaper, and any owner of taxable property within the city  
22 may, within sixty days after publication, file with the city auditor a protest against the  
23 adoption of the resolution. Protests must be in writing and must describe the property  
24 which is the subject of the protest. If the governing body finds such protests to have  
25 been signed by the owners of taxable property having an assessed valuation equal to  
26 five percent or more of the assessed valuation of all taxable property within the city, as  
27 theretofore last finally equalized, all further proceedings under the initial resolution are  
28 barred.

29 6. The governing body of any county may also by resolution adopted by a two-thirds vote  
30 dedicate the tax levies ~~as~~ levy authorized by ~~sections~~ section 57-15-06.6 and  
31 ~~57-15-06-9~~ and may authorize and issue general obligation bonds to be paid by

1            ~~these~~the dedicated levies~~ies~~levy for the purpose of providing funds for the purchase,  
2            construction, reconstruction, or repair of regional or county correction centers, or parks

9            of taxable property having an assessed valuation equal to five percent or more of the  
10           assessed valuation of all taxable property within the county, as theretofore last finally  
11           equalized, all further proceedings under the initial resolution are barred.

12           **SECTION 28. AMENDMENT.** Section 23-06-30 of the North Dakota Century Code is  
13           amended and reenacted as follows:

14           **23-06-30. Abandoned cemeteries to be maintained by counties.**

15           The board of county commissioners of each county may provide for the identification,  
16           cataloguing, recording, and shall provide for the general maintenance and upkeep of each  
17           abandoned cemetery located within such county using revenues derived from its general fund  
18           levy authority. The board shall, at least once each year, proceed to have the weeds and grass  
19           cut, restore gravestones to their original placement, and perform any other general  
20           maintenance necessary to maintain the dignity and appearance of the grounds. For the  
21           purposes of this section, a cemetery means any tract of land used as a burial plot and which is  
22           filed with the recorder of the county as a public burying place. The board of county  
23           commissioners of each county shall provide for the registration, with the state department of  
24           health, of each abandoned cemetery within such county unless such cemetery has been  
25           previously registered. Such registration must take place within one year of notification being  
26           made to the board, by any interested party of the existence of such abandoned cemetery.  
27           ~~Expenditures may not exceed levy limitations as provided in section 57-15-27.2.~~

28           **SECTION 29. AMENDMENT.** Section 23-18-01 of the North Dakota Century Code is  
29           amended and reenacted as follows:



1       **23-18-01. Hospital associations authorized - County tax levy in aid - Election.**

2       A county or community hospital association may be established in any county in this state.  
3       The executive officers and directors must be residents of the county. The association may apply  
4       to the board of county commissioners of the county for a grant to aid in the erection or operation  
5       of a nonsectarian county hospital. The application for the grant must be in writing and must  
6       state the incorporation of the association, the names and places of residence of all of its  
7       executive officers, and the assets of the association, and must specify the mill rate of levy  
8       applied for, which ~~may not be in excess of~~ must be within the limitation in subsection 424 of  
9       section 57-15-06.7. If the board of county commissioners is satisfied that the statements in the  
10      applications are true and that the association intends in good faith to establish or aid in the  
11      operation of a nonsectarian county or community hospital, it ~~shall~~ may submit to the electors of  
12      the county the question of levying a tax in aid of such nonsectarian county or community  
13      hospital, not exceeding the limitation in subsection 424 of section 57-15-06.7. The county  
14      auditor shall give notice of such election within the time and in the manner prescribed by law for  
15      the holding of county elections.

16      Voter-approved levy authority under this section authorized by electors of a county before  
17      January 1, 2015, remains in effect through taxable year 2024 or for the time period authorized  
18      by the electors, whichever expires first. After January 1, 2015, reauthorization by electors of  
19      voter-approved levy authority under this section is allowable only for hospital associations in  
20      existence prior to January 1, 2015, and may not be effective for more than ten taxable years.

21      A hospital association under this chapter shall transition to a hospital district under chapter  
22      23-30 by July 1, 2017, and is not required to obtain approval of electors under section 23-30-02  
23      to make the transition.

24      **SECTION 30. AMENDMENT.** Section 23-30-01 of the North Dakota Century Code is  
25      amended and reenacted as follows:

26      **23-30-01. Definitions.**

27      In this chapter, unless the context or subject matter otherwise requires:

- 28      1. "Hospital" means an institution with an organized medical staff, permanent facilities  
29      including inpatient beds, medical services including physician services and continuous  
30      nursing services, to provide diagnosis and treatment for medical conditions, both  
31      surgical and nonsurgical, and services including rehabilitation services.

- 1           2. "Hospital district" means a district organized pursuant to section 23-30-02 for the  
2           purpose of supporting one or more of the following types of institutions: a hospital, an  
3           intermediate health care facility, ~~and~~ a nursing home, or a clinic.
- 4           3. "Intermediate health care facility" means a health-related institution planned,  
5           organized, operated, and maintained to supply supportive, restorative, and preventive  
6           health care with related social care, to individuals who, because of their physical or  
7           mental condition, or both, require less than twenty-four-hour nursing care in an  
8           institutional environment, but who do not have an injury, illness, or disability for which  
9           regular medical care and twenty-four-hour nursing services are required.
- 10          4. "Nursing home" means an institution in which nursing care is rendered for  
11          compensation to two or more persons not related to the operator by blood or marriage,  
12          serving persons suffering from a prolonged physical or mental illness or defect, or  
13          persons recovering from some injury or disease. Care provided must include:  
14          administration of medicines, preparation of special diets, giving of bedside care,  
15          application of dressings and bandages, and carrying out treatments prescribed by duly  
16          licensed practitioners of the healing arts.

17           **SECTION 31. AMENDMENT.** Section 23-30-07 of the North Dakota Century Code is  
18   amended and reenacted as follows:

19           **23-30-07. Tax levy authorized.**

20           The board of directors shall annually estimate the probable expense for operating the  
21   hospital district. The estimate must be certified by the president and secretary to the proper  
22   county auditor or county auditors, on or before June thirtieth of each year. The auditor or  
23   auditors shall levy a tax not exceeding the limitation in section 57-15-26.4 for the maintenance  
24   of the district for the fiscal year as provided by law. The tax must be:

- 25          1. Collected as other taxes are collected in the county.
- 26          2. Turned over to the secretary-treasurer of the district, who must have a surety bond set  
27          by the board of directors in the amount of at least five thousand dollars.
- 28          3. Placed to the credit of the district authorizing it by its secretary-treasurer in a state or  
29          national bank qualifying as a public depository.

1           4.   Paid out upon warrants drawn upon the fund by authority of the board of directors of  
2                   the district, bearing the signature of the secretary-treasurer and the countersignature  
3                   of the president of the district.

4           The amount of the tax levy may not exceed the amount of funds required to defray the  
5 expenses of the district for a period of one year as embraced in the annual estimate of expense  
6 including the amount of principal and interest upon the indebtedness of the district for the  
7 ensuing year.

8           Voter-approved levy authority under this section or section 23-18-01 authorized by electors  
9 of a county before January 1, 2015, remains in effect through taxable year 2024 or for the time  
10 period authorized by the electors, whichever expires first. After January 1, 2015, approval or  
11 reauthorization by electors of voter-approved levy authority under this section may not be  
12 effective for more than ten taxable years.

13           **SECTION 32. AMENDMENT.** Section 24-05-01 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15           **24-05-01. County road system and construction plan - County road and bridge tax**  
16 **levy - Allocation and use of funds.**

17           ~~In each county having a population of two thousand or more, there must be levied and~~  
18 ~~collected a property tax of not less than one fourth of one mill, nor more than the maximum rate~~  
19 ~~permitted by section 57-15-06, on each~~The board of county commissioners of any county shall  
20 periodically prepare a proposed county construction program of roads on the county road  
21 system, setting forth a general description of the roads to be constructed, the location of bridges  
22 constituting a part of the program, the approximate total mileage, and the priority of  
23 construction.

24           1.   The board of county commissioners may levy a tax not exceeding a tax rate of  
25                   ten mills per dollar of the taxable valuation of ~~all taxable~~ property in the county for the  
26 improvement of ~~highways~~county roads and bridges.

27           2.   When authorized by ~~sixty percent~~ a majority of the qualified electors voting upon the  
28 question at a regular or special election in the county, the county commissioners may  
29 levy and collect a ~~property~~an additional tax for county road and bridge purposes not  
30 exceeding ~~the limitation in subsection 14 of section 57-15-06.7a~~ a tax rate of ten mills  
31 per dollar of the taxable valuation of property in the county. The levy pursuant to such

1 an election may be discontinued ~~at the discretion of~~by the board of county  
2 commissioners; or, upon petition of five percent of the qualified electors of such  
3 county, the question of discontinuance of the levy must be submitted to the qualified  
4 electors of the county at any regular or special election and, upon a favorable vote to to  
5 discontinue the levy of sixty percent a majority of the qualified electors voting, such  
6 levy must be discontinued.

7 Of the proceeds of the tax collected under levy authority under this subsection on  
8 account of property situated within any city, by the county treasurer of the county in  
9 which the city is located, twenty percent must be turned over by the treasurer to the  
10 auditor of the city, in the manner provided in section 11-13-06 to be expended under  
11 the direction of the governing body of the city in the improvement of its streets and  
12 highways.

13 3. When a county requires levy authority for county road and bridge purposes in excess  
14 of the limitations under subsections 1 and 2 and the county is authorized by a majority  
15 of the qualified electors voting upon the question at a regular or special election in the  
16 county, the board of county commissioners may levy and collect an additional tax not  
17 exceeding a tax rate of ten mills per dollar of the taxable valuation of property in the  
18 county. The levy pursuant to an election under this subsection may be discontinued by  
19 the board of county commissioners or, upon petition of five percent of the qualified  
20 electors of such county, the question of discontinuance of the levy must be submitted  
21 to the qualified electors of the county at any regular or special election and, upon a  
22 favorable vote to discontinue the levy of a majority of the qualified electors voting,  
23 such levy must be discontinued.

24 4. Additional levy authority authorized by electors of a county under this section or  
25 section 57-15-06.3 before January 1, 2015, remains in effect under the provisions of

27 but not exceeding ten taxable years, unless discontinued earlier by the board of  
28 county commissioners or the electors of the county. After January 1, 2015, approval or  
29 reauthorization by electors of increased levy authority under this section may not be  
30 effective for more than ten taxable years.

1        5. The county treasurer shall retain and deposit in a fund known as the county road and  
2        bridge fund the county share of the tax under this section and any proceeds of this tax  
3        totaling less than twenty dollars in a taxable year which is collected on account of  
4        property situated within any city. Proceeds of the county share of the tax not turned-  
5        over to cities pursuant to this section must be kept in the county road fund and under  
6        this section must be expended in the improvement of highways as provided in this  
7        chapter under the direction of the board of county commissioners. The provisions of  
8        this section in regard to allocation apply to the proceeds of any tax originally levied for  
9        other purposes if appropriated or transferred to the county road and bridge fund or for  
10       expenditure for road and bridge purposes. No allocation pursuant to this section may  
11       include the proceeds received by the county as its share of the allocation made  
12       pursuant to section 54-27-19, nor may any allocation under this section include  
13       moneys received from the state as the result of any other intergovernmental transfer.

14        Any unobligated balance in the county special road fund and reserve road and  
15        bridge fund on August 1, 2015, must be transferred to the county road and bridge fund  
16        and the county special road fund and reserve road and bridge fund must be closed  
17        out.

18        **SECTION 33. AMENDMENT.** Section 24-05-02 of the North Dakota Century Code is  
19        amended and reenacted as follows:

20        **24-05-02. Fund - How expended.**

21        The county road and bridge fund created by section 24-05-01 may be expended only for  
22        road machinery and for grading, ditching, and surfacing, ~~in proper form and condition for public~~  
23        ~~travel, such highways or parts of highways, howsoever established, as constitute the principal~~  
24        ~~thoroughfares of the county, communicating with shipping points and marketplaces resorted to~~  
25        ~~by inhabitants of the county, for which the means otherwise provided, in the opinion of the board~~  
26        ~~of county commissioners, are not sufficient and implementation of the proposed county~~  
27        construction program of roads on the county road system.

28        **SECTION 34. AMENDMENT.** Section 24-05-05 of the North Dakota Century Code is  
29        amended and reenacted as follows:

1       **24-05-05. County auditor to issue warrants.**

2       Upon the filing of the surveyor's certificate as provided in section 24-05-03, the county  
3 auditor shall issue warrants accordingly on the county treasurer in favor of the contractor,  
4 payable out of the county road and bridge fund appropriated thereto, and the same must be  
5 paid by the treasurer.

6       **SECTION 35. AMENDMENT.** Section 24-05-16 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8       **24-05-16. County road system - Designation.**

10 ~~kilometers]. This system must remain substantially unchanged until such system has been~~

12       The county road system must be the roads designated and selected by the boards of  
13 county commissioners. The director must be informed of the system so designated. Any

15 must be made by the board of county commissioners and the director must be notified of such  
16 changes. In designating and selecting roads on the county road system, the boards of county  
17 commissioners of the several counties shall take into account such factors as the actual or

20 into the general scheme of the statewide network of county roads.

6 and the services will be provided. No unclaimed dog or cat may be released for adoption by an  
7 animal shelter that receives funds from the levy under this section without being first sterilized,  
8 or without a written agreement and deposit from the adopter guaranteeing that the animal will  
9 be sterilized.

10 **SECTION 41. AMENDMENT.** Section 40-05-20 of the North Dakota Century Code is

12 **40-05-20. Programs and activities for handicapped persons - Expenditure of funds.**

13 The governing body of any city or park district may establish or maintain programs and  
14 activities for handicapped persons, including recreational and other leisure-time activities and

16 body may provide funding from revenues derived from its general fund levy authority and may

26 **40-26-08. Municipality liable generally for deficiencies in special improvement fund.**

27 Whenever all special assessments and all utility revenues and taxes, if any, appropriated  
28 and theretofore collected for a special improvement, made under authority of any law  
29 authorizing the payment of the cost thereof in whole or in part from special assessments, are  
30 insufficient to pay principal or interest then due on the special improvement warrants issued  
31 against such improvement, the governing body shall levy a tax upon all of the taxable property

1 in the municipality for the payment of such deficiency. If at any time a deficiency is likely to  
2 occur within one year in such special improvement fund for the payment of principal and interest

5 any deficiency in a special improvement fund, including a sewer and water connections

8 balance remains unexpended in such a special improvement fund after the payment of all  
9 warrants drawn thereon with interest, it shall be paid over or transferred to the general fund of  
10 the municipality.

11 **SECTION 43. AMENDMENT.** Section 40-28-05 of the North Dakota Century Code is  
12 amended and reenacted as follows:

13 **40-28-05. Sewer and water connections assessment fund - Warrants - Payment.**

14 All money collected from assessments for laying and constructing sewer, water, and other  
15 service connections provided for in this chapter shall be kept in a fund called "sewer and water  
16 connections assessment fund", and warrants shall be drawn on such fund for the payment of  
17 the cost of such connections. All sewer and water connections assessment warrants shall be  
18 payable as specified and in such amount as in the judgment of the governing body will be  
19 provided by the taxes and assessments. Such warrants shall bear interest at a rate of not more

17 expires in a city, any unobligated balance in the fire department reserve fund must be  
18 transferred to the city capital improvements fund.

28 subsidizing city emergency medical services, shall upon written application to the county board  
29 of such county be exempted from such county tax levy. The city may set aside, as a  
30 depreciation expense, up to ten percent of its annual emergency medical service operating or  
31 subsidization budget in a dedicated emergency medical services sinking fund, deposited with

1 the auditor for replacement of equipment and ambulances. The ten percent emergency medical  
2 services sinking fund may be in addition to the actual annual emergency medical services  
3 budget but the total of the annual emergency medical services budget and the annual ten-  
4 percent emergency medical services fund may not exceed the approved mill levy.

5 **SECTION 96. AMENDMENT.** Section 57-15-51.1 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **57-15-51.1. ~~Levy authorized~~Funding for township emergency medical service.**

8 Pursuant to a vote of sixty percent of the ~~The~~ qualified electors voting at the annual township  
9 meeting, or at a special election called for that purpose upon petition of fifty percent of the  
10 number of qualified electors of the township voting in the last election for governor, the board of  
11 township supervisors shall levy annually a tax approved by the qualified electors not exceeding  
12 the limitation in subsection 7 of section 57-15-20.2 of an organized township may authorize the  
13 township to provide funding from revenues derived from its general fund levy authority for the  
14 purpose of subsidizing township emergency medical service. In providing for emergency  
15 medical service, the board of supervisors may cooperate with one or more additional townships  
16 or with a city, county, or rural ambulance service district in accordance with chapter 54-40.

22 ~~election called for such purpose, the~~The governing body of any city may levy taxes annually, not  
23 exceeding the limitation in subsection 24 of section 57-15-10, provide funding from revenues  
24 derived from the capital improvements fund levy authority under section 57-15-38 for the  
25 purpose of providing additional funds to meet the operational, maintenance, and construction  
26 costs and costs of maintaining structural and mechanical components of establishing stations  
27 for police protection services and correctional facilities. The proceeds of this levy must be  
28 placed in a separate fund known as the police station and correctional facility fund. No levy may  
29 be made under this section during any period in which the moneys to the fund equal or exceed  
30 an amount equal to the sum that would be produced by a levy of ten mills upon the taxable  
31 valuation of the city making the levyAny levy under this section approved by the electors of a

1 city before January 1, 2015, remains effective for ten taxable years or for the period of time for  
2 which it was approved by the voters, whichever is less, under the provisions of this section in  
3 effect at the time it was approved. When the authority to levy under this section expires in a city,  
4 any unobligated balance in the police station and correctional facility fund must be transferred to  
5 the city capital improvements fund.

6 **SECTION 98. AMENDMENT.** Section 57-15-55 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **57-15-55. Tax levy for public transportation.**

9 The governing body of any city, upon approval by a majority vote of the qualified electors of  
10 the city voting on the question at any citywide election, may annually levy a tax not exceeding  
11 the limitation in subsection 2510 of section 57-15-10 to provide funds for the provision and  
12 operation of a public transportation system within the city under a contract approved by the  
13 governing body with a private contractor, or by the city itself.

14 **SECTION 99. AMENDMENT.** Subsection 1 of section 57-15-56 of the North Dakota  
15 Century Code is amended and reenacted as follows:

16 1. The board of county commissioners of any county is hereby authorized to levy a tax,  
17 or if no levy is made by the board of county commissioners, the governing body of any  
18 city in the county is authorized to levy a tax, in addition to all levies now authorized by  
19 law, for the purpose of establishing or maintaining services and programs for senior  
20 citizens including the maintenance of existing senior citizen centers which will provide  
21 informational, health, welfare, counseling, and referral services for senior citizens, and  
22 assisting such persons in providing volunteer community or civic services. If the tax  
23 authorized by this section is levied by the board of county commissioners, any existing  
24 levy under this section by a city in the county becomes void for subsequent taxable  
25 years. The removal of the levy is not subject to the requirements of subsection 3. This  
26 tax may not exceed the limitation in subsection 2512 of section 57-15-06.7 or  
27 subsection 2611 of section 57-15-10. The proceeds of the tax must be kept in a  
28 separate fund and used exclusively for the public purposes provided for in this section.  
29 This levy must be in addition to any moneys expended by the board of county  
30 commissioners pursuant to section 11-11-58 or by the governing body of any city  
31 pursuant to section 40-05-16.

1       **SECTION 100. AMENDMENT.** Section 57-20-23 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3       **57-20-23. County responsible for collecting and transmitting state taxes.**

4       Each county is responsible to the state for the full amount of the taxes levied for state  
5 purposes, except such amounts or taxes as have been canceled as uncollectible, or canceled  
6 or abated, as provided by law. If any county treasurer proves to be a defaulter, to any amount,  
7 of state revenue, ~~such amount must be made up to the state within the ensuing three years by~~  
8 ~~additional levies in such manner in annual amounts as the board of county commissioners may~~  
9 ~~direct. In such case~~ the county shall make up the deficiency from revenues derived from the  
10 county's general fund levy authority over a period of three years, without interest, and the  
11 county can have recourse to the official bond of the county treasurer for indemnity.

24 acquisition of road machinery or equipment, the board of county commissioners may authorize  
25 use of funds derived from the county levy under section 24-05-01 to repay the loan, in addition  
26 to any other funding for loan repayment available to the county.

6 levy authority of the township for such park purposes, but such levies do not apply to property in  
7 any city or park district which levies for park district purposes.

22 be used only for weather modification activities in conjunction with the state of North Dakota.  
23 The tax certified by the weather modification authority is limited to the period of existence of the  
24 weather modification authority ~~as provided for in this chapter.~~

25       **SECTION 105. AMENDMENT.** Section 61-24-02 of the North Dakota Century Code is  
26 amended and reenacted as follows:

27       **61-24-02. Garrison Diversion Conservancy District created.**

28       The "Garrison Diversion Conservancy District", hereinafter referred to as the "district"  
29 consists of that part of the state that is included within the boundaries of the following counties:  
30 Barnes, Benson, Bottineau, Burleigh, Cass, Dickey, Eddy, Foster, Grand Forks, Griggs,

1 LaMoure, McHenry, McLean, Nelson, Pierce, Ramsey, Ransom, Renville, Richland, Sargent,  
2 Sheridan, Steele, Stutsman, Traill, Ward, and Wells.

3 The district is a governmental agency, body politic and corporate with the authority to  
4 exercise the powers specified in this chapter, or which may be reasonably implied.

5 Any county may join the district upon application of its board of county commissioners and  
6 the approval of the application by the board of directors of the district. ~~Such county is authorized  
7 to levy taxes as may be necessary to carry out its part of the agreement for becoming a part of  
8 the district, which levy is in addition to the amount that may otherwise be legally levied for  
9 county purposes.~~

10 **SECTION 106. TRANSITION.** The treasurer of each county, city, township, or other political  
11 subdivision maintaining a special fund for which levy authority is eliminated by this Act, by the  
12 end of the fiscal year for which deposit of revenue from levy authority is terminated by this Act,  
13 shall satisfy any obligations of that fund, transfer the remaining balance to the general fund of  
14 the political subdivision, and close out the special fund.
