All vacancies and unexpired terms shall be filled in the same manner as the original appointment and within sixty (60) days from the date of the vacancy. Members may be removed by the Governor for incompetence, willful neglect of duty, corruption in office, or malfeasance in office.

B. Members appointed to the Commission shall reside in this8 state and shall have the following qualifications:

9 1. Two members shall have experience as a professional
10 combative sports practitioner, other than as a professional wrestler
11 or in professional combative sports promotions;

One member shall have experience as a professional wrestler
 or in professional wrestling promotions;

14 3. One member shall have experience in sports medicine;
15 4. One member shall have experience in the cable television
16 business; and

17 5. Four members shall represent the public at large as lay18 members.

19 C. No member of the Commission or any person related to a 20 member within the third degree by consanguinity or affinity shall 21 promote, sponsor, or have any financial interest in the promotion or 22 sponsorship of any professional combative sports event or amateur 23 mixed martial arts event while a member of the Commission.
