9	An Act relating to the prevention of child homelessness; providing short title; creating the
10	Advisory Council on Child Homelessness; providing expiration date; stating purpose; providing for
11	appointments; specifying date by which appointments are made; providing for vacancies; providing for
12	designation of cochairs; specifying quorum; providing for meetings and staffing; requiring compliance with
13	certain laws; providing for determination of meeting dates; requiring examination of certain information;
14	requiring report; providing for codification; providing an effective date; and declaring an
15	emergency.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. NEW LAW A new section of law to be codified
20	in the Oklahoma Statutes as Section 1-9-123 of Title 10A, unless
21	there is created a duplication in numbering, reads as follows:
22	A. This act shall be known and may be cited as the "Oklahoma
23	Child Homelessness Prevention Act".

- B. There is hereby created to continue until September 1, 2016, the Advisory Council on Child Homelessness. The purpose of the Advisory Council shall be to:
 - 1. Review data and propose policy solutions relating to the issue of child homelessness; and
 - 2. Update the Oklahoma State Legislature on existing programs to reduce child homelessness including, but not limited to, programs administered or financed in whole or in part by any agency of this state, nonprofit organizations or private-sector entities.
 - C. The Advisory Council shall consist of eleven (11) members to be appointed as follows:
 - 1. Four shall be appointed by the Speaker of the House of Representatives as follows:
 - a. one shall be a member of the majority party of the House of Representatives with knowledge of human services issues,
 - b. one shall be a member of the minority party of the House of Representatives with knowledge of human services issues,
 - c. one shall be a representative of the social services nonprofit community, and
 - d. one shall be a member of the mental health and substance abuse services community;

1 2. Four shall be appointed by the President Pro Tempore of the Senate as follows: 2 3 one shall be a member of the majority party of the a. Senate with knowledge of human services issues, 4 5 one shall be a member of the minority party of the Senate with knowledge of human services issues, 6 7 C. one shall be a representative of the education community, and 8 9 d. one shall be a member of the juvenile justice community; and 10 11 3. Three shall be appointed by the Governor as follows: one shall be the Director of Human Services or a 12 a. designee, 13 b. one shall be the State Commissioner of Health or a 14 15 designee, and one shall be the Commissioner of Mental Health and 16 C. Substance Abuse Services or a designee. 17 Appointments to the Advisory Council shall be made by 18 September 1, 2015. Advisory Council members shall serve at the 19 pleasure of their appointing authorities. A vacancy on the Advisory 20 Council shall be filled by the original appointing authority. 21 The President Pro Tempore of the Senate and Speaker of the 22

House of Representatives shall each designate a cochair from among

the members of the Advisory Council. A majority of the members of

- 1 | the Advisory Council shall constitute a quorum to do business. The
- 2 | Senate and House of Representatives shall, at the discretion of the
- 3 | President Pro Tempore and the Speaker of the House of
- 4 Representatives, provide staff support to the Advisory Council as
- 5 | necessary to assist in the performance of its duties.
- 6 | F. The proceedings of all meetings of the Advisory Council
- 7 | shall comply with the provisions of the Oklahoma Open Meeting Act
- 8 and Oklahoma Open Records Act. Members of the Advisory Council
- 9 shall determine meeting dates.
- 10 G. The Advisory Council shall include an examination of the
- 11 | following in its assessment and recommendations:
- 12 1. State trends in the number of children who are homeless or
- 13 | are at risk of becoming homeless;
- 14 2. The state's role in providing services to children and youth
- 15 who are homeless or at risk for becoming homeless;
- 3. State policy regarding homeless children and youth; and
- 4. Existing services, resources, and capacity including, but
- 18 | not limited to, the availability of publicly or privately provided
- 19 resources to children and youth who are homeless or at risk of
- 20 becoming homeless.
- 21 H. The Advisory Council shall submit a report to the President
- 22 Pro Tempore of the Senate and Speaker of the House of
- 23 Representatives by September 1, 2016, describing assessment and
- 24 recommendations provided for by subsection G of this act.

SECTION 2. This act shall become effective July 1, 2015. SECTION 3. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
