15	SECTION 1. AMENDATORY 21 O.S. 2011, Section 1289.3, is
16	amended to read as follows:

18	DEFINITIONS FOR FIREARMS ACT
19	"Pistols" <u>or "handguns"</u> as used in the Oklahoma Firearms Act of
20	1971 <del>, Sections 1289.1 through 1289.17 of this title,</del> shall mean any
21	firearm capable of discharging a <del>projectile</del> <u>single or multiple</u>
22	projectiles from a single round of ammunition composed of any
23	material which may reasonably be expected to be able to cause lethal
24	injury, with a barrel or barrels less than sixteen (16) inches in

1 length, and using either gunpowder, gas or any means of rocket 2 propulsion a combustible propellant charge, but not to include flare guns, underwater fishing guns or blank pistols. 3 4

DEFINITIONS

- A. As used in the Oklahoma Self-Defense Act:
- "Concealed handgun" means a loaded or unloaded pistol, the presence of which is or handgun not openly discernible visible to the ordinary observation of a reasonable person;
- 2. "Unconcealed handgun" means a loaded or unloaded pistol or handgun carried upon the person in a belt holster or shoulder holster that is wholly or partially where the firearm is visible, or carried upon the person in using a scabbard, sling or case designed for carrying firearms that is wholly or partially visible; and
- "Pistol" or "handgun" means any derringer, revolver or semiautomatic firearm which:
  - has an overall barrel or barrels length of less than a. sixteen (16) inches,
  - is capable of discharging a projectile single or b. multiple projectiles from a single round of ammunition

1	composed of any material which may reasonably be
2	expected to be able to cause lethal injury,
3	c. <del>is designed to</del> <u>can</u> be held and fired by the use of <del>a</del>
4	single hand one or both hands, and
5	d. uses <del>either gunpowder, gas or any means of rocket</del>
6	propulsion a combustible propellant charge to
7	discharge propel the projectile or projectiles.
8	B. The definition of pistol or handgun for purposes of the
9	Oklahoma Self-Defense Act shall not apply to homemade or imitation
10	pistols, flare guns, underwater fishing guns or blank pistols.
11	SECTION 3. This act shall become effective November 1, 2016.
