5. Page 24, Line 1 through Line 2, by deleting all language and renumbering subsequent subsections.
6. Page 36, Line 18, after "11.", by deleting all language through Page 37, Line 4; and renumbering subsequent subsections.
7. Page 47, Line 24, by deleting the words "any employee of the Office of Juvenile Affairs or residential facility" and inserting in lieu thereof the words "certain state agency employees"
