Issue a verbal warning about the existence of the warrant</u> 15 <u>and further advise the defendant to contact the clerk of the court</u> 16 <u>for the purpose of resolving the outstanding warrant. All verbal</u> 17 <u>warnings shall be documented by the law enforcement officer on a</u> 18 department-issued warning ticket; or

19 <u>2. Take the defendant</u> before a magistrate of the county in 20 which the warrant was issued, who must admit the defendant to bail, 21 and immediately transmit the warrant, complaint, depositions, if 22 any, and undertaking, to the clerk of the court in which the 23 defendant is required to appear.
