

Senate Bill 1548

Sponsored by Senators MONNES ANDERSON, KRUSE; Senators DEMBROW, KNOPP, Representative GILLIAM
(Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Amends certain statutes that reference "physician" to include references to "physician assistant" and "nurse practitioner."

Takes effect July 1, 2014.

Be It Enacted by the People of the State of Oregon:

12 **SECTION 1.** ORS 3.450 is amended to read:

13 3.450. (1) As used in this section[,]:

14 (a) "Drug court program" means a program in which:

15 [(a)] (A) Individuals who are before the court obtain treatment for substance abuse issues and
16 report regularly to the court on the progress of their treatment; and

17 [(b)] (B) A local drug court team, consisting of the court, agency personnel and treatment and
18 service providers, monitors the individuals' participation in treatment.

19 (b) "**Individual-physician relationship**" includes a relationship between an individual and
20 a physician assistant or nurse practitioner.

21 (2)(a) The governing body of a county or a treatment provider may establish fees that individuals
22 participating in a drug court program may be required to pay for treatment and other services
23 provided as part of the drug court program.

24 (b) A court may order an individual participating in a drug court program to pay fees to par-
25 ticipate in the program. Fees imposed under this subsection may not be paid to the court.

26 (3) Records that are maintained by the circuit court specifically for the purpose of a drug court
27 program must be maintained separately from other court records. Records maintained by a circuit
28 court specifically for the purpose of a drug court program are confidential and may not be disclosed
29 except in accordance with regulations adopted under 42 U.S.C. 290dd-2, including under the cir-

1 cumstances described in subsections (4) to (7) of this section.

2 (4) If the individual who is the subject of the record gives written consent, a record described
 3 in subsection (3) of this section may be disclosed to members of the local drug court team in order
 4 to develop treatment plans, monitor progress in treatment and determine outcomes of participation
 5 in the drug court program.

6 (5) A record described in subsection (3) of this section may not be introduced into evidence in
 7 any legal proceeding other than the drug court program unless:

8 (a) The individual who is the subject of the record gives written consent for introduction of the
 9 record; or

10 (b) The court finds good cause for introduction. In determining whether good cause exists for
 11 purposes of this paragraph, the court shall weigh the public interest and the need for disclosure
 12 against the potential injury caused by the disclosure to:

13 (A) The individual who is the subject of the record;

14 (B) The individual-physician relationship; and

15 (C) The treatment services being provided to the individual who is the subject of the record.

16 (6) A court, the State Court Administrator, the Alcohol and Drug Policy Commission or the
 17 Oregon Criminal Justice Commission:

18 (a) May use records described in subsection (3) of this section and other drug court program
 19 information to track and develop statistics about the effectiveness, costs and other areas of public
 20 interest concerning drug court programs.

21 (b) May release statistics developed under paragraph (a) of this subsection and analyses based
 22 on the statistics to the public.

23 (7) Statistics and analyses released under subsection (6) of this section may not contain any in-
 24 formation that identifies an individual participant in a drug court program.

25 **SECTION 2.** ORS 30.302 is amended to read:

26 30.302. (1) As used in this section, [*retired physician*] "**retired provider**" means any person:

27 (a) Who holds a degree of Doctor of Medicine, Doctor of Osteopathy or Doctor of Podiatric
 28 Medicine, or who has met the minimum educational requirements for licensure to practice
 29 naturopathic medicine **or as a physician assistant under ORS 677.505 to 677.525 or a nurse**
 30 **practitioner under ORS 678.375 to 678.390;**

31 (b) Who has been licensed and is currently retired in accordance with the provisions of ORS
 32 chapter 677, **678** or 685;

33 (c) Who is registered with the Oregon Medical Board as a retired emeritus physician or who
 34 complies with the requirements of **the Oregon Medical Board as a retired physician assistant,**
 35 **the Oregon State Board of Nursing as a retired nurse practitioner** or the Oregon Board of
 36 Naturopathic Medicine as a retired naturopath;

37 (d) Who registers with the county health officer in the county in which the physician, **physician**
 38 **assistant, nurse practitioner** or naturopath practices; and

39 (e) Who provides medical care as a volunteer without compensation solely through referrals
 40 from the county health officer specified in paragraph (d) of this subsection.

41 (2) Any retired [*physician*] **provider** who treats patients pursuant to this section shall be con-
 42 sidered to be an agent of a public body for the purposes of ORS 30.260 to 30.300.

43 **SECTION 3.** ORS 30.800 is amended to read:

44 30.800. (1) As used in this section and ORS 30.805, "emergency medical assistance" means:

45 (a) Medical or dental care not provided in a place where emergency medical or dental care is

1 regularly available, including but not limited to a hospital, industrial first-aid station or [a
 2 *physician's or dentist's office*] **the office of a physician, physician assistant or dentist**, given
 3 voluntarily and without the expectation of compensation to an injured person who is in need of im-
 4 mediate medical or dental care and under emergency circumstances that suggest that the giving of
 5 assistance is the only alternative to death or serious physical aftereffects; or

6 (b) Medical care provided voluntarily in good faith and without expectation of compensation by
 7 a physician licensed [*by the Oregon Medical Board in the physician's*] **under ORS chapter 677, a**
 8 **physician assistant licensed under ORS 677.505 to 677.525 or a nurse practitioner licensed**
 9 **under ORS 678.375 to 678.390 and in the person's** professional capacity as a [*team physician*]
 10 **provider of health care for an athletic team** at a public or private school or college athletic
 11 event or as a volunteer [*physician*] **provider of health care** at other athletic events.

12 (2) No person may maintain an action for damages for injury, death or loss that results from acts
 13 or omissions of a person while rendering emergency medical assistance unless it is alleged and
 14 proved by the complaining party that the person was grossly negligent in rendering the emergency
 15 medical assistance.

16 (3) The giving of emergency medical assistance by a person does not, of itself, establish [*the re-*
 17 *lationship of physician and patient, dentist and patient or nurse and patient*] **a professional re-**
 18 **lationship** between the person giving the assistance and the person receiving the assistance insofar
 19 as the relationship carries with it any duty to provide or arrange for further medical care for the
 20 injured person after the giving of emergency medical assistance.

21 **SECTION 4.** ORS 30.802 is amended to read:

22 30.802. (1) As used in this section:

23 (a) "Automated external defibrillator" means an automated external defibrillator approved for
 24 sale by the federal Food and Drug Administration.

25 (b) "Public setting" means a location that is:

26 (A) Accessible to members of the general public, employees, visitors and guests, but that is not
 27 a private residence;

28 (B) A public school facility as defined in ORS 327.365;

29 (C) A health club as defined in ORS 431.680; or

30 (D) A place of public assembly as defined in ORS 431.690.

31 (2) A person may not bring a cause of action against another person for damages for injury,
 32 death or loss that result from acts or omissions involving the use, attempted use or nonuse of an
 33 automated external defibrillator when the other person:

34 (a) Used or attempted to use an automated external defibrillator;

35 (b) Was present when an automated external defibrillator was used or should have been used;

36 (c) Provided training in the use of an automated external defibrillator;

37 (d) Is a physician, **physician assistant licensed under ORS 677.505 to 677.525 or nurse**
 38 **practitioner licensed under ORS 678.375 to 678.390** and provided services related to the placement
 39 or use of an automated external defibrillator; or

40 (e) Possesses or controls one or more automated external defibrillators placed in a public set-
 41 ting.

42 (3) The immunity provided by this section does not apply if:

43 (a) The person against whom the action is brought acted with gross negligence or with reckless,
 44 wanton or intentional misconduct; or

45 (b) The use, attempted use or nonuse of an automated external defibrillator occurred at a lo-

1 cation where emergency medical care is regularly available.

2 (4) Nothing in this section affects the liability of a manufacturer, designer, developer, distributor
3 or supplier of an automated external defibrillator, or an accessory for an automated external
4 defibrillator, under the provisions of ORS 30.900 to 30.920 or any other applicable state or federal
5 law.

6 **SECTION 5.** ORS 87.555 is amended to read:

7 87.555. (1) Except as otherwise provided by law, whenever any person receives hospitalization
8 or medical treatment on account of any injury, and the person, or the personal representative of the
9 person after the death of the person, claims damages from the person causing the injury, then the
10 hospital or any physician licensed under ORS chapter 677, **physician assistant licensed under**
11 **ORS 677.505 to 677.525 or nurse practitioner licensed under ORS 678.375 to 678.390** who treats
12 the injured person in the hospital or who provides medical services shall have a lien upon any sum
13 awarded the injured person or the personal representative of the person by judgment or award or
14 obtained by a settlement or compromise to the extent of the amount due the hospital and the phy-
15 sician, **physician assistant or nurse practitioner** for the reasonable value of such medical treat-
16 ment rendered prior to the date of judgment, award, settlement or compromise. However, no such
17 lien shall be valid against anyone coming under the Workers' Compensation Act.

18 (2) When the injured person receiving hospitalization or medical care from a physician, **physi-**
19 **cian assistant or nurse practitioner** is the beneficiary of an insurance policy, including a policy
20 that provides personal injury protection coverage or similar no-fault medical insurance but exclud-
21 ing a health insurance policy, that provides for payment of such hospitalization and medical care,
22 both the hospital and physician, **physician assistant or nurse practitioner** shall have liens upon
23 the amount payable under the insurance policy. If a hospital or physician, **physician assistant or**
24 **nurse practitioner** has properly perfected a lien pursuant to ORS 87.565 (2), the insurer obligated
25 to make payment shall pay the sum due under the insurance policy directly to the hospital and
26 physician, **physician assistant or nurse practitioner** in the amount due each for services ren-
27 dered, and such payment shall constitute a release of the insurer making the payment to the extent
28 of the payment.

29 (3) When there are insufficient funds to satisfy in full the liens of all hospitals [*and*],
30 physicians, **physician assistants and nurse practitioners** claiming a lien created by this section,
31 the insurer making the payment shall prorate the available funds without regard to the sequence
32 of the filing of the notice of lien by the hospitals [*or*], physicians, **physician assistants or nurse**
33 **practitioners** and pay the hospitals [*or*], physicians, **physician assistants or nurse practitioners**
34 in proportion to the amount due each for services rendered.

35 **SECTION 6.** ORS 87.560 is amended to read:

36 87.560. (1) No lien under ORS 87.555 (1) shall be allowed:

37 (a) For hospitalization and treatment from a physician, **physician assistant or nurse practi-**
38 **tioner** rendered after a settlement has been effected by or on behalf of the party causing the injury;

39 (b) Against any sum for necessary attorney fees, costs and expenses incurred by the injured
40 party in securing a settlement, compromise, award or judgment; or

41 (c) For an amount payable for medical services under a policy that provides personal injury
42 protection coverage provided to an injured person prior to a hospital [*or*], physician, **physician**
43 **assistant or nurse practitioner** perfecting a lien under ORS 87.565 (2).

44 (2) This section does not preclude a hospital [*or*], a physician licensed under ORS chapter 677,
45 **physician assistant licensed under ORS 677.505 to 677.525 or nurse practitioner licensed under**

1 **ORS 678.375 to 678.390** from perfecting a lien under ORS 87.555.

2 **SECTION 7.** ORS 87.565 is amended to read:

3 87.565. (1) In order to perfect a lien under ORS 87.555 (1), a hospital, an owner or operator of
4 a hospital *[or]*, a physician, **a physician assistant or a nurse practitioner** shall:

5 (a) Not later than 30 days after the discharge of the patient from the hospital, file a notice of
6 lien substantially in the form prescribed in ORS 87.570, containing a statement of the amount
7 claimed, with the recording officer of the county wherein such hospital is located; and

8 (b) Prior to the date of judgment, award, settlement or compromise, serve a certified copy of the
9 notice of lien by registered or certified mail upon:

10 (A) The person alleged to be responsible for causing the injury and from whom damages are or
11 may be claimed or to the last-known address of the person; or

12 (B) The insurance carrier that has insured the person alleged to be responsible, if such insur-
13 ance carrier is known.

14 (2) In order to perfect a lien under ORS 87.555 (2), a hospital, an owner or operator of a hospital
15 *[or]*, a physician, **a physician assistant or a nurse practitioner** shall:

16 (a) Not later than 30 days after the discharge of the patient from the hospital, file a notice of
17 lien substantially in the form prescribed in ORS 87.570, containing a statement of the amount
18 claimed, with the recording officer of the county wherein such hospital is located; and

19 (b) Serve a certified copy of the notice of lien by certified mail upon the insurance company that
20 is obligated to make payment for hospitalization and medical services.

21 **SECTION 8.** ORS 87.575 is amended to read:

22 87.575. Each recording officer shall maintain a *[hospital and physician]* lien docket in which,
23 upon the filing of a notice of lien, the recording officer shall enter the name of the injured person,
24 the approximate date of the hospitalization services or medical treatment, the name and address of
25 the hospital filing the notice and the amount claimed and the name and address of the physician,
26 **physician assistant or nurse practitioner** filing the notice and the amount claimed. The recording
27 officer shall make an index thereto in the names of the injured persons.

28 **SECTION 9.** ORS 87.581 is amended to read:

29 87.581. (1) A person or insurer shall be liable to a hospital and physician, **physician assistant**
30 **or nurse practitioner** for the reasonable value of hospitalization services and medical treatment
31 rendered out of the moneys due under any payment, award, judgment, settlement or compromise,
32 after paying the attorney fees, costs and expenses incurred in connection therewith, or the propor-
33 tion of that amount as determined under ORS 87.555 (3), if the person or insurer:

34 (a) Has received a notice of lien that complies with ORS 87.565;

35 (b) Has not paid the hospital and physician, **physician assistant or nurse practitioner** the
36 reasonable value of hospitalization services and medical treatment that the hospital and physician,
37 **physician assistant or nurse practitioner** rendered; and

38 (c) Pays moneys to the injured person, the heirs or personal representative of the injured person,
39 the attorney for the injured person or for the heirs or personal representative of the injured person,
40 or a person not claiming a valid lien under ORS 87.555, as compensation for the injury suffered or
41 as payment for the costs of hospitalization services or medical treatment incurred by the injured
42 person.

43 (2) An action arising under subsection (1) of this section shall be commenced within 180 days
44 after the date of payment under subsection (1)(c) of this section.

45 **SECTION 10.** ORS 87.623 is amended to read:

1 87.623. The recording officer of the county shall record the notices filed under ORS 87.613 in the
2 [hospital] lien docket maintained under ORS 87.575.

3 **SECTION 11.** ORS 109.640 is amended to read:

4 109.640. (1) Any physician, **physician assistant licensed under ORS 677.505 to 677.525** or
5 nurse practitioner **licensed under ORS 678.375 to 678.390** may provide birth control information
6 and services to any person without regard to the age of the person.

7 (2) A minor 15 years of age or older may give consent, without the consent of a parent or
8 guardian of the minor, to:

9 (a) Hospital care, medical or surgical diagnosis or treatment by a physician licensed by the
10 Oregon Medical Board, and dental or surgical diagnosis or treatment by a dentist licensed by the
11 Oregon Board of Dentistry, except as provided by ORS 109.660.

12 **(b) Diagnosis or treatment by a physician assistant who is licensed under ORS 677.505 to**
13 **677.525 and who is acting pursuant to a practice agreement as defined in ORS 677.495.**

14 [(b)] (c) Diagnosis and treatment by a nurse practitioner who is licensed by the Oregon State
15 Board of Nursing under ORS 678.375 and who is acting within the scope of practice for a nurse
16 practitioner.

17 [(c)] (d) Except when the minor is obtaining contact lenses for the first time, diagnosis and
18 treatment by an optometrist who is licensed by the Oregon Board of Optometry under ORS 683.010
19 to 683.340 and who is acting within the scope of practice for an optometrist.

20 **SECTION 12.** ORS 109.650 is amended to read:

21 109.650. A hospital or any physician, **physician assistant**, nurse practitioner, dentist or
22 optometrist described in ORS 109.640 may advise a parent or legal guardian of a minor of the care,
23 diagnosis or treatment of the minor or the need for any treatment of the minor, without the consent
24 of the minor, and is not liable for advising the parent or legal guardian without the consent of the
25 minor.

26 **SECTION 13.** ORS 109.675 is amended to read:

27 109.675. (1) A minor 14 years of age or older may obtain, without parental knowledge or consent,
28 outpatient diagnosis or treatment of a mental or emotional disorder or a chemical dependency, ex-
29 cluding methadone maintenance, by a physician **or physician assistant** licensed by the Oregon
30 Medical Board, a psychologist licensed by the State Board of Psychologist Examiners, a nurse
31 practitioner registered by the Oregon State Board of Nursing, a clinical social worker licensed by
32 the State Board of Licensed Social Workers, a professional counselor or marriage and family ther-
33 apist licensed by the Oregon Board of Licensed Professional Counselors and Therapists or a com-
34 munity mental health program established and operated pursuant to ORS 430.620 when approved to
35 do so by the Oregon Health Authority pursuant to rule.

36 (2) However, the person providing treatment shall have the parents of the minor involved before
37 the end of treatment unless the parents refuse or unless there are clear clinical indications to the
38 contrary, which shall be documented in the treatment record. The provisions of this subsection do
39 not apply to:

40 (a) A minor who has been sexually abused by a parent; or

41 (b) An emancipated minor, whether emancipated under the provisions of ORS 109.510 and
42 109.520 or 419B.550 to 419B.558 or, for the purpose of this section only, emancipated by virtue of
43 having lived apart from the parents or legal guardian while being self-sustaining for a period of 90
44 days prior to obtaining treatment as provided by this section.

45 **SECTION 14.** ORS 109.680 is amended to read:

1 109.680. A physician, **physician assistant**, psychologist, nurse practitioner, clinical social
 2 worker licensed under ORS 675.530, professional counselor or marriage and family therapist licensed
 3 by the Oregon Board of Licensed Professional Counselors and Therapists or community mental
 4 health program described in ORS 109.675 may advise the parent or parents or legal guardian of any
 5 minor described in ORS 109.675 of the diagnosis or treatment whenever the disclosure is clinically
 6 appropriate and will serve the best interests of the minor's treatment because the minor's condition
 7 has deteriorated or the risk of a suicide attempt has become such that inpatient treatment is nec-
 8 essary, or the minor's condition requires detoxification in a residential or acute care facility. If such
 9 disclosure is made, the physician, **physician assistant**, psychologist, nurse practitioner, clinical so-
 10 cial worker licensed under ORS 675.530, professional counselor or marriage and family therapist li-
 11 censed by the Oregon Board of Licensed Professional Counselors and Therapists or community
 12 mental health program shall not be subject to any civil liability for advising the parent, parents or
 13 legal guardian without the consent of the minor.

14 **SECTION 15.** ORS 109.685 is amended to read:

15 109.685. A physician, **physician assistant**, psychologist, nurse practitioner, clinical social
 16 worker licensed under ORS 675.530, professional counselor or marriage and family therapist licensed
 17 by the Oregon Board of Licensed Professional Counselors and Therapists or community mental
 18 health program described in ORS 109.675 who in good faith provides diagnosis or treatment to a
 19 minor as authorized by ORS 109.675 shall not be subject to any civil liability for providing such di-
 20 agnosis or treatment without consent of the parent or legal guardian of the minor.

21 **SECTION 16.** ORS 127.700 is amended to read:

22 127.700. As used in ORS 127.700 to 127.737:

23 (1) "Attending physician" shall have the same meaning as provided in ORS 127.505.

24 (2) "Attorney-in-fact" means an adult validly appointed under ORS 127.540, 127.700 to 127.737
 25 and 426.385 to make mental health treatment decisions for a principal under a declaration for mental
 26 health treatment and also means an alternative attorney-in-fact.

27 (3) "Declaration" means a document making a declaration of preferences or instructions re-
 28 garding mental health treatment.

29 (4) "Health care facility" shall have the same meaning as provided in ORS 127.505.

30 (5) "Incapable" means that, in the opinion of the court in a protective proceeding under ORS
 31 chapter 125, or the opinion of two physicians, a person's ability to receive and evaluate information
 32 effectively or communicate decisions is impaired to such an extent that the person currently lacks
 33 the capacity to make mental health treatment decisions.

34 (6) "Mental health treatment" means convulsive treatment, treatment of mental illness with
 35 psychoactive medication, admission to and retention in a health care facility for a period not to
 36 exceed 17 days for care or treatment of mental illness, and outpatient services.

37 (7) "Outpatient services" means treatment for a mental or emotional disorder that is obtained
 38 by appointment and is provided by an outpatient service as defined in ORS 430.010.

39 (8) "Provider" means a mental health treatment provider, **a physician assistant licensed under**
 40 **ORS 677.505 to 677.525 or a nurse practitioner licensed under ORS 678.375 to 678.390.**

41 (9) "Representative" means "attorney-in-fact" as defined in this section.

42 **SECTION 17.** ORS 127.710 is amended to read:

43 127.710. A declaration becomes operative when it is delivered to the principal's physician or
 44 other [*mental health treatment*] provider and remains valid until revoked or expired. The physician
 45 or provider shall act in accordance with an operative declaration when the principal has been found

1 to be incapable. The physician or provider shall continue to obtain the principal's informed consent
 2 to all mental health treatment decisions if the principal is capable of providing informed consent or
 3 refusal.

4 **SECTION 18.** ORS 127.722 is amended to read:

5 127.722. A declaration may be revoked in whole or in part at any time by the principal if the
 6 principal is not incapable. A revocation is effective when a capable principal communicates the re-
 7 vocation to the attending physician or other provider. The attending physician or other provider
 8 shall note the revocation as part of the principal's medical record.

9 **SECTION 19.** ORS 127.727 is amended to read:

10 127.727. (1) None of the following may serve as attorney-in-fact:

11 (a) The attending physician or [*mental health service*] provider or an employee of the physician
 12 or provider, if the physician, provider or employee is unrelated to the principal by blood, marriage
 13 or adoption.

14 (b) An owner, operator or employee of a health care facility in which the principal is a patient
 15 or resident, if the owner, operator or employee is unrelated to the principal by blood, marriage or
 16 adoption.

17 (c) A person who is the principal's parent, guardian or former guardian if:

18 (A) At any time while the principal was under the care, custody or control of the person, a court
 19 entered an order:

20 (i) Taking the principal into protective custody under ORS 419B.150; or

21 (ii) Committing the principal to the legal custody of the Department of Human Services for care,
 22 placement and supervision under ORS 419B.337; and

23 (B) The court entered a subsequent order that:

24 (i) The principal should be permanently removed from the person's home, or continued in sub-
 25 stitute care, because it was not safe for the principal to be returned to the person's home, and no
 26 subsequent order of the court was entered that permitted the principal to return to the person's
 27 home before the principal's wardship was terminated under ORS 419B.328; or

28 (ii) Terminated the person's parental rights under ORS 419B.500 and 419B.502 to 419B.524.

29 (4) A principal, while not incapable, may petition the court to remove a prohibition contained
 30 in subsection (1)(c) of this section.

31 **SECTION 20.** ORS 127.730 is amended to read:

32 127.730. None of the following may serve as a witness to the signing of a declaration:

33 (1) The attending physician or [*mental health service*] provider or a relative of the physician or
 34 provider;

35 (2) An owner, operator or relative of an owner or operator of a health care facility in which the

39 135.139. (1) When a person has been charged with a crime in which it appears from the nature
 40 of the charge that the transmission of body fluids from one person to another may have been in-
 41 volved, the district attorney, upon the request of the victim or the parent or guardian of a minor
 42 or incapacitated victim, shall seek the consent of the person charged to submit to a test for HIV
 43 and any other communicable disease. In the absence of such consent or failure to submit to the test,
 44 the district attorney may petition the court for an order requiring the person charged to submit to
 45 a test for HIV and any other communicable disease.

1 (2)(a) At the time of an appearance before a circuit court judge on a criminal charge, the judge

26 a contagious or communicable disease that poses an imminent threat to the health of other persons
27 in the facility. However, prescription medication may not be administered except upon a written
28 prescription or written order by [*a licensed physician or licensed dentist and administered by a li-*
29 *icensed physician, licensed dentist or other medical personnel authorized by the State of Oregon under*
30 *ORS chapter 677, 678 or 679*] **a physician licensed under ORS chapter 677, physician assistant**

33 (35) "Vital statistics" means the aggregated data derived from records and reports of live birth,
34 death, fetal death, induced termination of pregnancy, marriage, declaration of domestic partnership,
35 dissolution of marriage, dissolution of domestic partnership and supporting documentation and re-

 35 the time of the accident.

36 (B) A hit-and-run vehicle.

37 (C) A phantom vehicle.

38 (D) A stolen vehicle.

39 (E) A vehicle that is owned or operated by a self-insurer:

40 (i) That is not in compliance with ORS 806.130 (1)(c); or

41 (ii) That provides recovery to an insured in an amount that is less than the limits for uninsured
 42 motorist coverage of the insured.

43 (L) "Uninsured vehicle" does not include:

44 (A) An insured vehicle, unless the vehicle is a stolen vehicle;

45 (B) Except as provided in paragraph (k)(E) of this subsection, a vehicle that is owned or oper-

1 ated by a self-insurer within the meaning of any motor vehicle financial responsibility law, motor
2 carrier law or any similar law;

3 (C) A vehicle that is owned by the United States of America, Canada, a state, a political sub-
4 division of any such government or an agency of any such government;

5 (D) A land motor vehicle or trailer, if operated on rails or crawler-treads or while located for
6 use as a residence or premises and not as a vehicle;

7 (E) A farm-type tractor or equipment designed for use principally off public roads, except while
8 actually upon public roads; or

9 (F) A vehicle owned by or furnished for the regular or frequent use of the insured or any
10 member of the household of the insured.

11 (m) "Vehicle" means every device in, upon or by which any person or property is or may be
12 transported or drawn upon a public highway, but does not include devices moved by human power
13 or used exclusively upon stationary rails or tracks.

14 (3) This coverage applies only to accidents that occur on and after the effective date of the
15 policy, during the policy period and within the United States of America, its territories or pos-
16 sessions, or Canada.

17 (4)(a) This coverage does not apply to bodily injury of an insured with respect to which the in-
18 sured or the legal representative of the insured shall, without the written consent of the insurer,
19 make any settlement with or prosecute to judgment any action against any person or organization
20 who may be legally liable therefor.

21 (b) This coverage does not apply to bodily injury to an insured while occupying a vehicle, other
22 than an insured vehicle, owned by, or furnished for the regular use of, the named insured or any
23 relative resident in the same household, or through being struck by the vehicle.

24 (c) This coverage does not apply so as to inure directly or indirectly to the benefit of any
25 workers' compensation carrier, any person or organization qualifying as a self-insurer under any
26 workers' compensation or disability benefits law or any similar law or the State Accident Insurance
27 Fund Corporation.

28 (d) This coverage does not apply with respect to underinsured motorist benefits unless:

29 (A) The limits of liability under any bodily injury liability insurance applicable at the time of
30 the accident regarding the injured person have been exhausted by payment of judgments or settle-
31 ments to the injured person or other injured persons;

32 (B) The described limits have been offered in settlement, the insurer has refused consent under
33 paragraph (a) of this subsection and the insured protects the insurer's right of subrogation to the
34 claim against the tortfeasor;

35 (C) The insured gives credit to the insurer for the unrealized portion of the described liability
36 limits as if the full limits had been received if less than the described limits have been offered in
37 settlement, and the insurer has consented under paragraph (a) of this subsection; or

38 (D) The insured gives credit to the insurer for the unrealized portion of the described liability
39 limits as if the full limits had been received if less than the described limits have been offered in
40 settlement and, if the insurer has refused consent under paragraph (a) of this subsection, the insured
41 protects the insurer's right of subrogation to the claim against the tortfeasor.

42 (e) When seeking consent under paragraph (a) or (d) of this subsection, the insured shall allow
43 the insurer a reasonable time in which to collect and evaluate information related to consent to the
44 proposed offer of settlement. The insured shall provide promptly to the insurer any information that
45 is reasonably requested by the insurer and that is within the custody and control of the insured.

1 Consent will be presumed to be given if the insurer does not respond within a reasonable time. For
2 purposes of this paragraph, a “reasonable time” is no more than 30 days from the insurer’s receipt
3 of a written request for consent, unless the insured and the insurer agree otherwise.

4 (5)(a) As soon as practicable, the insured or other person making claim shall give to the insurer
5 written proof of claim, under oath if required, including full particulars of the nature and extent of
6 the injuries, treatment and other details entering into the determination of the amount payable
7 hereunder. The insured and every other person making claim hereunder shall submit to examinations
8 under oath by any person named by the insurer and subscribe the same, as often as may reasonably
9 be required. Proof of claim shall be made upon forms furnished by the insurer unless the insurer fails
10 to furnish the forms within 15 days after receiving notice of claim.

11 (b) Upon reasonable request of and at the expense of the insurer, the injured person shall submit
12 to physical examinations by physicians, **physician assistants or nurse practitioners** selected by
13 the insurer and shall, upon each request from the insurer, execute authorization to enable the
14 insurer to obtain medical reports and copies of records.

15 (6) If, before the insurer makes payment of loss hereunder, the insured or the legal represen-
16 tative of the insured institutes any legal action for bodily injury against any person or organization
17 legally responsible for the use of a vehicle involved in the accident, a copy of the summons and
18 complaint or other process served in connection with the legal action shall be forwarded imme-
19 diately to the insurer by the insured or the legal representative of the insured.

20 (7)(a) The limit of liability stated in the declarations as applicable to “each person” is the limit
21 of the insurer’s liability for all damages because of bodily injury sustained by one person as the
22 result of any one accident and, subject to the above provision respecting each person, the limit of
23 liability stated in the declarations as applicable to “each accident” is the total limit of the
24 company’s liability for all damages because of bodily injury sustained by two or more persons as the
25 result of any one accident.

26 (b) Any payment made under this coverage to or for an insured shall be applied in reduction
27 of any amount that the insured may be entitled to recover from any person who is an insured under
28 the bodily injury liability coverage of this policy.

29 (c) Any amount payable under the terms of this coverage because of bodily injury sustained in
30 an accident by a person who is an insured under this coverage shall be reduced by:

31 (A) All sums paid on account of the bodily injury by or on behalf of the owner or operator of
32 the uninsured vehicle and by or on behalf of any other person or organization jointly or severally
33 liable together with the owner or operator for the bodily injury, including all sums paid under the
34 bodily injury liability coverage of the policy; and

35 (B) The amount paid and the present value of all amounts payable on account of the bodily in-
36 jury under any workers’ compensation law, disability benefits law or any similar law.

37 (d) Any amount payable under the terms of this coverage because of bodily injury sustained in
38 an accident by a person who is an insured under this coverage shall be reduced by the credit given
39 to the insurer pursuant to subsection (4)(d)(C) or (D) of this section.

40 (e) The amount payable under the terms of this coverage may not be reduced by the amount of
41 liability proceeds offered, described in subsection (4)(d)(B) or (D) of this section, that has not been
42 paid to the injured person. If liability proceeds have been offered and not paid, the amount payable
43 under the terms of the coverage shall include the amount of liability limits offered but not accepted
44 due to the insurer’s refusal to consent. The insured shall cooperate so as to permit the insurer to
45 proceed by subrogation or assignment to prosecute the claim against the uninsured motorist.

1 (8) No action shall lie against the insurer unless, as a condition precedent thereto, the insured
 2 or the legal representative of the insured has fully complied with all the terms of this policy.

3 (9)(a) With respect to bodily injury to an insured:

4 (A) While occupying a vehicle owned by a named insured under this coverage, the insurance
 5 under this coverage is primary.

6 (B) While occupying a vehicle not owned by a named insured under this coverage, the insurance
 7 under this coverage shall apply only as excess insurance over any primary insurance available to
 8 the occupant that is similar to this coverage, and this excess insurance shall then apply only in the
 9 amount by which the applicable limit of liability of this excess coverage exceeds the sum of the
 10 applicable limits of liability of all primary insurance available to the occupant.

11 (b) If an insured is an insured under other primary or excess insurance available to the insured
 12 that is similar to this coverage, then the insured's damages are deemed not to exceed the higher of
 13 the applicable limits of liability of this insurance or the additional primary or excess insurance
 14 available to the insured, and the insurer is not liable under this coverage for a greater proportion
 15 of the insured's damages than the applicable limit of liability of this coverage bears to the sum of
 16 the applicable limits of liability of this insurance and other primary or excess insurance available
 17 to the insured.

18 (c) With respect to bodily injury to an insured while occupying any motor vehicle used as a
 19 public or livery conveyance, the insurance under this coverage shall apply only as excess insurance
 20 over any other insurance available to the insured that is similar to this coverage, and this insurance
 21 shall then apply only in the amount by which the applicable limit of liability of this coverage ex-
 22 ceeds the sum of the applicable limits of liability of all other insurance.

23 (10) If any person making claim hereunder and the insurer do not agree that the person is le-
 24 gally entitled to recover damages from the owner or operator of an uninsured vehicle because of
 25 bodily injury to the insured, or do not agree as to the amount of payment that may be owing under
 26 this coverage, then, in the event the insured and the insurer elect by mutual agreement at the time
 27 of the dispute to settle the matter by arbitration, the arbitration shall take place as described in
 28 ORS 742.505. Any judgment upon the award rendered by the arbitrators may be entered in any court
 29 having jurisdiction thereof, provided, however, that the costs to the insured of the arbitration pro-
 30 ceeding do not exceed \$100 and that all other costs of arbitration are borne by the insurer.
 31 "Costs" as used in this provision does not include attorney fees or expenses incurred in the pro-
 32 duction of evidence or witnesses or the making of transcripts of the arbitration proceedings. The
 33 person and the insurer each agree to consider themselves bound and to be bound by any award made
 34 by the arbitrators pursuant to this coverage in the event of such election. At the election of the
 35 insured, the arbitration shall be held:

36 (a) In the county and state of residence of the insured;

37 (b) In the county and state where the insured's cause of action against the uninsured motorist
 38 arose; or

39 (c) At any other place mutually agreed upon by the insured and the insurer.

40 (11) In the event of payment to any person under this coverage:

41 (a) The insurer shall be entitled to the extent of the payment to the proceeds of any settlement
 42 or judgment that may result from the exercise of any rights of recovery of the person against any
 43 uninsured motorist legally responsible for the bodily injury because of which payment is made;

44 (b) The person shall hold in trust for the benefit of the insurer all rights of recovery that the
 45 person shall have against such other uninsured person or organization because of the damages that

1 are the subject of claim made under this coverage, but only to the extent that the claim is made or
2 paid herein;

3 (c) If the insured is injured by the joint or concurrent act or acts of two or more persons, one
4 or more of whom is uninsured, the insured shall have the election to receive from the insurer any
5 payment to which the insured would be entitled under this coverage by reason of the act or acts
6 of the uninsured motorist, or the insured may, with the written consent of the insurer, proceed with
7 legal action against any or all persons claimed to be liable to the insured for the injuries. If the
8 insured elects to receive payment from the insurer under this coverage, then the insured shall hold
9 in trust for the benefit of the insurer all rights of recovery the insured shall have against any other
10 person, firm or organization because of the damages that are the subject of claim made under this
11 coverage, but only to the extent of the actual payment made by the insurer;

12 (d) The person shall do whatever is proper to secure and shall do nothing after loss to prejudice
13 such rights;

14 (e) If requested in writing by the insurer, the person shall take, through any representative not
15 in conflict in interest with the person, designated by the insurer, such action as may be necessary
16 or appropriate to recover payment as damages from such other uninsured person or organization,
17 such action to be taken in the name of the person, but only to the extent of the payment made
18 hereunder. In the event of a recovery, the insurer shall be reimbursed out of the recovery for ex-
19 penses, costs and attorney fees incurred by the insurer in connection therewith; and

20 (f) The person shall execute and deliver to the insurer any instruments and papers as may be
21 appropriate to secure the rights and obligations of the person and the insurer established by this
22 provision.

23 (12)(a) The parties to this coverage agree that no cause of action shall accrue to the insured
24 under this coverage unless within two years from the date of the accident:

25 (A) Agreement as to the amount due under the policy has been concluded;

26 (B) The insured or the insurer has formally instituted arbitration proceedings;

27 (C) The insured has filed an action against the insurer; or

28 (D) Suit for bodily injury has been filed against the uninsured motorist and, within two years
29 from the date of settlement or final judgment against the uninsured motorist, the insured has
30 formally instituted arbitration proceedings or filed an action against the insurer.

31 (b) For purposes of this subsection:

32 (A) "Date of settlement" means the date on which a written settlement agreement or release is
33 signed by an insured or, in the absence of these documents, the date on which the insured or the
34 attorney for the insured receives payment of any sum required by the settlement agreement. An
35 advance payment as defined in ORS 31.550 shall not be deemed a payment of a settlement for pur-
36 poses of the time limitation in this subsection.

37 (B) "Final judgment" means a judgment that has become final by lapse of time for appeal or by
38 entry in an appellate court of an appellate judgment.

39 **SECTION 78.** ORS 743.531 is amended to read:

40 743.531. (1) A group health insurance policy may on request by the group policyholder provide
41 that all or any portion of any indemnities provided by such policy on account of hospital, nursing,
42 medical or surgical services may, at the insurer's option, be paid directly to the hospital or person
43 rendering such services. However, the amount of any such payment shall not exceed the amount of
44 benefit provided by the policy with respect to the service or billing of the provider of aid. The
45 amount of such payments pursuant to one or more assignments shall not exceed the amount of ex-

1 penses incurred on account of such hospitalization or medical or surgical aid.

2 (2) Nothing in this section is intended to authorize an insurer to:

3 (a) Furnish or [*provide*] directly **provide the** services of hospitals [*or physicians and surgeons*],
4 **physicians licensed under ORS chapter 677, physician assistants licensed under ORS 677.505**
5 **to 677.525 or nurse practitioners licensed under ORS 678.375 to 378.390;** or

6 (b) Direct, participate in or control the selection of the specific hospital [*or physician and sur-*
7 *geon*], **physician, physician assistant or nurse practitioner** from whom the insured secures ser-
8 vices or who exercises medical or dental professional judgment.

9 (3) Nothing in subsection (2) of this section prevents an insurer from negotiating and entering
10 into contracts for alternative rates of payment with providers and offering the benefit of such al-
11 ternative rates to insureds who select such providers. An insurer may utilize such contracts by of-
12 fering a choice of plans at the time an insured enrolls, one of which provides benefits only for
13 services by members of a particular provider organization with whom the insurer has an agreement.
14 If an insured chooses such a plan, benefits are payable only for services rendered by a member of
15 that provider organization, unless such services were requested by a member of such organization
16 or are rendered as the result of an emergency.

17 (4) Payment so made shall discharge the insurer's obligation with respect to the amount of in-

44 erwise specifically authorized by statute which, in the opinion of the director, are unjust, unfair or
45 unfairly discriminatory to any person insured or proposed for coverage under a Medicare supple-

13 (b) "Originating site" means the physical location of the patient receiving a telemedical health

15 (c) "Telemedical" means delivered through a two-way video communication that allows a health
 16 professional to interact with a patient who is at an originating site.

 43 audiologist if an enrollee elects to purchase a hearing aid priced higher than the benefit amount by
 44 paying the difference between the benefit amount and the price of the hearing aid.

45 (4) A health benefit plan may subject the payment, coverage or reimbursement required under

1 this section to provisions of the plan that apply to other durable medical equipment benefits covered
 2 by the plan, including but not limited to provisions relating to deductibles, coinsurance and prior
 3 authorization.

4 (5) This section is exempt from ORS 743A.001.

5 **SECTION 86.** ORS 743A.168 is amended to read:

6 743A.168. A group health insurance policy providing coverage for hospital or medical expenses
 7 shall provide coverage for expenses arising from treatment for chemical dependency, including
 8 alcoholism, and for mental or nervous conditions at the same level as, and subject to limitations no
 9 more restrictive than, those imposed on coverage or reimbursement of expenses arising from treat-
 10 ment for other medical conditions. The following apply to coverage for chemical dependency and for
 11 mental or nervous conditions:

12 (1) As used in this section:

13 (a) "Chemical dependency" means the addictive relationship with any drug or alcohol charac-
 14 terized by a physical or psychological relationship, or both, that interferes on a recurring basis with
 15 the individual's social, psychological or physical adjustment to common problems. For purposes of
 16 this section, "chemical dependency" does not include addiction to, or dependency on, tobacco, to-
 17 bacco products or foods.

18 (b) "Facility" means a corporate or governmental entity or other provider of services for the
 19 treatment of chemical dependency or for the treatment of mental or nervous conditions.

20 (c) "Group health insurer" means an insurer, a health maintenance organization or a health care
 21 service contractor.

22 (d) "Program" means a particular type or level of service that is organizationally distinct within
 23 a facility.

24 (e) "Provider" means a person that:

25 (A) Has met the credentialing requirement of a group health insurer, is otherwise eligible to
 26 receive reimbursement for coverage under the policy and is:

27 (i) A health facility as defined in ORS 430.010;

28 (ii) A residential facility as defined in ORS 430.010;

29 (iii) A day or partial hospitalization program as defined in ORS 430.010;

30 (iv) An outpatient service as defined in ORS 430.010; or

31 (v) An individual behavioral health or medical professional licensed or certified under Oregon
 32 law; or

33 (B) Is a provider organization certified by the Oregon Health Authority under subsection (13)
 34 of this section.

35 (2) The coverage may be made subject to provisions of the policy that apply to other benefits
 36 under the policy, including but not limited to provisions relating to deductibles and coinsurance.
 37 Deductibles and coinsurance for treatment in health facilities or residential facilities may not be
 38 greater than those under the policy for expenses of hospitalization in the treatment of other medical
 39 conditions. Deductibles and coinsurance for outpatient treatment may not be greater than those
 40 under the policy for expenses of outpatient treatment of other medical conditions.

41 (3) The coverage may not be made subject to treatment limitations, limits on total payments for
 42 treatment, limits on duration of treatment or financial requirements unless similar limitations or
 43 requirements are imposed on coverage of other medical conditions. The coverage of eligible expenses
 44 may be limited to treatment that is medically necessary as determined under the policy for other
 45 medical conditions.

1 (4)(a) Nothing in this section requires coverage for:

2 (A) Educational or correctional services or sheltered living provided by a school or halfway
3 house;

4 (B) A long-term residential mental health program that lasts longer than 45 days;

5 (C) Psychoanalysis or psychotherapy received as part of an educational or training program,
6 regardless of diagnosis or symptoms that may be present; or

7 (D) A court-ordered sex offender treatment program.

8 (b) Notwithstanding paragraph (a)(A) of this subsection, an insured may receive covered outpa-
9 tient services under the terms of the insured's policy while the insured is living temporarily in a
10 sheltered living situation.

11 (5) A provider is eligible for reimbursement under this section if:

12 (a) The provider is approved or certified by the Oregon Health Authority;

13 (b) The provider is accredited for the particular level of care for which reimbursement is being
14 requested by the Joint Commission on Accreditation of Hospitals or the Commission on Accredi-
15 tation of Rehabilitation Facilities;

16 (c) The patient is staying overnight at the facility and is involved in a structured program at
17 least eight hours per day, five days per week; or

18 (d) The provider is providing a covered benefit under the policy.

19 (6) Payments may not be made under this section for support groups.

20 (7) If specified in the policy, outpatient coverage may include follow-up in-home service or out-
21 patient services. The policy may limit coverage for in-home service to persons who are homebound
22 under the care of a physician, **physician assistant licensed under ORS 677.505 to 677.525 or**
23 **nurse practitioner licensed under ORS 678.375 to 678.390.**

24 (8) Nothing in this section prohibits a group health insurer from managing the provision of
25 benefits through common methods, including but not limited to selectively contracted panels, health
26 plan benefit differential designs, preadmission screening, prior authorization of services, utilization
27 review or other mechanisms designed to limit eligible expenses to those described in subsection (3)
28 of this section.

29 (9) The Legislative Assembly has found that health care cost containment is necessary and in-
30 tends to encourage insurance policies designed to achieve cost containment by ensuring that re-
31 imbursement is limited to appropriate utilization under criteria incorporated into such policies,
32 either directly or by reference.

33 (10)(a) Subject to the patient or client confidentiality provisions of ORS 40.235 relating to phy-
34 sicians, ORS 40.240 relating to nurse practitioners, ORS 40.230 relating to psychologists, ORS 40.250
35 and 675.580 relating to licensed clinical social workers and ORS 40.262 relating to licensed profes-
36 sional counselors and licensed marriage and family therapists, a group health insurer may provide
37 for review for level of treatment of admissions and continued stays for treatment in health facilities,

43 (c) Review shall be performed by or under the direction of a medical or osteopathic physician
44 licensed by the Oregon Medical Board, **a physician assistant licensed by the Oregon Medical**
45 **Board, a nurse practitioner licensed by the Oregon State Board of Nursing,** a psychologist li-

1 censed by the State Board of Psychologist Examiners, a clinical social worker licensed by the State
2 Board of Licensed Social Workers or a professional counselor or marriage and family therapist li-
3 censed by the Oregon Board of Licensed Professional Counselors and Therapists, in accordance with
4 standards of the National Committee for Quality Assurance or Medicare review standards of the

6 (d) Review may involve prior approval, concurrent review of the continuation of treatment,
7 post-treatment review or any combination of these. However, if prior approval is required, provision
8 shall be made to allow for payment of urgent or emergency admissions, subject to subsequent re-
9 view. If prior approval is not required, group health insurers shall permit providers, policyholders
10 or persons acting on their behalf to make advance inquiries regarding the appropriateness of a
11 particular admission to a treatment program. Group health insurers shall provide a timely response
12 to such inquiries. Noncontracting providers must cooperate with these procedures to the same ex-
13 tent as contracting providers to be eligible for reimbursement.

14 (11) Health maintenance organizations may limit the receipt of covered services by enrollees to
15 services provided by or upon referral by providers contracting with the health maintenance organ-
16 ization. Health maintenance organizations and health care service contractors may create substan-
17 tive plan benefit and reimbursement differentials at the same level as, and subject to limitations no

41 or both, to be imposed on any provider organization that applies for certification under subsection

45 (16) The intent of the Legislative Assembly in adopting this section is to reserve benefits for

1 different types of care to encourage cost effective care and to ensure continuing access to levels

 11 or reimbursement of at least \$500 for a tobacco use cessation program for a person enrolled in the

13 (2) As used in this section, "tobacco use cessation program" means a program recommended by
 14 a physician, **physician assistant licensed under ORS 677.505 to 677.525 or nurse practitioner**
 15 **licensed under ORS 678.375 to 678.390 and** that follows the United States Public Health Service
 16 guidelines for tobacco use cessation. "Tobacco use cessation program" includes education and med-
 17 ical treatment components designed to assist a person in ceasing the use of tobacco products.

18 (3) This section is exempt from ORS 743A.001.

19 **SECTION 88.** ORS 743A.184 is amended to read:

20 743A.184. (1) Subject to other terms, conditions and benefits in the plan, group health benefit
 21 plans as described in ORS 743.730 shall provide payment, coverage or reimbursement for supplies,
 22 equipment and diabetes self-management programs associated with the treatment of insulin-
 23 dependent diabetes, insulin-using diabetes, gestational diabetes and noninsulin-using diabetes pre-
 24 scribed by a health care professional legally authorized to prescribe such items.

25 (2) As used in this section, "diabetes self-management program" means one program of assess-
 26 ment and training after diagnosis and no more than three hours per year of assessment and training
 27 upon a material change of condition, medication or treatment that is provided by:

28 (a) An education program credentialed or accredited by a state or national entity accrediting
 29 such programs; or

30 (b) A program provided by a physician licensed under ORS chapter 677, **a physician assistant**
 31 **licensed under ORS 677.505 to 677.525**, a registered nurse, a nurse practitioner, a certified diabetes
 32 educator or a licensed dietitian with demonstrated expertise in diabetes.

33 **SECTION 89.** ORS 744.364 is amended to read:

34 744.364. (1)(a) A life settlement provider entering into a life settlement contract shall first ob-
 35 tain:

36 (A) If the owner is the insured, a written statement from [*a licensed attending physician*] **a li-**
 37 **censed physician, a physician assistant licensed under ORS 677.505 to 677.525 or a nurse**
 38 **practitioner licensed under ORS 678.375 to 678.390** that the owner is of sound mind and under
 39 no constraint or undue influence to enter into a life settlement contract; and

40 (B) A document in which the insured consents to the release of the insured's medical records
 41 to a licensed life settlement provider, life settlement broker and the insurance company that issued
 42 the life insurance policy covering the life of the insured.

43 (b) Within 20 days after an owner executes documents necessary to transfer any rights under
 44 an insurance policy or, if the insured is terminally ill, within 20 days after an owner entering any
 45 agreement, option, promise or any other form of understanding, expressed or implied, to transfer the

1 policy for value, the life settlement provider shall give written notice to the insurer that issued the
2 insurance policy that the policy has or will become a settled policy. The notice must be accompanied
3 by the documents required by paragraph (c) of this subsection.

4 (c) The life settlement provider shall deliver a copy of the medical release required under par-
5 agraph (a)(B) of this subsection, a copy of the owner's application for the life settlement contract,
6 the notice required under paragraph (b) of this subsection and a request for verification of coverage
7 to the insurer that issued the life policy that is the subject of the life transaction. The Director of
8 the Department of Consumer and Business Services shall develop and approve a form for the request
9 for verification.

10 (d) The insurer shall respond to a request for verification of coverage submitted on an approved
11 form by a life settlement provider or life settlement broker within 30 calendar days of the date the
12 request is received and shall indicate whether, based on the medical evidence and documents pro-
13 vided, the insurer intends to pursue an investigation at this time regarding the validity of the in-
14 surance contract or possible fraud. The insurer shall accept a request for verification of coverage
15 made on a form approved by the director. The insurer shall accept an original or facsimile or elec-
16 tronic copy of such request and any accompanying authorization signed by the owner. Failure by the
17 insurer to meet its obligations under this subsection is a violation of the Insurance Code.

18 (e) Prior to or at the time of execution of the life settlement contract, the life settlement pro-
19 vider shall obtain a witnessed document in which the owner consents to the life settlement contract,
20 represents that the owner has a full and complete understanding of the life settlement contract, that
21 the owner has a full and complete understanding of the benefits of the life insurance policy, ac-
22 knowledges that the owner is entering into the life settlement contract freely and voluntarily and,
23 for persons with a terminal illness or chronic illness or condition, acknowledges that the insured
24 has a terminal illness or chronic illness and that the terminal illness or chronic illness or condition
25 was diagnosed after the life insurance policy was issued.

26 (f) If a life settlement broker performs any of the activities required of the life settlement pro-
27 vider, the provider is deemed to have fulfilled the requirements of this section that were performed
28 by the broker.

29 (2) All medical information solicited or obtained by any licensee is privileged and confidential
30 under ORS 705.137.

31 (3)(a) All life settlement contracts entered into in this state must provide the owner with an
32 absolute right to rescind the contract before the earlier of 60 calendar days after the date upon
33 which the life settlement contract is executed by all parties or 30 calendar days after the life
34 settlement proceeds have been sent to the owner under subsection (5) of this section.

35 (b) The life settlement provider may condition rescission upon the owner both giving notice and
36 repaying to the life settlement provider within the rescission period all proceeds of the settlement
37 and any premiums, loans and loan interest paid by or on behalf of the life settlement provider in
38 connection with or as a consequence of the life settlement.

39 (c) If the insured dies during the rescission period, the life settlement contract is deemed to have
40 been rescinded, subject to repayment within 60 calendar days of the death of the insured to the life
41 settlement provider or purchaser of all life settlement proceeds and any premiums, loans and loan
42 interest that have been paid by the life settlement provider or purchaser.

43 (d) In the event of any rescission, if the life settlement provider has paid commissions or other
44 compensation to a life settlement broker in connection with the rescinded transaction, the life
45 settlement broker shall refund all such commissions and compensation to the life settlement provider

1 within five business days following receipt of written demand from the life settlement provider. The
2 demand must be accompanied by either the owner's notice of rescission if rescinded at the election
3 of the owner, or the notice of the death of the insured if rescinded by reason of the death of the
4 insured within the applicable rescission period.

5 (4) The life settlement purchaser shall have the right to rescind a life settlement contract within
6 three days after the disclosures mandated by ORS 744.354 (7) are received by the purchaser.

7 (5)(a) The life settlement provider shall instruct the owner to send the executed documents re-
8 quired to effect the change in ownership, assignment or change in beneficiary directly to an inde-
9 pendent escrow agent selected by the provider.

10 (b) Within three business days after the date the escrow agent receives the document, or from
11 the date the life settlement provider receives the documents, if the owner erroneously provides the
12 documents directly to the provider, the provider shall pay or transfer the proceeds of the life
13 settlement into an escrow or trust account maintained in a state or federally chartered financial
14 institution whose deposits are insured by the Federal Deposit Insurance Corporation.

15 (c) Upon payment of the settlement proceeds into the escrow account, the escrow agent shall
16 deliver the original change in ownership, assignment or change in beneficiary forms to the life
17 settlement provider or related provider trust or other designated representative of the life settle-
18 ment provider. Upon the escrow agent's receipt of the acknowledgment of the properly completed
19 transfer of ownership, assignment or designation of beneficiary from the insurance company, the
20 escrow agent shall pay the settlement proceeds to the owner.

21 (6) Failure to pay the owner the full contract amount for the life settlement contract within the
22 time set forth under subsection (5) of this section renders the life settlement contract voidable by
23 the owner until the time full payment is tendered to and accepted by the owner. Funds are deemed
24 sent by a life settlement provider to an owner as of the date that the escrow agent either releases
25 funds for wire transfer to the owner or places a check for delivery to the owner via the United
26 States Postal Service or another nationally recognized delivery service.

27 (7)(a) Contacts with the insured for the purpose of determining the health status of the insured
28 by the life settlement provider or life settlement broker after the life settlement has occurred may
29 be made only by the life settlement provider or broker licensed in this state or its authorized rep-
30 resentatives and are limited to once every three months for insureds with a life expectancy of more
31 than one year, and to no more than once per month for insureds with a life expectancy of one year
32 or less.

33 (b) The limitations set forth in this subsection do not apply to any contacts with an insured for
34 reasons other than determining the insured's health status.

35 **SECTION 90.** ORS 744.367 is amended to read:

36 744.367. (1) A person may not enter into a life settlement contract at any time prior to the ap-
37 plication or issuance of a policy that is the subject of a life settlement contract or within a five-year
38 period commencing with the date of issuance of the insurance policy or certificate. However, this
39 five-year restriction does not apply if the owner certifies to the life settlement provider that any one
40 or more of the following conditions has been met within the five-year period:

41 (a) The policy was issued upon the owner's exercise of conversion rights arising out of a group
42 or individual policy if the total of the time covered under the conversion policy plus the time cov-
43 ered under the prior policy is at least 60 months. The time covered under a group policy is calcu-
44 lated without regard to any change in insurance carriers, provided the coverage has been
45 continuous and under the same group sponsorship;

1 (b) The owner submits independent evidence to the life settlement provider that one or more of
2 the following conditions have been met within the five-year period:

3 (A) The owner or insured is terminally ill or chronically ill;

4 (B) The owner's spouse dies;

5 (C) The owner divorces the owner's spouse;

6 (D) The owner retires from full-time employment;

7 (E) The owner becomes physically or mentally disabled and a physician, **physician assistant**
8 **licensed under ORS 677.505 to 677.525 or nurse practitioner licensed under ORS 678.375 to**
9 **678.390** determines that the disability prevents the owner from maintaining full-time employment;
10 or

11 (F) A final order, judgment or decree is entered by a court of competent jurisdiction, on the
12 application of a creditor of the owner, adjudicating the owner bankrupt or insolvent, or approving
13 a petition seeking reorganization of the owner or appointing a receiver, trustee or liquidator to all
14 or a substantial part of the owner's assets; or

15 (c) The owner enters into a life settlement contract more than two years after the date of issu-
16 ance of a policy and, with respect to the policy, at all times prior to the date that is two years after
17 policy issuance, the following conditions are met:

18 (A) Policy premiums have been funded exclusively with unencumbered assets, including an in-
19 terest in the life insurance policy being financed only to the extent of its net cash surrender value,
20 provided by, or full recourse liability incurred by, the insured or a person closely related to the in-
21 sured by blood or law or a party having a lawful substantial economic interest in the continued life,
22 health and bodily safety of the person insured, or a trust established primarily for the benefit of such
23 parties;

24 (B) There is no agreement or understanding with any other person to guarantee any such li-
25 ability or to purchase or stand ready to purchase the policy, including through an assumption or
26 forgiveness of the loan; and

27 (C) Neither the insured nor the policy has been evaluated for settlement.

28 (2) Copies of the independent evidence described in subsection (1)(b) of this section and docu-
29 ments required by ORS 744.364 (1) must be submitted to the insurer when the life settlement pro-
30 vider or other party entering into a life settlement contract with an owner submits a request to the
31 insurer for verification of coverage. The copies must be accompanied by a letter of attestation from
32 the life settlement provider that the copies are true and correct copies of the documents received
33 by the life settlement provider.

34 (3) If the life settlement provider submits to the insurer a copy of the owner's or insured's cer-
35 tification described in and the documents required by ORS 744.364 (1) when the provider submits a
36 request to the insurer to effect the transfer of the policy or certificate to the life settlement pro-
37 vider, the copy conclusively establishes that the life settlement contract satisfies the requirements
38 of this section and the insurer shall respond in a timely manner to the request.

39 (4) An insurer may not, as a condition of responding to a request for verification of coverage

41 insured, life settlement provider or life settlement broker sign any forms, disclosures, consent or
42 waiver form that has not been expressly approved by the Director of the Department of Consumer
43 and Business Services for use in connection with life settlement contracts in this state.

44 (5) Upon receipt of a properly completed request for a change of ownership or beneficiary of a
45 policy, the insurer shall respond in writing within 30 calendar days with written acknowledgement

1 confirming that the change has been effected or specifying the reasons why the requested change
 2 cannot be processed. The insurer may not unreasonably delay effecting change of ownership or

6 746.230. (1) No insurer or other person shall commit or perform any of the following unfair claim
 7 settlement practices:

8 (a) Misrepresenting facts or policy provisions in settling claims;

9 (b) Failing to acknowledge and act promptly upon communications relating to claims;

10 (c) Failing to adopt and implement reasonable standards for the prompt investigation of claims;

11 (d) Refusing to pay claims without conducting a reasonable investigation based on all available
 12 information;

13 (e) Failing to affirm or deny coverage of claims within a reasonable time after completed proof
 14 of loss statements have been submitted;

15 (f) Not attempting, in good faith, to promptly and equitably settle claims in which liability has
 16 become reasonably clear;

17 (g) Compelling claimants to initiate litigation to recover amounts due by offering substantially
 18 less than amounts ultimately recovered in actions brought by such claimants;

19 (h) Attempting to settle claims for less than the amount to which a reasonable person would
 20 believe a reasonable person was entitled after referring to written or printed advertising material
 21 accompanying or made part of an application;

22 (i) Attempting to settle claims on the basis of an application altered without notice to or consent
 23 of the applicant;

24 (j) Failing, after payment of a claim, to inform insureds or beneficiaries, upon request by them,
 25 of the coverage under which payment has been made;

26 (k) Delaying investigation or payment of claims by requiring a claimant or *[the physician of the*
 27 *claimant]* **the claimant's physician, physician assistant or nurse practitioner** to submit a pre-
 28 liminary claim report and then requiring subsequent submission of loss forms when both require
 29 essentially the same information;

30 (L) Failing to promptly settle claims under one coverage of a policy where liability has become
 31 reasonably clear in order to influence settlements under other coverages of the policy; or

32 (m) Failing to promptly provide the proper explanation of the basis relied on in the insurance
 33 policy in relation to the facts or applicable law for the denial of a claim.

34 (2) No insurer shall refuse, without just cause, to pay or settle claims arising under coverages
 35 provided by its policies with such frequency as to indicate a general business practice in this state,
 36 which general business practice is evidenced by:

37 (a) A substantial increase in the number of complaints against the insurer received by the De-
 38 partment of Consumer and Business Services;

39 (b) A substantial increase in the number of lawsuits filed against the insurer or its insureds by
 40 claimants; or

41 (c) Other relevant evidence.

42 (3)(a) No health maintenance organization, as defined in ORS 750.005, shall unreasonably with-
 43 hold the granting of participating provider status from a class of statutorily authorized health care
 44 providers for services rendered within the lawful scope of practice if the health care providers are
 45 licensed as such and reimbursement is for services mandated by statute.

1 (b) Any health maintenance organization that fails to comply with paragraph (a) of this sub-
