**PROPOSED AMENDMENTS TO
C-ENGROSSED SENATE BILL 243**

1 On page 1 of the printed C-engrossed bill, line 2, after “firearms;” delete
2 the rest of the line and delete line 3 and insert “amending ORS 131.602 and
3 166.272; and prescribing an effective date.”.

4 Delete lines 5 through 15 and delete pages 2 through 6 and insert:

5 **“SECTION 1.** ORS 166.272 is amended to read:

6 “166.272. (1) A person commits the crime of unlawful possession of a ma-
7 chine gun, short-barreled rifle[,] **or** short-barreled shotgun [*or firearms*
8 *silencer*] if the person knowingly possesses any machine gun, short-barreled
9 rifle[,] **or** short-barreled shotgun [*or firearms silencer*].

10 “(2) Unlawful possession of a machine gun, short-barreled rifle[,] **or**
11 short-barreled shotgun [*or firearms silencer*] is a Class B felony.

12 “(3) A peace officer may not arrest or charge a person for violating sub-
13 section (1) of this section if the person has in the person’s immediate pos-
14 session documentation showing that the machine gun, short-barreled rifle[,]
15 **or** short-barreled shotgun [*or firearms silencer*] is [*registered as required*]
16 **lawfully possessed** under federal law.

17 “(4) It is an affirmative defense to a charge of violating subsection (1) of
18 this section that the machine gun, short-barreled rifle[,] **or** short-barreled
19 shotgun [*or firearms silencer*] was [*registered as required*] **lawfully possessed**
20 under federal law.
