A BILL

To prohibit the Secretary of the Interior and the Secretary of Agriculture from prohibiting the use of lead ammunition or tackle on certain Federal land or water under the jurisdiction of the Secretary of the Interior and the Secretary of Agriculture, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Protecting Access for*
5 *Hunters and Anglers Act”.*

6 **SEC. 2. PROTECTING ACCESS FOR HUNTERS AND ANGLERS**
7 **ON FEDERAL LAND AND WATER.**

8 *(a) IN GENERAL.—Except as provided in section 20.21*
9 *or 20.108 of title 50, Code of Federal Regulations (as in*
10 *effect on the date of enactment of this Act), and subsection*
11 *(b), the Secretary of the Interior, acting through the Direc-*
12 *tor of the United States Fish and Wildlife Service or the*
13 *Director of the Bureau of Land Management, and the Sec-*
14 *retary of Agriculture, acting through the Chief of the Forest*
15 *Service (referred to in this section as the “applicable Sec-*
16 *retary”), may not—*

17 *(1) prohibit the use of lead ammunition or tackle*
18 *on Federal land or water that is—*

19 *(A) under the jurisdiction of the applicable*
20 *Secretary; and*

21 *(B) made available for hunting or fishing*
22 *activities; or*

23 *(2) issue regulations relating to the level of lead*
24 *in ammunition or tackle to be used on Federal land*
25 *or water described in paragraph (1).*

1 (b) *EXCEPTION.*—Subsection (a) shall not apply to a
2 prohibition or regulations described in that subsection that
3 are limited to a specific unit of Federal land or water, if
4 the applicable Secretary determines that—

5 (1) a decline in wildlife population at the spe-
6 cific unit of Federal land or water is primarily
7 caused by the use of lead in ammunition or tackle,
8 based on the field data from the specific unit of Fed-
9 eral land or water; and

10 (2) the prohibition or regulations, as applicable,
11 are—

12 (A) consistent with the law of the State in
13 which the specific Federal land or water is lo-
14 cated;

15 (B) consistent with an applicable policy of
16 the fish and wildlife department of the State in
17 which the specific Federal land or water is lo-
18 cated; or

19 (C) approved by the applicable fish and
20 wildlife department of the State in which the
21 specific Federal land or water is located.

22 (c) *FEDERAL REGISTER NOTICE.*—The applicable Sec-
23 retary shall include in a Federal Register notice with re-
24 spect to any prohibition or regulations that meet the re-
25 quirements of paragraphs (1) and (2) of subsection (b) an

- 1 *explanation of how the prohibition or regulations, as appli-*
- 2 *cable, meet those requirements.*
