Mrs. FISCHBACH, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2494) to make the assault of a law enforcement officer a deportable offense, and for other purposes; providing for consideration of the bill (H.R. 3091) to allow Federal law enforcement officers to purchase retired service weapons, and for other purposes; and providing for consideration of the concurrent resolution (H. Con. Res. 40) expressing support for local law enforcement officers and con-

demning efforts to defund or dismantle local law enforcement agencies.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2494) to make the assault of a
6 law enforcement officer a deportable offense, and for other
7 purposes. The first reading of the bill shall be dispensed
8 with. All points of order against consideration of the bill
9 are waived. General debate shall be confined to the bill
10 and shall not exceed one hour equally divided and con-
11 trolled by the chair and ranking minority member of the
12 Committee on the Judiciary or their respective designees.
13 After general debate the bill shall be considered for
14 amendment under the five-minute rule. In lieu of the
15 amendment in the nature of a substitute recommended by
16 the Committee on the Judiciary now printed in the bill,
17 it shall be in order to consider as an original bill for the
18 purpose of amendment under the five-minute rule an
19 amendment in the nature of a substitute consisting of the
20 text of Rules Committee Print 118-4. That amendment
21 in the nature of a substitute shall be considered as read.
22 All points of order against that amendment in the nature
23 of a substitute are waived. No amendment to that amend-
24 ment in the nature of a substitute shall be in order except

1 those printed in part A of the report of the Committee
2 on Rules accompanying this resolution. Each such amend-
3 ment may be offered only in the order printed in the re-
4 port, may be offered only by a Member designated in the
5 report, shall be considered as read, shall be debatable for
6 the time specified in the report equally divided and con-
7 trolled by the proponent and an opponent, shall not be
8 subject to amendment, and shall not be subject to a de-
9 mand for division of the question in the House or in the
10 Committee of the Whole. All points of order against such
11 amendments are waived. At the conclusion of consider-
12 ation of the bill for amendment the Committee shall rise
13 and report the bill to the House with such amendments
14 as may have been adopted. Any Member may demand a
15 separate vote in the House on any amendment adopted
16 in the Committee of the Whole to the bill or to the amend-
17 ment in the nature of a substitute made in order as origi-
18 nal text. The previous question shall be considered as or-
19 dered on the bill and amendments thereto to final passage
20 without intervening motion except one motion to recom-
21 mit.

22 SEC. 2. At any time after adoption of this resolution
23 the Speaker may, pursuant to clause 2(b) of rule XVIII,
24 declare the House resolved into the Committee of the
25 Whole House on the state of the Union for consideration

1 of the bill (H.R. 3091) to allow Federal law enforcement
2 officers to purchase retired service weapons, and for other
3 purposes. The first reading of the bill shall be dispensed
4 with. All points of order against consideration of the bill
5 are waived. General debate shall be confined to the bill
6 and shall not exceed one hour equally divided and con-
7 trolled by the chair and ranking minority member of the
8 Committee on the Judiciary or their respective designees.
9 After general debate the bill shall be considered for
10 amendment under the five-minute rule. In lieu of the
11 amendment in the nature of a substitute recommended by
12 the Committee on the Judiciary now printed in the bill,
13 it shall be in order to consider as an original bill for the
14 purpose of amendment under the five-minute rule an
15 amendment in the nature of a substitute consisting of the
16 text of Rules Committee Print 118-5. That amendment
17 in the nature of a substitute shall be considered as read.
18 All points of order against that amendment in the nature
19 of a substitute are waived. No amendment to that amend-
20 ment in the nature of a substitute shall be in order except
21 those printed in part B of the report of the Committee
22 on Rules accompanying this resolution. Each such amend-
23 ment may be offered only in the order printed in the re-
24 port, may be offered only by a Member designated in the
25 report, shall be considered as read, shall be debatable for

1 the time specified in the report equally divided and con-
2 trolled by the proponent and an opponent, shall not be
3 subject to amendment, and shall not be subject to a de-
4 mand for division of the question in the House or in the
5 Committee of the Whole. All points of order against such
6 amendments are waived. At the conclusion of consider-
7 ation of the bill for amendment the Committee shall rise
8 and report the bill to the House with such amendments
9 as may have been adopted. Any Member may demand a
10 separate vote in the House on any amendment adopted
11 in the Committee of the Whole to the bill or to the amend-
12 ment in the nature of a substitute made in order as origi-
13 nal text. The previous question shall be considered as or-
14 dered on the bill and amendments thereto to final passage
15 without intervening motion except one motion to recom-
16 mit.

17 SEC. 3. Upon adoption of this resolution it shall be
18 in order to consider in the House the concurrent resolution
19 (H. Con. Res. 40) expressing support for local law enforce-
20 ment officers and condemning efforts to defund or dis-
21 mantle local law enforcement agencies. All points of order
22 against consideration of the concurrent resolution are
23 waived. The concurrent resolution shall be considered as
24 read. All points of order against provisions in the concur-
25 rent resolution are waived. The previous question shall be

1 considered as ordered on the concurrent resolution and
2 preamble, and on any amendment thereto, to adoption
3 without intervening motion or demand for division of the
4 question except: (1) one hour of debate equally divided and
5 controlled by the chair and ranking minority member of
6 the Committee on the Judiciary or their respective des-
7 ignees; and (2) the amendment printed in part C of the
8 report of the Committee on Rules accompanying this reso-
9 lution, if offered by the Member designated in the report,
10 which shall be in order without intervention of any point
11 of order, shall be considered as read, shall be separately
12 debatable for the time specified in the report equally di-
13 vided and controlled by the proponent and an opponent,
14 and shall not be subject to a demand for division of the
15 question.
