## A BILL

To amend chapter 44 of title 18, United States Code, to enhance penalties for theft of a firearm from a Federal firearms licensee.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Firearms Li-  
5 censee Protection Act of 2023”.

1 **SEC. 2. AMENDMENTS TO ENHANCE CERTAIN PENALTIES.**

2 Section 924 of title 18, United States Code, is  
3 amended—

4 (1) by striking subsection (i) and inserting the  
5 following:

6 “(i)(1)(A) A person who knowingly violates section  
7 922(u), or attempts to do so, shall be fined under this  
8 title, imprisoned for not more than 20 years, or both.

9 “(B) In the case of a violation described in subpara-  
10 graph (A) that occurs during the commission of—

11 “(i) a burglary, the term of imprisonment shall  
12 be not less than 3 years; or

13 “(ii) a robbery, the term of imprisonment shall  
14 be not less than 5 years.

15 “(2) In this subsection—

16 “(A) the term ‘burglary’ means the unlawful  
17 entry into, or remaining in, the business premises of  
18 a licensed importer, licensed manufacturer, or li-  
19 censed dealer with the intent to commit a crime; and

20 “(B) the term ‘robbery’ has the meaning given  
21 the term in section 1951(b).”; and

22 (2) in subsection (m), by inserting “, or at-  
23 tempts to do so,” after “or licensed collector”.
