## 2017 ASSEMBLY BILL 430

June 30, 2017 - Introduced by Representatives SUBECK, ANDERSON, BERCEAU, OHNSTAD, C. TAYLOR, SARGENT, ZAMARRIPA and ZEPNICK, cosponsored by Senators JOHNSON, LARSON and L. TAYLOR. Referred to Committee on Criminal Justice and Public Safety.

1     **AN ACT** *to renumber and amend* 941.29 (4); *to amend* 941.29 (1g) (a), 941.291  
2           (1) (b) and 973.123 (1); and *to create* 941.29 (4) (b) of the statutes; **relating to:**  
3           storage of a firearm in a house in which a resident is prohibited from possessing  
4           a firearm and providing a criminal penalty.

---

***Analysis by the Legislative Reference Bureau***

This bill requires a person to store any firearm he or she possesses in a securely locked box or container or other secure locked location or with a trigger lock engaged if the person resides with a person who is prohibited from possessing a firearm under state law. A person who violates this requirement is guilty of a Class A misdemeanor for a first offense and a Class I felony for a second or subsequent offense.

11 **SECTION 3.** 941.29 (4) (b) of the statutes is created to read:

12 941.29 (4) (b) 1. A person who resides with a person who is prohibited under  
13 sub. (1m) from possessing a firearm shall, when not carrying the firearm, store any  
14 firearm he or she possesses in a securely locked box or container or in a locked  
15 location that a reasonable person would believe to be secure or ensure that a trigger  
16 lock is engaged on the firearm.

17 2. A person who violates subd. 1. is guilty of the following:

18 a. For a first violation, a Class A misdemeanor.

19 b. For a 2nd or subsequent violation, a Class I felony.
